FULL AND COMPLETE RELEASE OF LIABILITY AND INDEMNITY AGREEMENT

I understand and EXPRESSLY AGREE to the fact that skiing in its various forms is an INHERENTLY HAZARDOUS SPORT that has many dangers and risks. I realize that injuries are a common and ordinary occurrence of this sport. I acknowledge that SKI RACING AND TRAINING and related activities are ESPECIALLY HAZARDOUS activities and GREATLY INCREASE THE RISKS of skiing. Specifically, I understand that race training may occur BEFORE the ski area is PREPARED FOR THE PUBLIC. Therefore, normal SAFTEY PREPARATIONS WILL NOT BE IN PLACE, including, but not limited to, the presence of grooming and other MACHINERY on the slopes WITHOUT WARNINGS, irregular snow conditions, especially as to snow making and lift ramps, electric cords, hoses and other maintenance equipment will be on the slopes, NO PADDING, ropes or signs will be in place. RESPONSE TO ACCIDENTS will be GREATLY SLOWED, lift operators may NOT be available, etc. DESPITE recognizing these risks, I have made voluntary choice to participate despite the risks they present. In consideration of Red River Ski Area, Inc. making ski racing, training and related activities available. I EXPRESSLY AGREE that I freely accept and voluntarily assume ALL RISKS OF PERSONAL INJURY OR DEATH or property damage and FULLY RELEASE Red River Ski Area, Inc. and their agents, employees, coaches, directors, officers and volunteers (hereafter referred to as Ski Company) FROM ANY AND ALL LIABILITY for personal injury, death or property damage which results IN ANY WAY from participation in this sport, or while working any Ski Racing, training, or while traveling to and from any Ski Clinic racing, training, or event, including any caused by NEGLIGENCE, conditions on or about the premises and facilities of any ski area where ski racing or training participants may be skiing or the operations of the ski area including, but not limited to, grooming, snow making, ski lift operations while loading or unloading, gate setting, course setting, coaching, other skiers or any other activities related to ski racing or training and ACCEPT MYSELF THE FULL RESPONSIBILITY FOR ANY AND ALL such damages or injury of any kind which may result.

I also agree to DEFEND, INDEMNIFY AND HOLD HARMLESS Ski Company from any claims for damages against it by me, or any third parties arising out of my conduct while participating in Ski Clinic and Race Camp activity.

In exchange for, and in consideration of, Ski Company making this training time and the ski area available to me for participation in the sport of skiing. I CONTRACTUALLY AGREE that any and all disputes between myself and Ski Company arising from participation in the ski racing, training or participation in the sport of skiing, and including any claims for personal injury and/or death, will be GOVERNED BY THE LAWS OF THE STATE OF NEW MEXICO and the EXCLUSIVE JURISDICTION thereof will be in the state or federal courts of the STATE OF NEW MEXICO.

I the undersigned, HAVE READ AND UNDERSTAND the terms of the above Full and Complete Release of Liability and Indemnity Agreement and I am signing it freely and of my own accord, realizing IT IS BINDING upon me, my heirs, assigns REALIZING ITS BINDING EFFECT ON ME. If any part of this agreement is deemed unenforceable, the remainder shall be an enforceable contract between the parties, I AM AWARE THAT THIS CONTRACT IS LEGALLY BINDING AND THAT SIGNING BELOW I AM RELEASING MY LEGAL RIGHTS.
