[origin: US7269621B2] A method, system and graphical user interface for dynamically updating transmission characteristics in a web mail reply are described. In one embodiment of the invention, a graphical user interface includes a web mail reply form that includes: one or more address fields; an input area for inputting a reply message; and a plurality of response options selectable by a user. In response to selection of a response option by a user, one or more of the address fields in the reply form are changed while maintaining the reply message in the input area.
