- The permittee must provide the City Of Trenton with a Certificate of Liability Insurance, in the amount of \$1,000,000.00, naming the City Of Trenton as the additional insured.
- The permittee must notify the City of any changes or cancellation via phone 609.815.2167 within 24 hours or be charged for a full day (\$43.00* 2 hours = \$86.00).
- Four (4) lifeguards will service every summer camp program. The rates to be charged for each day is as follows:
