RELEASE, PERMISSION, AND INDEMNITY AGREEMENT

Waiver: In consideration of being permitted to participate in any way in Pickleball by the Seaside ("the Tournament"), I, for myself, my heirs or assigns, do hereby release, waive, discharge and covenant not to sue, Thousand Trails, Seaside, OR, its/their officers, employees and agents from liability from any and all claims resulting in personal injuries, accidents or illnesses (including death) and property loss arising from my participation in the Tournament.
