Exam Instructions and Information: Read each question thoroughly and answer each question on the attached answer sheet using current 2013-15 USA Volleyball Domestic Competition Regulations (DCR) and the USAV Indoor Case Book. Scoring Instructions are found on pages 132-175 of the DCR. Team S refers to the serving team and Team R refers to the receiving team. When a team's serve or receive status is not relevant to the question, Team A or Team B is used to differentiate the teams. Assume there are no other conditions than those specifically mentioned in the question.

For questions 1 through 25, read each situation carefully and indicate on the answer sheet whether the statement and/or action taken is Correct or Incorrect:

1. When entering the starting player numbers on the Scoresheet, the number should be centered in the **Order** section.
 Correct Incorrect
2. All information (except the signatures) is recorded using CAPITAL LETTERS.
 Correct Incorrect
3. After the scorer receives the line-ups, player changes may be made until after the warm-up session is finished.
 Correct Incorrect
4. Scheduled match **Time**, **Start** time and **End** time should be entered on the scoresheet using International time (for example: 13:15 for 1:15 pm).
 Correct Incorrect
5. When recording the team scores at the time of substitutions, time-outs, sanctions, and remarks, Team A's score is always entered first followed by Team B's score.
 Correct Incorrect
6. Prior to the start of each set, as the second referee is checking the team line-ups on the court, the scorer should make sure that the **HEADINGS** information is accurate.
 Correct Incorrect
7. If two Liberos are designated for the first set, either Libero may enter the court prior to the first rally of the match.
 Correct Incorrect
8. Team A designates no Libero for set 1. Team A may then designate any legal player as the Libero for Set 2.
 Correct Incorrect
9. Team A makes a substitution. Team B then takes a time-out. At the end of the time-out, Team A may request an additional substitution.
 Correct Incorrect
10. When recording a substitution slash the exiting player's number.
 Correct Incorrect

11. The scorer notices that Team A's line-up sheet has no designated Liberos and no "X"s in the Libero boxes. The scorer should ask the second referee to take the line-up sheet back to Team A's coach to confirm that there are no Libero(s) for this set.
 Correct Incorrect
12. At the end of the set the scorer should circle the last point scored in the **Points** column for each team.
 Correct Incorrect
13. When the game captain is replaced by the Libero, the scorer should write the number of the replacement captain above the **TIME & TEAM** section.
 Correct Incorrect
14. Points scored on the serve are slashed; rally points for the receiving team are circled.
 Correct Incorrect
15. The 'Exit Score' entered in the **Service Rounds** box is the current score of the serving team at the end of that term of service.
 Correct Incorrect
16. While checking the line-up on the court before the start of the set, the scorer discovers that Team A #9 is on the court instead of #19. The scorer immediately notifies the second referee that the wrong player is on the court.
 Correct Incorrect
17. During the match, it is discovered that Team B #18 is on the court through an illegal substitution. If the officials can determine when the illegal substitution occurred, all points scored by Team B after the fault will be removed.
 Correct Incorrect
18. If Team A is using only 1 Libero for the set, the second **Libero#** box should be left blank.
 Correct Incorrect
19. If Team A designates 2 Liberos for set 1, the designation is for the match and the numbers are copied on the scoresheet(s) for all remaining non-deciding sets.
 Correct Incorrect
20. Team A #22 correctly enters the court to replace the Libero, and before the beckon for service, Team A #1 substitutes into the game for #22. The substitution is recorded on the scoresheet and Libero Control Sheet.
 Correct Incorrect
21. Team A #6 substitutes into the game for # 4. In the same dead ball period, the Libero replaces #6. When the Libero rotates to the front row, #4 replaces the Libero. This is a legal Libero replacement.

22. When a substitution is made by the team on the left before the court switch in a deciding set, record the substitution on both the far left and far right sides of the scoresheet.

23. In Set 1, Team B #9 was substituted out of the game using an exceptional substitution. In Set 3, Team B requests a substitution, #9 for #4. This is a legal substitution.

24. Before the court switch in a deciding set, all substitutions and Libero replacements are recorded on the far left and far right sides of the Libero Control Sheet
 Correct Incorrect
25. At the end of a deciding set, the scorer draws an hourglass through all unused points only in the middle and far right **Points** column of the scoresheet.
