City Water, Sewer Rates Change

Modifications ensure quality water and wastewater service delivery

On June 9, Northglenn City Council approved a change in the city's water and wastewater rates. The change will ensure that residents will continue to receive quality water and wastewater services including water acquisition, operations, maintenance and capital improvements.

The rate changes are based upon recommendations from a study that was conducted by an independent contractor hired by the city to ensure that water and wastewater charges meet the costs of providing those services.

The new rates are effective on June 27 and residents will notice the change on their August utility bill.

There is a flat monthly service charge of \$9.75 that covers utility billing, meter reading and fixed costs. The new residential water and wastewater rates are as follows:

- Tier 1 - \$1.90 per thousand for the first 3,000 gallons
- Tier 2 - \$3.72 per thousand over 3,000 to 10,000 gallons
- Tier 3 - \$4.52 per thousand over 10,000 to 20,000 gallons
- Tier 4 - \$6.70 per thousand over 20,000 gallons

The minimum wastewater/sewer charge is \$10.68 or \$3.56 per 1,000 gallons with a 3,000 gallon minimum. Sewer charges are based upon a household's winter consumption averaged during the months of November to February. This average is multiplied

by the rate \$3.56 and determines a resident's monthly sewer rate for the year until the process is repeated.

Minimum fees and charges are necessary for the maintenance and upkeep of the city's water infrastructure and ensure that water services are available to residents, as needed.

For mixed-use commercial use customers, the rates will remain the same up to 100 percent of the account's EQR (Equivalent Residential Unit) allotment or 3.25 per 1,000 gallons. Consumption over the 100 percent EQR will be charged \$5.26 per thousand gallons an increase of 14 cents.

Domestic use commercial customer will continue to pay \$3.25 per 1,000 gallons and for commercial irrigation use, the rates will increase 14 cents to \$5.26 per 1,000 gallons.

Residents can still pay their utility bill at City Hall, online, mail in a check or use the NEXT service where the monthly amount is deducted automatically from your bank account on its due date.

Construction Work Continues on W. 112th Ave.

Work has begun on the 2011 W. 112th Avenue Widening project which is funded by the voter-approved 4.0 mill property tax extension passed in 2009 with funds earmarked for street reconstruction and rehabilitation.

To date, tree removal and stormsewer infrastructure construction has been com-

pleted. Once final utility relocations are complete, the widening to add an eastbound lane from Alcott Street east to Pecos Street can begin. Other work will include an asphalt mill and overlay and trail enhancements. During construction, the eastbound lanes will be reduced to one lane of travel. Westbound lanes will not be affected until later on in the project when the mill and overlay work is scheduled to

take place.

Access to all businesses, residential neighborhoods and Northwest Open Space will be maintained and remain open during the construction.

City Council Meeting Summary May 26, 2011

Ordinances 1st Reading:

Funds for Rec Center Preliminarily Approved

CB-1753 – Council gave preliminary approval for a special ordinance to amend the 2011 Budget to accept a \$500,000 grant from the Adams County Open Space Advisory Board and appropriate the funds to the Capital Projects Fund. Also, \$700,000 would be appropriated from the Conservation Trust Fund in addition to \$500,000 in cost savings for a total of \$1,700,000 that will be used to replace the roof and HVAC system at the Northglenn Recreation Center.

Initial OK for State Sales Tax Compliance Measure

CB-1754 – Council gave preliminary approval for an ordinance to amend Article 5-2 of the Northglenn Municipal Code to comply with Colorado state sales tax procedures and requirements.

Irma Drive Plot Re-Zoned

CB-1750 – Council unanimously approved a special ordinance to rezone the property located at 10551 Irma Drive 0-1 from Open Space to Planned Unit Development (PUD) to allow commercial and light industrial land uses, to amend the city's zoning map and to impose penalties for violations of this ordinance.

Budget Amended for Curbside Recycling

CB-1752 – Council unanimously approved a special ordinance to amend the 2011 Budget to increase appropriations in the amount of \$182,050 for the purchase of 3,500 polycarts to implement curbside recycling and \$7,050 for fuel and maintenance costs and to decrease the 2011 Sanitation Fund unassigned balance by \$189,100 for the listed expenditures. 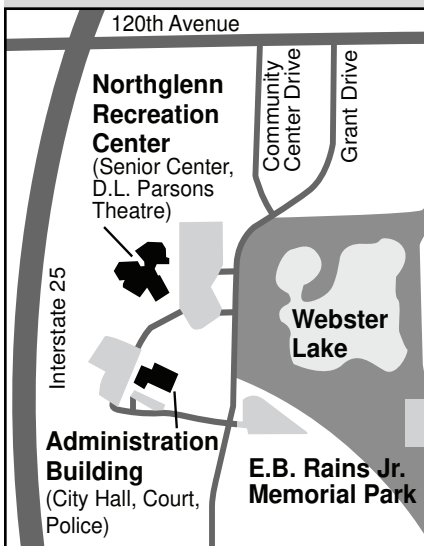

Used when insurance doesn't cover prescription

Do you need prescription drugs that are not covered by insurance? There is a way to help cut the cost of these medications.

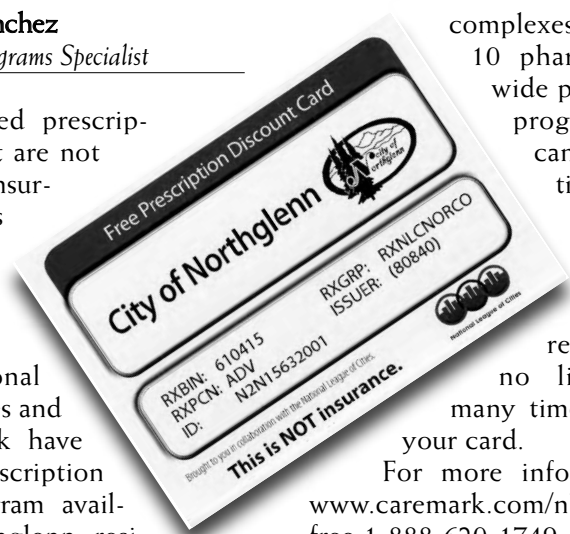
The National League of Cities and CVS Caremark have made the Prescription Discount Program available to Northglenn residents.

From its start in December 2008 through the end of May 2011, the program has saved 790 Northglenn residents \$13,197.21, an average price savings of 17.6 percent.

The cards are available at City Hall, the Northglenn Recreation Center and local churches and apartment

complexes. Nine out of 10 pharmacies nationwide participate in the program. The card can be used anytime a prescription is not covered by insurance. There are not any restrictions and no limits on how many times you may use your card.

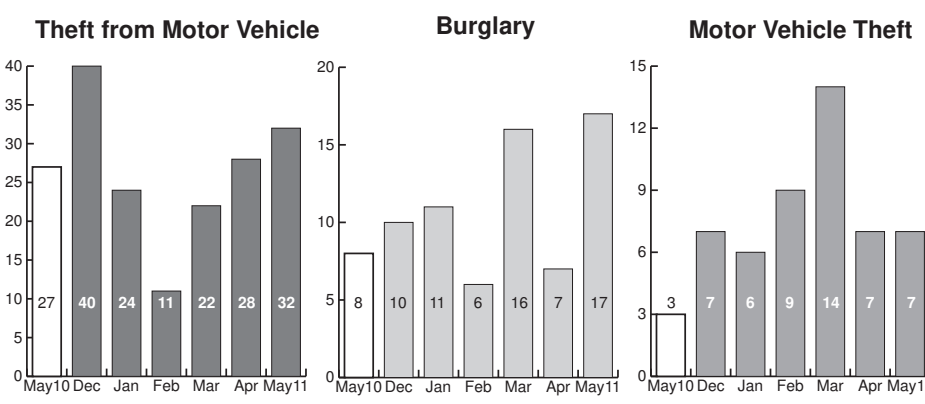

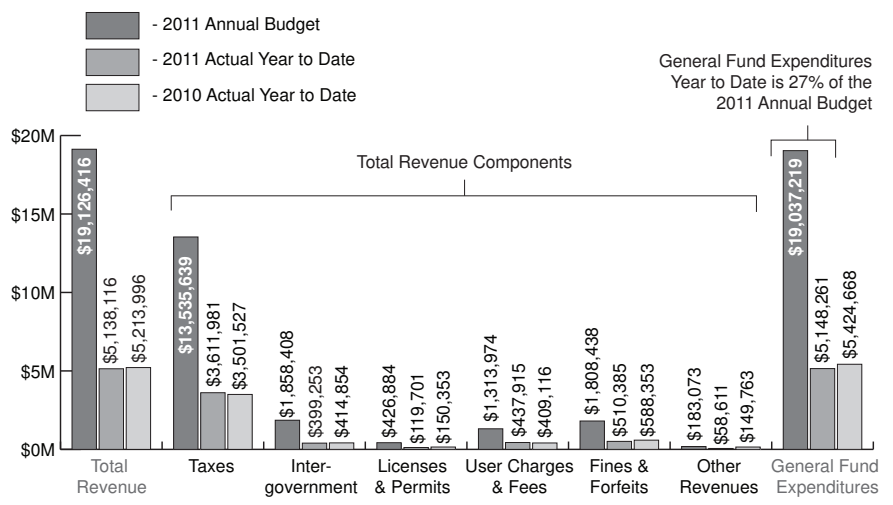
City of Northglenn May 2011 Crime Statistics

Curbside Recycling in City Begins

Phase I Recycling starts with residents south of 104th Avenue

Recently, residents were asked to share their opinion about curbside recycling by responding to a survey enclosed in their residential utility billing statements. The response to the survey was positive, with 3,300 residents expressing an interest in a curbside recycling program.

The city will roll out its recycling program with Phase I, which includes the area south of 104th Avenue and west of Interstate 25 or residents whose trash collection day is on Friday.

Residents who have expressed an interest in the recycling program and living within this specific area will receive a city-provided recycling cart.

Phase I recycling service will occur on a bi-weekly basis on your normal trash collection day and will begin in July.

Recycling containers were ordered and residents who live outside of the Phase I area may expect to receive their carts in approximately six to eight weeks.

All recyclable items must be contained within the recycling polycart, which is designated with a blue lid. Cardboard boxes should be flattened to optimize the use of the container. Items left outside the cart or non-recyclable items will not be collected.

A separate truck will collect recyclable items; therefore, the collection time will not coincide with the time of your regular trash collection.

As stated in the survey, the city's recycling program is included in the regular trash rate and is a voluntary program. If you have not returned the

survey, you may still submit your interest in the recycling program online at www.northglenn.org.

If you have completed and returned the mail survey, it is not necessary for you to complete the online survey as your interest in the program is already registered.

Residents who have expressed interest in the recycling program will be notified prior to implementation as the recycling program continues to rollout throughout the city. If you have any questions about the recycling program, please contact the Sanitation Division at 303-450-4004 from 7 a.m. to 3:30 p.m. weekdays.

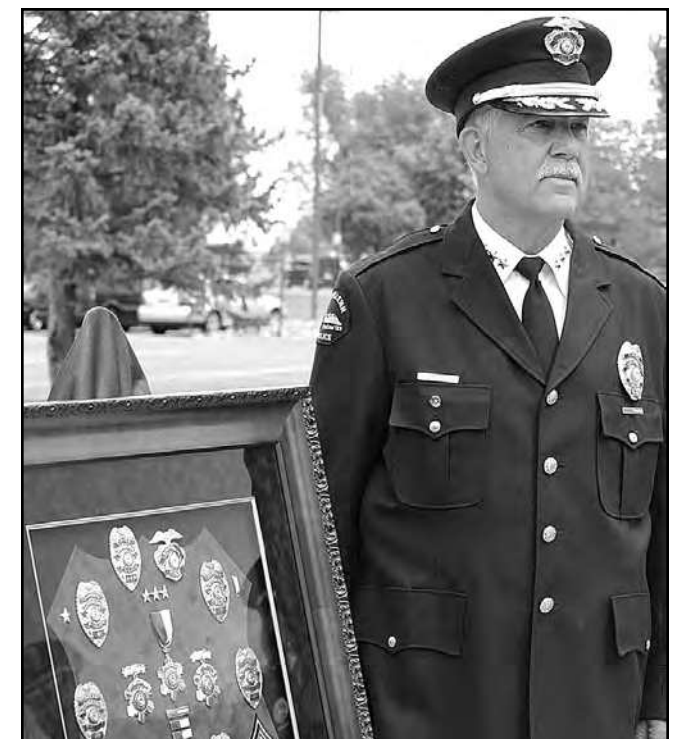

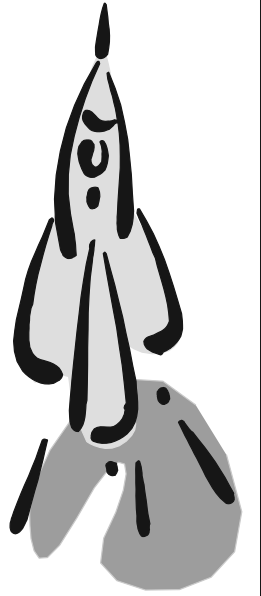

Fire Fighter Portrait to Benefit Colorado 9/11 Memorial

With the 10-year anniversary of the Sept. 11, 2001, terrorist attacks only months away, a commemorative portrait is being made available to benefit the 9/11 Memorial located in Broomfield at the northeast side of the Community Park pond, adjacent to the Mamie Doud Eisenhower Public Library, 3 Community Park Road.

Broomfield artist Ruth Soller's original oil painting is drawn from an October 2001 memorial service held at Ground Zero in New York City in which fire fighters handed out pieces of rubble to survivors and family members of those lost and missing in the World Trade Center.

"The original portrait painted by Ms. Soller was acquired by the General President of the International Association of Fire Fighters (IAFF) for permanent display in their headquarters in Washington,

D.C.," said Wendy Forbes, Public Information Officer of North Metro Fire Rescue. "We are incredibly honored that she has selected Colorado's 9/11 Memorial as the benefactor of the remaining 200 prints."

"Rather than a likeness of one individual, the portrait symbolizes all firefighters who joined in the search for their brothers," said Soller. "The spirit of the painting is one of indomitable hope, patriotism and determination to move forward even in the midst of grief and sorrow."

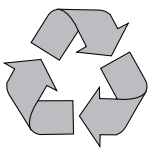

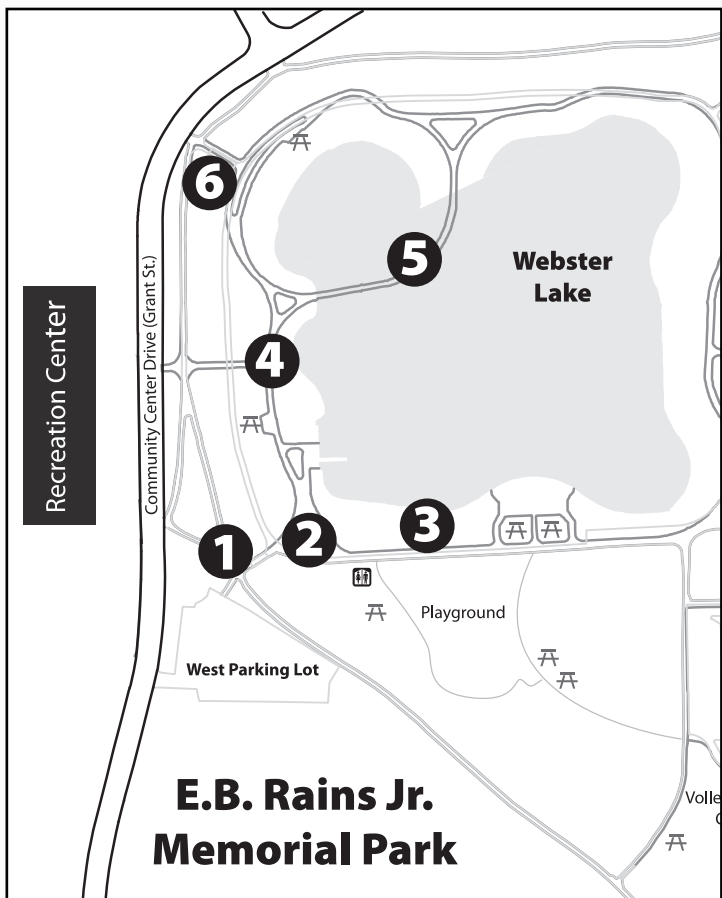
Past winners of the People's Choice Award have been purchased by the NAHF for permanent display at various locations throughout the city.
