Attachment-based Family Therapy

An empirically supported approach to working with depressed and suicidal adolescents

Attachment theory provides the over-arching framework for ABFT therapists. Optimal adolescent development occurs when adolescents perceive their parents as caring, protective, available and autonomy granting. Such a secure base provides a buffer which helps adolescents to withstand and grow from life's stressors. In contrast, when parents abandon, coerce, or otherwise fail to provide adequate nurturance or protection, adolescents withdraw from their parents and are at greater risk.

ABFT aims to repair ruptures in the attachment relationship, and establish or resuscitate the secure base so important for adolescent development. "Reattachment" occurs by first helping family members to access their longing for greater closeness and adopt the idea of rebuilding trust as a worthy initial goal of therapy. Then adolescents, in individual sessions, are helped to identify and articulate their perceived experience of the attachment failures, and commit to a discussion of these experiences with their parents. In individual sessions with the parents, they are helped to access greater empathy for their child and the parenting skills to provide both warmth and protection. When ready, the family again meets together to discuss core conflicts that have damaged trust in the family. ABFT is a flexible yet programmatic approach to facilitating these processes. Although not prescriptive, the treatment manual provides a clear road map of how to accomplish this "shuttle diplomacy" so that these profound and reparative conversations can happen relatively soon in therapy (e.g., within 4 to 5 sessions). Therapists are taught to rapidly focus on relational failure, vulnerable emotions, and the instinctual desire for giving and receiving attachment security.

Guy Diamond is the Director of the Center for Family Intervention Science at the Children's Hospital of Philadelphia and Associate Professor in the School of Medicine at The University of Pennsylvania. He is a child and adolescent psychologist with both clinical and research interests. He has been the principal investigator on grants funded by the National Institute of Mental Health, Center for Disease Control, Center for Substance Abuse Treatment, the Pennsylvania Department of Health and several private foundations and has published widely on adolescent and family focused treatment outcome and process research
