



Camp Betz, Berrien Springs, Michigan

Introduction:

Camp Frank S. Betz is owned and operated by Calumet Council Boy Scouts of America. Camp Betz is located in Berrien Springs Michigan, on the banks of the St. Joseph River, which affords a tremendous view. Camp Betz does not serve as a summer camp, but instead is used extensively for *leadership development* as well as weekend camping events. Camp Betz is open year round to Scouts and Scouters of the Calumet Council and out of council units.

Facilities

Camp Betz has four cabins that are available to rent. All cabins have new stoves, refrigerators, and furnaces that were purchased by Michigamea Lodge 110, Order of the Arrow, and have access to water. The camp is also equipped with a year round showers and washrooms that are separated for youth, men and women. There are large open fields for sporting activities and access to beautiful Lake Chapin for swimming and boating.

Tent camping areas are also available for units who wish to avail themselves of these facilities.

In order to use the waterfront area for swimming or boating at Camp Betz, your unit must conform to all standards of the Boy Scouts of America pertaining to aquatics. Please get special permission to use these facilities from the Camp Betz Professional Advisor before planning your event.

Directions to Camp Betz:

Camp Betz is located in Berrien Springs, Michigan and is about an hour and a half drive from the Chicagoland Area. Shortly after entering camp you will see a gray building on the left. This is the Campmaster's cabin. Please stop, check in, and get instructions from the Campmaster on duty.

To get to Camp Betz from Chicago take I-94 east to the Bridgman, Michigan exit (exit 16). Take

a right onto Red Arrow Highway and proceed to the first traffic light. Turn right and go east about ten miles. At the forth stop sign turn right onto Red Bud Trail and travel about 1/2 mile to Snow Road, which is at the bottom of a very steep hill. Turn left and proceed about 3/4 of a mile to the entrance to Camp Betz which will be on the right side of the road.

An alternate route to Betz is to get off of I-94 at Route 12 in Michigan and go east toward and thru the village of Three Oaks. Continue east to Route 31. At the junction, proceed north toward Holland, Michigan. After crossing the St. Joe River twice, get off at the Berrien Springs exit. This will be Snow Road. Turn right (away from Berrien Springs), crossing over Route 31, and the Camp entrance will be only a few hundred feet further.

Another option is to take the Indiana tollway from I-94 and proceed east to its intersection with Route 31. Go north on Route 31 and proceed as described above. The toll is approximately \$1.55 each way.

Functions of Camp Betz

Camp Betz is used for various activities throughout the year. Michigamea Lodge 110, Order of the Arrow, holds their lodge fellowships and other training sessions at camp. Camp Betz is also home to the Calumet Council National Youth Leader Training (NYLT) Course, Boy Scout Leader Training (BSLT) and Wood Badge. Camp Betz is also home to many other council wide programs such as African American Heritage Camp, Cub Weekend Camp, Religious Awards Camp, and Shooting Sports Camp.

3. National Council - Boy Scouts of America requirements for waterfront activities will be observed.

Rifle Range

1. Must have a certified instructor on site.
2. No 22's are to be used.

Reservation Policy:

1. Cancellations must be received in writing no less then thirty (30) days prior to arrival at Camp for a refund.
2. Fees must accompany the application - Faxes & Credit cards accepted (Visa or MasterCard).
3. Phone reservations may be made only if there is money in the unit account or a faxed application & valid credit card.
4. The Leader signing this application will be on site for the event or have designated an alternate on site.
5. Co-ed groups using the facility must have both male & female adult leadership.
6. The Unit Leader will accompany the Caretaker/Campmaster on checkout inspection before leaving camp.
