I. Introduction

The Brunswick County Health Department in collaboration with Novant Health Brunswick Medical Center and other community partners established a community health assessment in 2011 to identify the most pressing health needs in our community. The 2011 community health assessment serves as the basis for Novant Health's Community Health Needs Assessment 2013 – 2015. Novant Health Brunswick Medical Center will use the data in the Community Health Needs Assessment to enhance the health of its community through health and wellness programming, clinical services and financial support.

a. Organization Overview

Novant Health is the parent company of Novant Health Brunswick Medical Center and is a not-for-profit integrated health system consisting of 15 hospitals and a medical group consisting of over 1,000 physicians in over 350 clinic locations. In addition, Novant Health consists of numerous outpatient surgery centers, medical plazas, rehabilitation programs, diagnostic imaging centers and community health outreach programs. Novant's 25,000+ employees and physician partners care for patients and communities in North Carolina, Virginia, and South Carolina.

b. Our Community

Brunswick County is located in the Southeastern most point in North Carolina bordered by New Hanover, Pender, Columbus, and Horry County, South Carolina. The temperate climate and beautiful beaches have opened it up to tremendous population growth over the past ten years. The county has a total of 1,050 square miles, of which 855 square miles is land and 195 square miles is water.

The majority of the population lives in rural, unincorporated areas. The majority of the citizens are white with a smaller than average African America population and an even smaller population of Latinos. The major population growth is attributed to a large number of older persons who have chosen to retire in Brunswick County.

Brunswick County is divided into municipalities and small-incorporated areas. There are 19 municipalities, more than any other county in North Carolina.

Municipalities include Bald Head Island, Belville, Boiling Spring Lakes, Bolivia, Calabash, Carolina Shores, Caswell Beach, Holden Beach, Leland, Navassa, Northwest, Oak Island, Ocean Isle Beach, Sandy Creek, Shallotte, Southport, St. James, Sunset Beach, Varnamtown.

Demographics of the Community:

According to the 2010 US Census, Brunswick County has a population of 107,431 (34% urban, 66% rural). The population in 2000 was 73,143 resulting in a 46.9% increase to 2010.

In the summer, the population increases to approximately 180,000 with tourists and summer residents but these numbers are not used in this report even though it places a tremendous strain on all aspects of community life.

The percent of the population under five years of age is 5.4%, 18.8% of the population is below twenty years of age, and 21.4% is above age sixty-five years of age compared to 12.9% statewide. Females make up 51% of the total population and males make up 49%. The White population is 83% and African American is 11.4%. Latino population is 5.2%. Native American Indian is 0.7% and Asian is 0.5%.

Quick Facts:

- High school graduation is 84% and persons with a bachelor's degree or more are 18.5%.
- Per capita income has risen from \$19,857 in 2007 to \$25,993.
- Median household income has risen from \$35,888 in 2007 to \$44,891.
- The unemployment rate has risen from 4.5 in 2007 to 10.4 equal to the state.
- The number of persons living in poverty is 14.6%. The elderly poverty rate is 8.1%. The child poverty rate is 22.6%.
- Whites have an 8.7% poverty rate while blacks have a 27.1% poverty rate compared to the state with whites having an 8.4% and blacks having 22.9%.

- The number of persons without medical insurance is 19.8%. The state average for persons without medical insurance is 19.7%.
- Brunswick County is considered to be a medically underserved area having 1,578 people per physician versus the 859 per physician state average and 631 nationally.
- The number of persons receiving Medicaid is 14,939 or 14.1%. Of those, 10.1% or 10,709 are white, 3% or 3,207 are black, and 1% or 1,023 are Latino. The highest age rates are 0-5 years old with 3,894 or 26%.
- The number of persons eligible for Medicaid receiving dental care is 45.7% under 21 years old and for those over 21 is 30.6%.

II. Assessment Process and Methodology

a. Collaborative Community Partners and Public Health Input

Local health departments in North Carolina are required to conduct a comprehensive community health needs assessment to maintain local health department accreditation. The Novant Health Brunswick Medical Center Community Health Needs Assessment 2013 – 2015 is a joint effort with the Brunswick County Health Department, and is a project that involves the entire community. The Novant Health Brunswick Medical Center Community Health Needs Assessment 2013 – 2015 utilizes extensive, existing data from the Brunswick County Health Department Community Assessment 2011 as well as internally conducted research (including a review of Novant Health Brunswick Medical Center Emergency Department Utilization data – 2012).

b. Process, Methods and Assessment Data

The Novant Health Brunswick Medical Center Community Health Needs Assessment 2013-2015 primarily utilized extensive existing data from the Brunswick County Health Department Community Assessment 2011 and U.S. Census Bureau Data (2010). From a review of the collection of source data and community engagement, we believe that the development of the Novant Health Brunswick Medical Center Community Health Needs Assessment 2013-2015 is comprehensive enough in nature that any gaps that impact the facility's ability to assess the health needs of the community have been minimized.

Primary data (qualitative) was collected from the community through a randomized door-to-door survey, senior centers, Laundromats, an internet survey, community focus groups, and community leader surveys. Secondary data (quantitative) was gathered from state, regional, and local statistics from a variety of Sources. A Non Probability-based Convenience Sample Survey was developed as part of a regional process headed up by the Hospital Alliance. A survey was administered of which a total of 2,088 were collected. The survey was developed on a regional basis in collaboration with the Coastal Carolina Health Alliance and member county health departments. The surveys were developed using the state template to ensure all required information was gathered.

Survey Monkey was use to collect data online. Paper copies were distributed to citizens that did not have computer access. Novant Health Brunswick Medical Center and Dosher Memorial Hospital distributed surveys via email and hard copy. The University of North Carolina at Wilmington nursing students distributed hard copies throughout the community. The Brunswick County Health Department distributed surveys online thru the county web page and emails as well as hard copies to clients.

The intent of this informal survey was to determine what the citizens think is the biggest health problem in Brunswick County. The survey also was used to find out what types of access to care issues were being felt by the community. A wide variety of health problems were reported, but only the most common are reported here. The top five responses were selected for each question:

Question 1: In your opinion, what do most people die from in your community? 1. Heath Disease; 2. Cancer; 3. Diabetes; 4. Stroke; 5. Motor Vehicle Accidents

Question 2: In your opinion, what is the biggest health issue of concern in your community? 1. Chronic Disease; 2. Obesity; 3. Drug and Alcohol Abuse; 4. Tobacco Use; 5. Asthma

Question 3: In your opinion, what do you think is the main reason that keeps people in your community from seeking medical treatment?

- 1. Lack of Insurance/ unable to pay; 2. lack of knowledge/understanding of need; 3. Fear
- 4. Cultural Health Beliefs; 5. Transportation

Question 4: Which factor do you feel most affects the quality of the health care you or people in your community receive?

1. Economic; 2. Age; 3. Ability to read or write/education; 4. Language Barrier; 5. Not Important

Question 5: In your opinion, do you feel people in your community lack the funds for any of the following? 1. Health Insurance; 2. Medicine; 3. Utilities; 4. Food; 5. Transportation.

Question 6: How do you rate your own health? 1. Very Good Health; 2. Good; 3. Excellent; 4. Fair; 5. Poor

Question 7: What does your community need to improve the health of your family, friends, and neighbors?

Question 12: If public authorities announced a mandatory evacuation from your neighborhood or community due to a large-scale disaster or emergency, would you evacuate? 1. Yes

Question 13: What would be the main reason you might not evacuate if asked to do so?1. Concern leaving pets; 2. Traffic jams, hard to get out; 3. Concern about family safety4. Leaving property; 5. N/A would leave

III. Prioritized Health Needs

Various community groups and individuals were involved in this assessment of the health of Brunswick County. A focus group was held with selected stake holders. There were 14 participants: bankers, emergency room workers, school nurse, parks and recreation, police, rental, other business professionals, and retired professionals who engaged in a group discussion based on five questions relative to data presented.

<u>Representatives or Leaders of Medically Underserved, Low-Income and Minority Populations and</u> <u>Populations with Chronic Disease Needs:</u>

- New Hope Clinic is committed to serving the healthcare needs of the underserved in Brunswick County. New Hope Clinic delivers a full range of health-care services, including primary and specialty medical care, dental care, patient education, and prescription medications, at no cost to our patients. With the tireless commitment of our organizational partners, volunteer base, and staff, New Hope Clinic is able to provide an innovative and comprehensive solution for the large number of uninsured Brunswick County residents.
- Community Care of the Lower Cape Fear was launched in 2003. Community Care of Lower Cape Fear serves nearly 95,000 Medicaid and Health Choice (CHIP) enrollees, and select Medicare, Blue Cross Blue Shield of North Carolina and State Employees Health Plan enrollees. The Community Care of Lower Cape Fear geographic footprint spans Bladen, Brunswick, and Columbus, New Hanover, Onslow and Pender counties.

Community Care of Lower Cape Fear works in partnership with 154 primary care practices, hospitals, health departments, departments of social services, and other agencies and organizations, including LMEs and SEAHEC, in our six-county network. These professionals work together to provide cooperative, coordinated care through the Medical Home model. This approach matches each patient with a primary care physician who leads a health care team that addresses the patient's health needs. Community Care of Lower Cape Fear's care managers provide services to enable patients to better manage their chronic health conditions. The goal of Community Care of Lower Cape Fear is to improve health outcomes and quality of life for our patients, while reducing care costs in the communities it serves. Community Care of Lower Cape Fear is one of 14networks participating in the statewide healthcare partnership called Community Care of North Carolina. All 100 Counties in North Carolina are covered by a Community Care of North Carolina Network, with more than 4,500 primary care providers participating statewide.

Careful examination of the data listed for Brunswick County show the top indicators in each category are (not in order of priority):

- Heart disease
- Diabetes
- Stroke
- Obesity
- Tobacco use
- Cultural health beliefs
- Economic issues
- Lack of cholesterol / blood pressure screenings
- Teen pregnancy
- Lack of exercise
- Lack of fruits and vegetables in diet

From in-depth analysis of the data, Novant Health Brunswick Medical Center and its collaborative community partners have determined to focus on the following health priorities:

- 1. Obesity reduction efforts in the community especially schools
- 2. Diabetes education and support
- 3. Provide health screenings in the community including cholesterol, glucose, and blood pressure
- 4. Address minority health issues focusing on cancer, hypertension, and diabetes
- 5. Emphasis on reducing number of women who smoke while pregnant

The prioritized health needs of the community were collectively reviewed by the Novant Health Brunswick Medical Center Board of Directors. The Board evaluated each documented need and its intersection with the organization's vision, commitments, and key strengths. Subsequently, the team further prioritized the health needs agreeing upon the top three health priorities:

- 1. Chronic Disease & Disability Prevention: Diabetes
- 2. Chronic Disease & Disability Prevention: Childhood Obesity
- 3. Smoking During Pregnancy

Novant Health Brunswick Medical Center is working to address each of the identified areas of need through resource allocation and support of the following programs:

- 1. Diabetes: Blood glucose screenings; diabetes education
- 2. Childhood Obesity: women's and children's wellness education; children's nutrition education
- 3. Smoking During Pregnancy: OB/GYN referrals for smoking cessation; smoking cessation courses
