Membership Identification Badges

All members will be issued an I.D. that must be presented for admission into the pool complex.

Membership I.D's. are non-transferable.

Lost I.D. Badges must be replaced at a cost of \$5.00 per badge.

Guest Policy

Members 18 years of age and older will be permitted to bring in non member guests on a daily basis through the purchase of a guest card.

3 admission guest card \$25.00

5 admission guest card \$40.00

10 admission guest card \$75.00

Guest cards are non-transferable

Guest cards can only be used by a current member of the facility.

The sponsoring member must be present to bring in a guest.

The sponsoring member is responsible for the behavior of any non member they bring into the facility.

The member may not leave their guest alone in the facility at any time.

Guardian Form

Any member wishing to allow a member/non-member adult to accompany their child into the facility must fill out and sign a **guardian form** in advance. This form acknowledges that this adult is responsible for supervising their child while in the pool facility.

Guest Rain check Policy

Guest credits will not be refunded in the event that the facility is forced to close due to inclement weather. Members are encouraged to check the weather forecast before bringing in guests.

In the event that the pool facility is forced to close due to equipment malfunction, or fecal accident, the sponsoring member will be given a rain check for guest credits used on that day. Guests must leave faculty within 15 minutes, member must return the guest wristband to office for rain check.

Splash Park Specific Rules

No child over the age of 13 may use the splash park

No Chairs will be allowed in the splash park

Parents must supervise their children at all times

All children in Diapers must wear rubber pants and bathing suits or "Swim Diapers" in the pool area

All diaper changing must be done in the changing area of the family bathroom

Code Incorporation

The swimming pool code of the New Jersey State Department of Health is hereby incorporated into these rules and becomes a part therof.

Penalties

Any person or persons violating any of the above rules and regulations may have their membership suspended at any time

Hours of Operations

Monday thru Friday - 12:00pm-8:00pm

Weekends and Holidays - 11:00am-8:00pm

<u>Main/Recreation Pool Specific</u> <u>Rules</u>

All swimmers must be at least 3 years of age and toilet trained (no diapers or swim pants will be allowed).

No flotation devices with the exception of management approved safety vests will be permitted.

During periods of excessive heat, adult swim periods will be called each hour on the hour. During these adult swim periods, all patrons under the age of 16 must exit the pool.

Training Pool Specific Rules

The training pool will be divided into three sections. One section of the pool will be designated for adults 21 and older. Two lanes will be designated for adults 16 and older. The swim lanes will be specifically designated for lap swimming and training only.

Members under the age of 16 will only be permitted to use the training pool during designated hours.

Flotation devices will not be permitted unless they are solely for the purposes of training.

Management reserves the right to close the training pool when its use is necessary for a swim meet or staff training exercise.

Wading Pool Specific Rules

No child over the age of 7 may use this pool

Parents must supervise their children at all times

All children in Diapers must wear rubber pants and bathing suits or "Swim Diapers" in the pool area

Management

The pool facility is operated by a certified, licensed management staff and Red Cross certified Lifeguards. They are responsible for the maintenance, order, and cleanliness of the pool complex and the enforcement of all rules and regulations. Proper respect and cooperation is expected at all times.

General Rules

The following rules and regulations have been instituted to ensure the welfare and safety of all of our patrons as well as the safe and sanitary operation of the pool facility. Failure to comply with any of the rules will result in the immediate suspension or revocation of membership.

All members must present their I.D. tag/badge for admission. Any person without a tag/badge will not be permitted to enter the facility.

No one is permitted in the water unless a lifeguard is present

Direct all questions to pool management. Please do not direct questions to lifeguards while they are on duty watching the pool.

All vehicles shall park in designated areas.

All food and drink must be consumed in the pavilion area of the facility. No food or drink except bottled water in plastic bottles will be permitted anywhere else in the facility (this includes gum, and candy).

Outside food may not be brought in, or delivered to the facility.

No glass/metal flip top bottles or containers will be permitted anywhere in the facility. This includes the pavilion area.

Members under the age of 13 will not be allowed into the complex without a parent or pre-registered guardian (See guardian form explanation on page 2)

The North Bergen Pool complex will not be responsible for any valuables brought into the facility.

Dress in and out of the pool will be consistent with standards of good taste. No indecent or unnecessary exposure will be permitted.

No soliciting will be allowed on the pool premises.

All bathers, including babies must wear bathing attire (cut-off jeans/pants are not allowed).

All persons planning to enter the water must shower prior to entering.

Patrons may not bring outside food into the facility.

Chairs may not be chained/tied to the fence or any other structure in the facility. Chairs may only be placed in specifically designated chair storage areas.

Any patron showing signs of having a communicable disease, open blister or cuts, sore inflamed eyes, ears, nose or mouth infections, excessive sunburn, or any type of skin disease will be excluded from swimming in any pool in the facility.

Any adult or child recently suffering from diarrhea (within 14 days) cannot swim in the pool. Doing so will risk the health and safety of all others in the pool.

Bicycles must be parked in designated areas.

No rowdiness, gambling, profanity, or other conduct unpleasant to or affecting the comfort of others will be permitted.

The use of air horns, whistles or any other emergency signaling devices is strictly forbidden in or around the facility.

No alcohol will be permitted in the pool facility.

There is no diving, or other head first entry anywhere in any pool.

Management reserves the right to close any and all portions of the pool at any time, for any reason.

Willful destruction of property will result in the suspension or revocation of membership.

The hanging of towels, clothing and bathing apparel on pool fences and structures is not permitted.

No pets or animals will be allowed into the facility.

No wrestling, running, or ball playing will be allowed within the pool area.

Management reserves the right to deny access to any member if the facility has reached the maximum capacity allowed by law.

No radios will be allowed in the facility (walkman type personal listening devices will be permitted).

No person appearing to be under the influence of drugs or alcohol will admitted into the facility.

No ground umbrellas will be allowed in the facility.

No tobacco products will be allowed anywhere in the facility. This includes but is not to limited to cigarettes, cigars, pipes, chew, and dip.

No spitting, expectorating, urinating, or spouting of water or other similar actions will be allowed in the pool area.

In the event of inclement weather such as thunder, lightning, heavy wind and rain the facility will be closed, and remain closed until all threats to public health have dissipated. At such point in time all patrons must exit the facility.

Management has the discretion to close the facility early if the weather has been bad for a large percentage of the day.

Lifeguards judgment prevails.

Anything not specifically covered in the rules that affect the health, safety, and comfort of pool patrons will be left to the discretion of the pool manager.

Management reserves the right to amend any of the aforementioned rules, regulations, or hours of operation at any time for any reason.
