## Local House Corporation Project of the Year (two categories)

#### 1. Project of the Year - Major Renovation

This award is given to the local house corporation for an outstanding major renovation \$250,000 or over that has enhanced the facility during the period March1, 2012 through January 31, 2014.

In one envelope, please supply the following material:

#### 2. Project of the Year - Special Project

This award is given to the local house corporation for an outstanding major renovation under \$250,000 that enhanced the facility during the period March 1, 2012 through January 31, 2014.

In one envelope, please supply the following material:

  - Fully describe the project.
  - Explain how the project has enhanced the facility and how it has benefited the collegiate chapter.
  - Provide photos, if possible.
- Letter of support providing justification for receipt of award from the chapter executive board with chapter president signature. *Recommended, not required.*
- Letter of support from the chapter advisory board with chapter advisor signature. *Recommended, not required.*

## Special Local House Corporation Awards (six categories)

#### 1. Facility Usage

This award is given to the local house corporation who has modified an existing space in the facility to meet the changing needs of the chapter during the period March 1, 2012 through January 31, 2014.

In one envelope, please supply the following material:

- Describe the project initiated to modify or change an existing space to adapt to the chapter space usage needs.
- Letter of support providing justification for receipt of award from the chapter executive board with chapter president signature.
- Provide photos, if possible

#### 2. Use of Branding

This award is given to the local house corporation that creates a living-learning environment for its collegiate chapter that promotes Alpha Chi Omega's heritage through symbols, pictures, color schemes, etc., during the period March 1, 2012 through January 31, 2014.

#### 3. Risk Management

This award is given to the local house corporation that has initiated a risk management initiative to improve the safety of the living environment for the chapter during the period March 1, 2012 through January 31, 2014.

#### 4. Joint Local House Corporation and Chapter Housing Project

#### 5. Joint Local House Corporation and Chapter Friend-Raising Initiative

This award is given to the local house corporation that partnered with the chapter in a "Friend-Raising" initiative. The initiative focuses on engaging alumnae in local house corporation chapter activities and/or needs during the period March 1, 2012 through January 31, 2014.

- Provide a letter of support from the chapter executive board with chapter president signature acknowledging the positive partnership in accomplishing the housing project.

#### 6. Local House Corporation Sustainability/Green Initiative

This award is given to the local house corporation for an outstanding sustainable/green initiative that has enhanced the facility during the period March 1, 2012 through January 31, 2014.

- Letter of support from the local house corporation board with the board president's signature. Recommended, not required.
