Texas Application for Registry of Approved Bingo Workers

WHO MUST SUBMIT THIS APPLICATION

You must submit this application to be listed on the Registry of Approved Bingo Workers (Registry). Any person that will be involved with the conduct of bingo as an operator, manager, cashier, usher, caller, salesperson, bookkeeper or Bingo Chairperson for a regular license holder must be listed on the Registry before they may begin working in their position unless they are employed on a provisional basis while awaiting the results of their background investigation and disclose this status on this form.

GENERAL INSTRUCTIONS

- The information requested below is necessary to conduct a criminal history background investigation which is authorized under the Bingo Enabling Act, Occupations Code, Chapter 2001.
- A person will not be listed on the Registry if, during the preceding ten years, the person has been convicted of a felony, criminal fraud, gambling related offense or crime of moral turpitude, or served any sentence, parole, mandatory supervision, or probation for such offense. A crime of moral turpitude would include forgery, theft, an offense that involves knowingly filing false information with a governmental agency, or any Class A misdemeanor defined by another state law as a crime of moral turpitude.
- Any changes to information contained on this application must be submitted to the Commission in writing or by filing Schedule N-3 Notice of Change for Registered Worker within 30 days of the change.
- If approved, a person will remain on the Registry for a period of three years from the date approved by the Commission. It is the responsibility of the registered person to reapply on or before their expiration date in order to remain on the Registry. All persons listed on the Registry and their expiration date can be confirmed at www.txbingo.org.
- NOTE:** If you reside outside of Texas, a Federal Bureau of Investigation or Texas Department of Public Safety fingerprint card must accompany this application.

PROVISIONAL EMPLOYMENT INSTRUCTIONS

- If you are employed as an operator, manager, cashier, usher, caller or salesperson on a provisional basis while awaiting the results of a background check by the Commission, check the Provisional Employment checkbox in item K and complete the playing location information requested in items L through O. If you will be working at more than one playing location, attach additional sheets.
- A bingo chairperson or bookkeeper is not eligible for provisional employment. They must be listed on the Registry before they may begin working in their position.
- A copy of this completed form and all fax or e-mail verification should be maintained by the licensed authorized organization provisionally employing you at the playing location until the individual is listed on the registry or the licensed authorized organization is notified that the individual is not qualified to be listed on the registry.
- All provisional employees should wear an identification card with the registry applicants name, 'Provisional Employment' in lieu of the unique registration number and the date that reflects the date the registry application was submitted to the commission as the expiration date while on duty. Blank cards are available at www.txbingo.org.
- A provisional employee must immediately stop working if: 1) after 14 days they are not listed on the registry if the individual is a resident of this state; 2) after 45-days they are not listed on the registry and the individual is not a resident of this state and submits a fingerprint card for a background investigation; and 3) found to be disqualified on the basis of the background investigation.
