### Damages & Security deposit:

The RENTER acknowledges his/her RESPONSIBILITY for the safe and proper operation of the boat, and for the safety and welfare of other boaters and passengers. It is agreed and understood by the renter that PYS shall not be held liable for damages, inconveniences or time lost caused by an accident, breakdown, or malfunction of the boat. RENTER further agrees to indemnify and hold harmless PYS and its agents against any and all claims. In Consideration of the agreement herein, Portland Yacht Services (herein referred to as PYS) agrees to lease to the undersigned (herein after referred to as the LESSEE) the boat and equipment describer herein. In the event the craft is not returned at time specified herein SAID Lessee agrees to pay for OVER TIME at the rate of \$50 per hour. Initial: \_\_\_\_\_

The LESSEE certifies that he/she has examined the boat and equipment and fined it acceptable and suitable for the purpose for which it is leased. That he/she will operate the boat in accordance with all safety rules and regulations as posted in this office and on the boat and further certifies that he/she has read and understand the rules and regulations. Lessee agrees to report any accident, malfunction or breakdown of rental craft to PYS immediately in accordance with the rules. Initial: \_\_\_\_\_

This certifies that I (We) , the lessee(s) are / am experiences and capable in all aspects of the handling and operation of the boat such as the one rented above. Lessee agrees that the PYS boat will not be occupied by a greater number of persons that is show in this rental agreement. I ( we) have familiarized myself / ourselves with a chart of the Casco Bay. The Lessee acknowledges he/she has carefully examines the boat and finds it suitable for the purpose for which it is leased, and that other accessory equipment is in the suitable and acceptable condition: that he/she will maintain both boat and equipment in a safe dependable condition. A major credit card authorization or CASH in the amount of \$500 shall be retained by PYS as partial compensation for failing to return the boat in good condition. Initial: \_\_\_\_\_

Lessee expressly agrees to indemnify and hold PYS and its agents, affiliates and personnel, HARMELESS of from and against any and all loss, cost, damage, attorney fees and/or liability in connection with the enforcing of the rental contract, including expenses incurred in connection with attempting to collect delinquent rent and in the event of a suit by LESSOR, to recover posse ions of said boat and / or to enforce any terms, conditions and / or provisions hereof.
