- 1. All bids to be per lot as numbered in the catalog unless otherwise mentioned by the auctioneer.
- 2. The highest bidder to be the buyer. In all cases of disputed bids, the lot shall be resold, but the auctioneer will use his judgement as to the good faith of all claims and his decision is final.
- 3. Bidders are required to register and give full identification prior to bidding and are required to use the number issued to them when identifying themselves as the successful bidder.
- 4.A good faith deposit of \$500 is required at the time of registration. This can be cash or credit card. If you do not make any purchase, your deposit will be returned in full.
- 5. The name and/ or number of the buyer shall be given immediately after the sale of each lot. When required, each buyer shall sign a form giving the lot number, amount for which sold and such deposits as may be demanded for all or pant of the lot. If the foregoing conditions are not complied with, said lot or lots may be resold at the option of the auctioneer.

- 15. Should Auction Company not be satisfied with credit information provided by purchaser. company shall hold, at Seller's request, for a period not longer than 72 hours, any such vehicle which purchaser has been the successful bidder, for satisfactory payment.
