## Day 2 Psychological First Aid

Psychological First Aid is designed to provide front line workers and first responders with a comprehensive overview of the pervasive psychological impact of exposure to traumatic stress. In this course participants will learn about the: 1) four specific categories of trauma; 2) variables related to trauma severity; 3) neurobiology of traumatic stress; 4) impact of trauma on the human nervous system; 5) common mental health disorders that emerge from psychological trauma; 6) nature of traumatic memory and its impact on eye witness testimony; 7) practical application of trauma stabilization techniques.

Jacqui replied to a question about similar Psychiatric First Aid courses and explained: The course I developed was adapted from the basic PSA model to be used in chronically traumatized populations as opposed to acute trauma, which is what PSA was initially designed for. As such, it includes advanced information on trauma psychology, attachment theory, and the neurophysiology of traumatic stress, none of which are part of the basic PSA course.
