

Rent In Advance / Rent Deposit Loan Application Form

Important Information

- 1. Only apply if you are homeless or threatened with homelessness.
- Please answer ALL the questions in this form so that we can decide whether you are eligible for a loan under the Rent in Advance/Rent Deposit scheme. Failure to do so will delay a decision being made and your application form will be returned to you to complete.
- 3. Please provide **ALL** information and evidence requested at the end of this form so that we can decide whether you are eligible for a loan under the Rent in Advance/Rent Deposit scheme. **Failure to do so will delay a decision being made.**
- 4. Where a Joint application for loan is being made, **ALL** relevant information (e.g. income, expenditure) should be given for both applicants.
- 5. You will **NOT** be eligible for a loan if you have already moved into the property. You should not make arrangements to move until the loan is agreed.
- 6. This will include looking at your income and outgoings and may include a credit reference check.
- 7. You will **NOT** be eligible for a loan if you if you have outstanding debts or arrears with Huntingdonshire District Council which are not being addressed.
- 8. You will **NOT** be eligible for the loan if the Council decides that the property is unaffordable for you or that your income is sufficient not to require the loan.
- 9. You will NOT be eligible for a loan if you own a property.
- 10. Please be aware that any loan amount may be **RESTRICTED** as a result of the Local Housing Allowance. The **maximum loan allowed** will be no more than twice the Local Housing Allowance you are entitled to.
- 11. The Council aims to make a decision on your application within **10** working days of receiving ALL the information requested.
- 12. The information you give will only be used in connection with your application for this loan.
- 13. Please also be aware of **legislation in respect of Rental Deposits** which came into affect on 06th April 2007 requiring new tenancy deposits to be protected in a government-authorised scheme where the tenancy held is an assured shorthold tenancy.
