**ORDER APPOINTING INTERPRETER**

On the date signed below, the Court considered the Applicants’ Motion to Appoint an Interpreter to assist Applicants and the attorney ad litem appointed by this Court and the Court in interpreting questions and information from the English language to the \_\_\_\_\_ language, and in understanding the documents filed in this suit in the matters pertaining to the Application for Appointment of Guardian of the Person of \_\_\_\_\_, an Adult, and Affidavit of Indigency because Applicants are unable to pay the cost of an interpreter. The Court finds that:

1. Applicants need the assistance of an interpreter who is able to interpret the English language into the \_\_\_\_\_ language and back again so Applicants may understand and respond to questions from the attorney ad litem appointed by this Court during that attorney’s investigation, and understand and respond to questions from this Court at the final hearing about their Application;

2. Applicants have requested appointment of \_\_\_\_\_, whose qualifications for this appointment are:

a. as a member of the National Association of Judiciary Interpreters & Translators, and the Houston Interpreters & Translators Association, he has been appointed as an interpreter by the judges in federal, state and county courts in Texas, including district and county courts in Fort Bend County;

- b. he has a B.A. in Languages and was born in \_\_\_\_\_, the native country of the Applicants in this case, and is able to interpret and translate \_\_\_\_\_ into English and English into \_\_\_\_\_;
- c. he is over eighteen years of age;
- d. he is not a party to this proceeding; and
- e. if appointed by this Court, he is willing to be sworn and perform the services of interpreter for purposes of permitting the Applicants to understand all documents filed in this suit and interpret for them in responding to questions from the attorney ad litem appointed by this Court during that attorney's investigation and in responding to questions from this Court at the final hearing on this Application; and

3. Applicants are not able to pay the cost of this proceeding and are unable to pay the cost of an interpreter.

**IT IS THEREFORE ORDERED** that \_\_\_\_\_, an interpreter able to interpret the English language into the \_\_\_\_\_ language and back again and able to explain to the Applicants in the \_\_\_\_\_ language the documents filed in this suit is hereby appointed as the Interpreter for Applicants \_\_\_\_\_ and \_\_\_\_\_, and for the Proposed Ward \_\_\_\_\_, an Adult, with respect to the Application for Appointment of Guardian of the Person of \_\_\_\_\_, to assist them by explaining to them in the \_\_\_\_\_ language the documents filed in this proceeding, and assist them in communications with the attorney ad litem appointed by this Court during that attorney's investigation, and assist them in communications with this Court at the final hearing on the Application, and the Interpreter will be compensated by Fort Bend

County, Texas for these necessary services in an amount determined reasonable by the Court at the final hearing of this suit.
