GENERAL INFORMATION FOR ALARM USERS

The following are the major requirements for alarm users:

PERMITS:

A permit must be obtained within sixty (60) days of the installation of an alarm system to transmit or relay a signal intended to summon emergency services of the Town of Prosper. Permits must be obtained before an alarm system is activated.

It is the responsibility of the permit holder to apply for renewal prior to the last day of the month in which the permit expires.

PERMIT FEES: Residential - \$36
Commercial - \$48

SERVICE FEES:

The alarm ordinance allows the permit holder five (5) free burglar alarms per alarm site during any twelve (12) month period. Service fees are as follows:

Service Call	Fee
0 – 5 False Burglar Alarms	No Charge
5 – up False Burglary Alarms	\$75.00 per Alarm
All False Robbery Alarms	\$75.00 per Alarm
0 – 2 False Fire Alarm	No Charge
2 – up False Fire Alarm	\$75.00 per Alarm
0 – 2 False Emergency Medical Assist Alarms	No Charge
2 - up False Emergency Medial Assist Alarms	\$75.00 per Alarm

RESPONSIBILITY OF PERMIT HOLDER

The person in control of the local alarm shall comply with all requirements of operation and maintenance as outlined in the town ordinance.

The permit holder is responsible for informing the town in writing of any change that alters the information listed on the permit application.

VIOLATION:

Any person who operates an alarm system in violation of this ordinance shall be deemed guilty of a misdemeanor and fined not in the excess of \$500.00. Each day of violation shall constitute a separate and distinct offense.

SUSPENSIONS:

A permit may be suspended or renewal refused if an alarm system generates an excessive number of false alarms.

Any false statement or misrepresentation of material fact made by an applicant for the purpose of obtaining an alarm permit or renewal while making a change thereto shall be sufficient cause for refusal to grant, or suspension of a permit.
