Failure to complete all the required sections of this form will result in your application being rejected.

Entitlement to a Metis Nation of Alberta Membership

“Metis” - a person who self identifies as Metis, is distinct from other Aboriginal peoples, is of historic Metis Nation Ancestry and is accepted by the Metis Nation.

A Métis must provide historical proof of his or her status as Métis:

- a) Historical Proof—evidence of an ancestor who received a land grant, or a scrip grant under the Manitoba Act or the Dominion Lands Act, or who was recognized as a Métis in other Government, church or community records
- b) Historic Métis Nation means the Aboriginal people then known as Métis or Half-Breeds who resided in Historic Métis Nation Homeland;
- c) Historic Métis Nation Homeland means the area of land in west central North America used and occupied as the traditional territory of the Métis or Half-Breeds as they were then known

Metis Homeland: The Homeland Geographically, braces all three Prairie Provinces (Manitoba, Saskatchewan and Alberta) also parts of Ontario, Northwest Territories and British Columbia

Requirements Checklist

- ☐ A completed Genealogy (Family Tree) which clearly outlines your Métis ancestry to the mid 1800's.
- ☐ Copy of live birth registration OR copy of a long form birth certificate showing the full names of biological parents OR
- ☐ Copy of baptismal certificate with Church seal legible PLUS wallet-size birth certificate
- ☐ One (1) piece of photo identification
- ☐ Proof of permanent residency in Alberta for a minimum of ninety (90) consecutive days may be required.

Photo Specifications

Your Membership card process will be slowed down considerably if the following guidelines are not followed:

IMAGE INFORMATION:

- Photos must be taken with uniform lighting and not show shadows or flash reflection on the face and head
- Photos must show a full front view of the face with both edges of the face showing clearly. The face and shoulders must be centered in the photo and squared to the camera
- Eyes must be open and clearly visible. Glasses, including tinted ones with prescription, may be worn as long as the eyes are clearly visible. Sunglasses are unacceptable
- The image must be clear, sharp and in focus
- Photos must be taken against a plain, uniform, white or light colored background
- Photos must reflect/represent natural skin tones
- Hats or head coverings are not permitted except when worn for religious reasons and only if the full facial features are clearly visible
- Photos must be in color

Digital Photos may be e-mailed to Registry@metis.org (please ensure you have your birth date and full name on the e-mail) or you can go to your Regional Office/Provincial Office to have your photo taken.

Incomplete applications received by mail will not be processed and will be returned to you or to your Regional Office
