#### 1. GENERAL INFORMATION

#### 1.1. Purpose

The purpose of this Request for Proposal (RFP) is to solicit proposals to provide AB86 Adult Education Professional Services, for the Kern Community College District, on behalf of the Kern CCD AB86 Adult Education Consortium. Any resulting agreement will be between the supplier whose proposal is selected and the Kern Community College District ("District" or "KCCD").

#### 1.3. RFP Designations

The following designations are used interchangeably and will apply for the purpose of this RFP:

The term "Kern Community College District," "Kern CCD," "KCCD," "District," "Bakersfield College" or "College"; "Porterville College", or "Cerro Coso Community College", as used in this RFP shall be construed to include its employees, officers and agents at its District Office and campuses.

The term "Vendor," "Candidate," "Supplier," "Bidder" or "Consultant" shall mean any company who submits a response to the RFP to fulfill the conditions and terms of this RFP.

The term "Successful Vendor," "Successful Bidder" or "Awarded Vendor" shall mean the company awarded this contract.

#### 2. SCOPE OF PROPOSED SERVICES

The Kern Community College District is seeking a successful vendor(s) to work collaboratively with the District in completing the CCCCO AB 86 Adult Education Consortium Planning Grant.

#### 2.1. Kern CCD Profile

See Attachment A, Consortium Management Plan.

#### 2.2. Intent

The Kern Community College District is seeking vendor(s) who are able to clearly demonstrate their relevant experience and expertise as it relates to completing the CCCCO AB86 Adult Education Consortium Planning Grant (for more information generally see <u>http://ab86.cccco.edu</u>) in particular the potential bidder is referred specifically to *Attachment <u>B</u>*, the CCCCO AB86 Certificate of Eligibility document which is incorporated and made a part of this solicitation as though fully set out herein.

#### 2.3. Service Required

Subcontracting is not allowed without prior approval of the Kern Community College District.

The vendor will be asked to collaborate with the Kern CCD AB86 Planning Grant Consortium and any and all other vendors, on each and every and all aspects of the scope(s) of work awarded to the vendor.

Bidder's Statement of its Scope of Work Election, *Attachment <u>C</u>*, must be completed and submitted along with your response to this RFP.

#### Scope of Work A: Project Coordination

The successful bidder will have expertise with strategic planning within and across multiple adult education sectors. The project coordinator is responsible for and will convene, direct, engaging other experts, and assist other contractors, consortium members, consortium partners and stakeholders in timely completing the work plan consisting of the seven (7) objectives as described and required by the AB86 Certification of Eligibility Instructions, Terms and Conditions documents, attached hereto and incorporated as though fully set out herein.

#### Scope of Work B: Plan Narrative & Compilation

The successful bidder will have experience writing and compiling large scale and scope strategic planning documents with a large number of contributors. The successful Consortium Plan bidder is responsible for and will work with the project coordinator, other contractor(s), consortium committee representatives, consortium members, consortium partners and stakeholders in timely completing the work required by the AB86 Certification of Eligibility Instructions, Terms and Conditions documents, attached hereto and incorporated as though fully set out herein. The successful sub region plan bidder will work with sub-region groups, using member – and contractor-provided data will be responsible for timely submission of the regional plan to the Project Coordinator for final writing, editing & compilation.

#### Scope of Work C: Adult Education Data

The successful bidder will have extensive experience in gathering, obtaining and using adult education data to identify, determine and distinguish between excellent, good, adequate and inadequate student progression; national best practices for accelerated student learning; best practices educational delivery models for frontier, rural and urban settings; and related adult education expertise. The successful bidder providing Adult education Data is responsible for and will work with the project coordinator, other contractor(s), consortium committee representatives, consortium members, consortium partners and stakeholders in timely completing the work required by the AB86 Certification of Eligibility Instructions, Terms and Conditions documents attached and incorporated as though fully set out herein.

#### Scope of Work D: Labor Market Data

The successful bidder will have extensive experience in gathering, obtaining and using labor market data to define specific local economies geographically, distinguish them from adjacent areas, identify commonalities, identify high wage high growth job opportunities for adults with less than a Bachelor's degree, based on employer provided information, work with the local WIBs and other stakeholders to ensure that the members, partners and stakeholders have the information and understanding of the information necessary to make important adult education decisions as part of this planning process. Labor Market data will need to be disaggregated to the Census Designated Place level in the frontier and rural areas and to the Census Block Groups level in the urban areas. The successful bidder providing Labor Market Data is responsible for and will work with the project coordinator, other contractor(s), consortium committee representatives, consortium members, consortium partners and stakeholders in timely completing the work required by the AB86 Certification of Eligibility Instructions, Terms and Conditions documents, attached hereto and incorporated as though fully set out herein.

#### 3. RULES AND INFORMATION GOVERNING COMPETITIVE PROCESS

#### 3.1. Proposal Submittal Process

- 1. All information must be entered legibly in ink or typewritten. The proposal submitted must not contain any erasures, interlineations, or other corrections.
- 2. Proposals shall be received by District, at the address stated in this RFP, on or before the date and time required. No oral, telegraphic, telephonic or facsimile proposals will be considered.
- 3. Corrections and/or modifications received after the specified closing time will not be accepted.
- 4. An authorized officer or employee of the responder must sign all responses.
- 5. Submit responses in a sealed envelope with the RFP number, closing date, and time shown.
- 6. Addenda issued by the District interpreting or changing any of the items in this RFP, including all modifications thereof, shall be responded to and incorporated in each proposal. The Vendor shall sign and date any Addenda Cover Sheet, submitting them with the proposal, or otherwise expressly acknowledge, in writing, receipt of all addenda.
- 7. All proposals received by the District will be considered a "Public Record" as defined in California Government Code section 6252 and shall be open to public inspection, except to the extent of the Vendor designates trade secrets or other proprietary material to be confidential. Any documentation which the Vendor believes to be a trade secret must be provided to the District in a separate envelope or binder and must be clearly marked as a trade secret. The District will endeavor to restrict distribution of material and analysis of the proposals. Vendors are cautioned that materials designated as trade secrets may nevertheless be subject to disclosure and the District shall in no way be liable or responsible for any such disclosure. Vendors are advised that the District does not wish to receive material designated as trade secrets and requests that Vendors not supply trade secret materials unless absolutely necessary. No part of the Vendor's proposal or supporting materials will be returned and such material will become the property of the District unless portions of the materials submitted are designated as proprietary at the time of submittal, and are specifically requested to be returned.

- 9. The delivery of a proposal to the District is the sole responsibility of the Vendor. Proposals will not be accepted subsequent to the date and time specified. Proposals received by the District after the specified deadline will not be considered.
- 10. The District may waive any immaterial deviation or defect in a proposal. The District's waiver shall in no way modify the RFP documents or excuse the Vendor from full compliance with the Scope of Work if awarded the contract.
- 11. The contract to be negotiated must include the aforementioned requirements, as requested by the District.

#### 3.2. Proposal Validity Period

Proposals are to be valid for a period of one hundred eighty (180) days after the deadline for receipt of proposals.

#### 3.3. Withdrawal or Modification of Proposal

Proposals may be withdrawn or modified in writing and submitted by US Mail or hand delivery from the Vendor prior to the deadline for receipt of proposals. No oral withdrawals or modifications will be accepted.

#### 3.4. Basis for Award

#### Proposal Evaluation Method

The contract(s) resulting from this Request for Proposal, if any, shall be awarded to the most qualified and responsive, responsible bidder whose proposal is determined to be the most advantageous to the Kern Community College District, taking into consideration the evaluation factors set forth in this solicitation.

#### Evaluation Criteria

Points will be awarded to each proposal based on Kern CCD's assessment on behalf of the Kern CCD AB86 Adult Education Consortium of the following criteria:

- 1) Bidder's qualifications and current or past experience relevant to the submitted bid
- 2) Bidder has identified the proposed project staff, has provided their resumes and the proportion of their time (FTEs) allocated to this project.
- 3) Bidder's project management approach proposed and prior management experience
- 4) Bidder's proposal reflects a thorough understanding of and addresses the work described in the AB86 Statement of Eligibility
- 5) Bidder has demonstrated their ability to timely meet the expectations specified in the AB86 Statement of Eligibility.
- Bidder has demonstrated that the proposed project staff members are capable of meeting the expectations specified in the AB86 Statement of Eligibility.
- 7) Bidder has provided all of the documents required by this RFP.
- Bidder has provided a budget with sufficient detail that a third party reviewer can ascertain all proposed unit and aggregate costs and expenses.
- Bidder has demonstrated and justified the reasonableness of each and every projected or estimated expense itemized in the budget.
- 10)Bidder has disclosed any actual or potential conflicts of interest.

#### Awarding of Contract

The Kern CCD will, on behalf of the Kern CCD AB86 Adult Education Planning Grant Consortium, award the contract or contracts to one or more successful bidder(s) who display the ability and expertise necessary to achieve the desired result(s) and best meet the needs of the work and the consortium.

#### 3.5. Contract

<u>Contract form</u>: Upon final selection, bidder agrees to sign and return the agreement in the form attached as *Attachment D* within a 24 hour time period, which will be processed by the District for award of contract. The form of agreement is not subject to negotiation.

#### 3.6. Term

<u>Period of Compensable work</u>: Date contract approval by the Board of Trustees of the Kern Community College District on behalf of the Kern CCD AB86 Adult Education Planning Grant Consortium (estimated to be 05/1/2014) to 06/30/15

<u>Reporting period</u>: The vendor must remain available to provide documentation and complete the final expenditure report due on or before 8/31/15.

#### 3.7. Termination of Contract

KCCD may elect to terminate the contract, in whole or in part, for its convenience, and such termination shall be effective thirty (30) calendar days after mailing of such Notice of Termination for Convenience to the Vendor. Thereafter, the Vendor shall have no further claim against KCCD under the contract.

The successful Vendor may choose to terminate the contract, and the Vendor must give KCCD 60 days prior written notice by sending an explanation for the termination of their contract to the Kern Community College District, Attention Mr. Tom Burke, Chief Financial Officer, 2100 Chester Avenue, Bakersfield, CA 93301.

The successful Vendor shall be in compliance with all Federal, State and Local laws governing this invitation to bid.

#### 3.8. Issuing Office

The KCCD is issuing this Request for Proposal (RFP) through the Business Services Purchasing Department. The KCCD Business Services Department is the sole point of contact regarding all contractual matters relating to the requirements described in this RFP, and is the only department authorized to change, modify or clarify, the specifications, terms, and conditions of this RFP. All communications, including any requests for clarification, concerning this RFP shall be in written format and submitted to the District Contact Person:

#### 3.9. Questions Regarding This RFP

Vendors requiring clarification of the intent or content of this RFP, or on procedural matters regarding the Request for Proposal process, may request clarification by submitting written questions by email or in an envelope marked with the title and RFP # of the proposal and addressed to the District Contact Person. Answers to the questions will be provided to all Vendors without identifying the submitter. Questions regarding this RFP must be submitted using the attached Bidder Inquiry Form in Section 10 no later than March 20, 2014 12:00 p.m.

#### 3.10. Reimbursement of Costs

Each Vendor submitting a proposal is responsible for all costs associated with preparing and submitting a complete proposal, including costs that may be incurred in providing KCCD with additional information. KCCD is under no obligation to reimburse Vendor for any proposal costs or incur any costs on Vendor's behalf.

#### 3.11. Protest Against Award

Any vendor wishing to file a protest against this RFP document must do so in writing within 72 hours after proposals are reviewed. All protest will be taken under advisement. Any protest received after that will not be recognized.

A protest of any vendor proposal will be delivered to the Kern Community College District, Attention Mr. Tom Burke, Chief Financial Officer, 2100 Chester Avenue, Bakersfield, CA 93301, by certified mail or by personal delivery during normal working hours.

#### 3.12. Suspension and Debarment

The Vendor certifies, for itself and all its designated partners, that neither the Vendor, nor any designated partners are under suspension or debarment by the LEA (Local Educational Agencies) or any other governmental entity, instrumentality, or authority and, if the Vendor cannot so certify, then it agrees to submit a written explanation as an attachment to this RFP form of why such certification cannot be made. A Vendor must verify its suspension or debarment status.

#### 3.13. Responsibility and Notice of Any Change

It is the Vendor's obligation to see that the services provided are ongoing from and after the effective date of the Vendor Contract and any Purchase Order issued, through the termination date thereof. Accordingly, the Vendor shall notify KCCD and the campus or LEA, by written notification if at any time during the term of the Vendor Contract or any Purchase Order, it changes its place of business, becomes delinquent in the payment of taxes, or if it or any of its designated partners are suspended or debarred by any agency, LEA, federal government, or any other state or governmental entity. Such notification shall be made within fifteen (15) days of the date of suspension, debarment, delinquency or change.

#### 3.14. Defaults

Default by Vendor: The District will hold the Vendor responsible for any damage which may be sustained because of failure or neglect to comply with any term or condition listed herein. It is specifically provided and agreed that time will be of essence in meeting the contract delivery requirements.

If the successful Vendor fails or neglects to furnish or deliver any of the materials, supplies or services listed herein, at the prices named and at the time and place herein stated, or otherwise fails or neglects to comply with the terms of the Vendor Contract, the District may, upon written notice to the Vendor, cancel the contract/purchase order in its entirety or cancel or rescind any or all items affected by such default, and may, whether or not the contract is terminated in whole or in part, purchase the materials, supplies or services elsewhere without further notice to the Vendor. The prices paid by the District at the time such purchases are made will be considered the prevailing market prices. Any extra cost incurred by such default may be collected by the District from the Vendor, or deducted from any funds due the Vendor.

#### 3.15. Insurance Requirements

The successful bidder selected shall furnish to the District, prior to the commencement of services, an underwriter's certificate of insurance reflecting not less than the following limits:

- a. \$2 million per occurrence for Workers' Compensation, if required;
- b. \$1 million per occurrence for Comprehensive General Liability;
- c. \$1 million per occurrence for Automobile Liability;
- d. \$1 million per occurrence for Errors and Omissions insurance.

All insurance shall be issued by a company or companies listed in the current "Best's Key Rating Guide" publication with a minimum of a B+, V rating. The District, its trustees, officers, agents and employees shall be named as additional insured on the General Liability policy. Any deviations from the requisite policy amounts and ratings must be approved by the District.

#### 3.16. Hold Harmless Clause

The successful bidder shall hold harmless and indemnify KCCD from every claim or demand which may be made by reason of:

- a. Any injury to person or property sustained by the bidder or by any person, firm or corporation, employed directly or indirectly by him upon or in connection with his performance under this bid, however caused.
- b. Any liability that may arise from the furnishing or use of any copyrighted or un-copyrighted composition, secret process or patented or un-patented invention, under this bid.
- c. The successful vendor at his own expense and risk shall defend any legal proceedings that may be brought against KCCD on any such claim or demand, and satisfy any judgment that may be rendered against any of them.

#### 3.17. Force Majeure

Neither party will incur any liability to the other if its performance of any obligation pursuant to the Vendor Agreement or Purchase Order is prevented or delayed by causes beyond its control and without the fault or negligence of either party. Causes beyond a party's control may include, but are not limited to, acts of God or war, changes in controlling law, regulations, orders or the requirements of any governmental entity, severe weather conditions, civil disorders, natural disasters, fire, epidemics and quarantines, throughout the trade, and freight embargoes.

The Vendor shall notify KCCD orally within five (5) business days and in writing within ten (10) business days of the date on which the Vendor becomes aware, or should have reasonably become aware, that such cause would prevent or delay its performance. Such notification shall (i) describe fully such cause(s) and its effect on performance, (ii) state whether performance under the Vendor Agreement (Purchase Order) is prevented or delayed and (iii) if performance is delayed, state a reasonable estimate of the duration of the delay, if the nature of the force majeure event does not prevent Vendor from reasonably making such estimation. The Vendor shall have the burden of proving that such cause(s) delayed or prevented its performance despite its diligent efforts to perform and shall produce within ten (10) business days of college campus written request such supporting documentation as KCCD may reasonably request. After receipt of such notification, the College Campus may elect either to cancel the Purchase Order or to extend the time for performance as reasonably necessary to compensate for the Vendor's delay.

In the event of a declared emergency by competent governmental authorities, the LEA by notice to the Vendor, may suspend all or a portion of the Purchase Order.

#### 3.18. Declaration of Non-Collusion

This RFP requires the Vendor to attest under the penalty of perjury that no collusion took place in providing a response to this RFP. Vendors must complete the Vendor Non-Collusion Affidavit in Section 8 of this RFP. If a Vendor cannot answer yes to these questions, he/she/it will not be able to submit a response to this RFP.

#### 3.19. Conflict of Interest

Vendor shall exercise reasonable care and diligence to prevent any actions or conditions that could result in a conflict with the best interest of the District. Vendor's efforts shall include, but not be limited to, establishing precautions to prevent its employees or agents from making, receiving, providing or offering gifts, entertainment, payments, loans, or other consideration which could be deemed to appear to influence individuals to act contrary to the best interest of the District.

#### 3.20. Compliance With Civil Rights Law and Americans With Disabilities Act

The Vendor hereby assures that it will comply with Subchapter VI of the Civil Rights Act of I964, 42 U.S.C. Section 2000 (e)(17), to the end that no person shall, on the grounds of race, creed, color, sex or national origin be excluded from participation in, be denied the benefits of, or be otherwise subject to discrimination under this RFP or under any project, program, or activity supported by this RFP.

The Vendor agrees to comply with applicable Federal and California laws including, but not limited to, the California Fair Employment and Housing Act, beginning with Government Code Section 12900, and Labor Code Section 1735. In addition, the Vendor agrees to require like compliance by any subcontracts employed for the services provided by him.

The Vendor hereby assures that it will comply with the Americans with Disabilities Act of 1990, 42 U.S.C. Sections 12101 et seq., to ensure that disabled individuals shall be reasonably accommodated in accordance with the Act the Vendor shall not exclude from participation in, or deny the benefit of, or otherwise subject a disabled individual to discrimination under this contract, or under any project, program, or activity supported by this RFP. Vendors must complete the Certification of Non-Discrimination in Section 9 of this RFP.

#### 3.21. Work Hours and Safety Standards Act

In the performance of any purchase order under the contract, the Vendor shall adhere to and comply with all the provisions of Section 103 and 107 of the Contract Work Hours and Safety Standards Act (40 U.S.C. 327-330) and as supplemented in the Department of Labor regulations (29 CRF Part 5).

#### 3.22. Public Agency Clause

Public agencies are authorized by law to purchase off of a contract awarded by an agency including all K-12 schools districts, community college districts, special districts and JPAs serving education, pursuant to Public Contract Code Sections 20118 and 20652. Using these statutes, the KCCD hereby declares its intent and authorization to allow any contracts awarded under this proposal to be "piggybackable" by other agencies in the state, <u>if the awarded vendor agrees</u>.

KCCD waives any right to receive payment from other California agencies making purchases off the awarded contract. KCCD shall incur no financial responsibility or liability in connection with the participation by another public agency. Each public agency must accept sole responsibility for its own order placement and payments directly to the awarded Vendor, and should consult with legal counsel about the propriety of using the contract resulting from this RFP as a "piggyback."

#### 4. GENERAL SPECIFICATIONS

#### 4.1. Qualifications of Bidder

#### Minimum Qualifications

- 1. Bidder's principal staff member must have a minimum of five years' experience relevant to the work described herein.
- 2. Bidder's established corporate or company must have a minimum of five years' experience relevant to the work described herein.

#### Experience and Reference Information

In addition to pricing, proposals will be considered from experienced companies who can demonstrate the capacity to meet all of the needs stated in this RFP. The successful bidder shall be an organization that has an excellent record as a provider of the type and scope of work detailed in this RFP. To illustrate this, bidders must provide as part of their response to the RFP:

- 1. Name and address of operating firm, names of owners or principals of firm. Also include a completed W-9, Request for Taxpayer Identification Number and Certification.
- 2. List and describe any claims or lawsuits that have been made against Vendor for non-performance or inadequate performance.
- 3. Insurance requirements as explained in Section 3.15 of this RFP.
- 4. Provide historical background of company and all principals' relevant experience.
- 5. Corporate and individual resumes for each and every person being proposed as project staff.
- 6. A portfolio of relevant; similar work.
- 7. Provide a minimum of three (3) letters of reference for relevant and/or similar work from clients that the bidder has provided similar services to. Contact information for these references also required. Provide the client entity name, primary contact name and title, phone number, e-mail and mailing address. References must include feedback regarding your vendor client relationship, work ethic, work quality, examples of service provided and invoicing and payment tracking. Work samples for these reference are required as part of the submitted portfolio.
- 8. Identify proposed project director.
- 9. Provide specific hours/FTEs for each person being proposed as project staff.

#### 4.2. Special Terms and Conditions

#### Identification of Project Director

Successful bidder shall identify a Project Director who will be ultimately responsible for all aspects of the work undertaken in the fulfillment of the requirements of this Request for Proposal. The Project Director and key staff shall be regularly available to participate in a conference call with Kern CCD on progress toward project goals. Meetings will be required throughout the project as deemed necessary by Kern CCD.

#### 4.3. Proposal and Portfolio

#### Pre-Interview Questions

Bidders will include with their response to this Request for Proposal, the responses to the questions below:

- Describe how you would work with Consortium members, partners and stakeholders to accomplish the AB86 Comprehensive Plan.
- Describe why your firm/company/entity would be a good fit for this project.
- 3) Describe your tracking and accounting procedures.

#### 5. PRICING SPECIFICATIONS

#### 5.1. Price Proposal

The Kern Community College District is awarding this Request for Proposal on an approved cost reimbursement basis. The successful vendor will be required to submit monthly invoices which separate out the services provided with a total invoice payment specified. Monthly invoices will be accompanied by supporting documentation, including but not limited to; timesheets, purchase orders and other documents sufficient to evidence budgeted and encumbered expenses claimed for reimbursement.

Budget modifications are allowable but must be approved in writing prior to the encumbrance of any expenditure based thereon.

#### 6. ORDERING, SHIPPING AND DELIVERY

#### 6.1. Ordering

To obtain bid pricing, KCCD shall only reference the applicable KCCD authorized agreement numbers on the vendor's ordering system. No supplier bid numbers, quotes, or reference numbers are required for order placement.

#### 6.2. Acceptance of Purchase Orders

If an award is made, the Successful Vendor may receive a purchase order to furnish the awarded item(s). These purchase orders constitute the vendor's authority to make delivery. All purchase orders received by the Successful Vendor up to and including the expiration date of the resultant agreement are acceptable and must be fulfilled in accordance with the delivery time specified in the resultant agreement.

#### 6.3. Payment

KCCD will order the items or services, receive the items or services from the vendor and pay the vendor upon receipt of invoices.

#### 6.4. Invoicing

All invoices are to be sent directly to the specified bill-to address.

KCCD shall put forth reasonable efforts to make payment by the required payment date. The required payment date is: (a) the date on which payment is due under the terms of the purchase order; or (b) thirty (30) days after a proper invoice actually is received at the "Bill To" address, and the Purchase Order items invoiced are received and accepted by KCCD. Payment may be delayed if the payment amount on an invoice is not based upon the price(s) as stated in the purchase order and the items actually received.

Payment should not be construed by the Successful Vendor as acceptance of the items furnished by the successful vendor. KCCD reserves the right to conduct further testing and inspection after payment, but within a reasonable time after delivery, and to reject the item(s) if such post payment testing or inspection discloses a defect or a failure to meet specifications.

KCCD does not pay service charges on any invoice.

#### 6.5. Inspection and Acceptance

All items provided under the resultant agreement shall meet or exceed the RFP specifications and shall comply with all Federal and California State laws governing their production, handling, processing and labeling. Inspection and acceptance of all items shall be at destination. Items found to be defective or not in accordance with the RFP specifications shall be replaced by the

successful vendor at no cost to KCCD. Failure to replace said items shall be considered sufficient cause for default action under the default provision of the resultant agreement.

#### 6.6. Damages for Late Delivery

Liquidated damages shall be assessed and deducted from vendor's invoice at the rate of \$100 per day for the balance of items delivered after each specified due date.


#### **PROJECT MANAGEMENT PLAN**

#### **Organizational Structure**

#### Consortia Membership:

Describe existing collaborative relationships between the community college district and school districts related to adult education. Identify how these relationships may inform the planning process going forward.

<u>Consortia Members</u>: The Kern Community College District (Kern CCD) will be serving as fiscal agent for this project. The Kern CCD AB86 Consortia currently includes the Delano Joint Union High School District; The Kern High School District; the Wasco Union High School District; the McFarland Unified School District; the Mojave Unified School District, the Porterville



Unified School District; the Sierra Sands Unified School District; the Tehachapi Unified School District and the Mono County Office of Education representing the Eastern Sierra Unified School District and the Mammoth Unified School District. Non-member districts will receive additional information as area stakeholders: the Inyo County Office of Education representing the Bishop Unified School District; Big Pine Unified School District; and Lone Pine Unified School District; the El Tejon Unified School District; the Owens Valley Unified School District; and the Muroc Unified School District.

The Kern Community College District serves more than 1.3 million residents  $(3.5\% \text{ of Californians})^1$  in urban and rural communities located over 24,800 square miles comprising all or portions of Kern, Tulare, Inyo, Mono, and San Bernardino Counties. This geographic area is defined as the Consortia service area. Over the past five years the Consortia service area has seen a population growth rate of 8.3%, nearly double that of the state growth rate of 4.6%.<sup>2</sup>

The Kern Community College District serves area residents at several campuses. Bakersfield College has a main campus in metro Bakersfield and an

educational center in Delano. Porterville College's main campus is in the city of Porterville. Cerro Coso Community College has a main campus in the City of Ridgecrest and educational centers in California City, Edwards, Lake Isabella, Bishop, and Mammoth Lakes.

There are four (4) High School Districts (HSDs) and 13 Unified School Districts (USDs) in the Consortia service area that together serve 332,744 traditional age (5 to 19) students and which host the areas' five (5) adult schools in Bakersfield, Delano, Porterville, and two in the Sierra Sands USD, and adult education programs in McFarland and Wasco. Together, these adult schools and adult programs served an additional 17,477 adult students in the 2012/13 Academic Year in completing their high school diploma credits (credit recapture); studying for and taking the GED, raising basic skills, English as a Second Language (ESL), serving adults with disabilities; short-term career technical education (CTE) and apprenticeship programs. Adult schools and education programs in the area are maintaining services as required, but an estimated 1500 adults have been turned away or are on wait lists and are unable to be served.

Existing Adult Education Collaboration: The Kern CCD and the service area Unified School Districts (USDs) and High School Districts (HSDs) have long established and substantial relationships with significant breadth and depth. A few examples include:

- Southern and Eastern Sierra CTE Collaborative: The Southern and Eastern CTE Collaborative facilitates the programs and practices to help students transition from high school through college and into careers. The Collaborative has three strategic goals: 1. to increase the number of high school graduates in our region; 2. to increase the number of students entering community colleges in the region who are prepared to do college level work; and 3. to increase the number of students who complete programs and earn degrees or industry recognized credentials. To accomplish these goals, the collaborative has been focused on articulation agreements, Dual Enrollment, career exploration, career pathways. The Collaborative has supported and encouraged the use of CATEMA for tracking and ensuring that students taking articulated courses receive college credit.
- High School, Community College & Adult School CTE / Perkins Advisory Boards: Each of the three community colleges and five adult schools in the Consortia service area have established advisory boards comprised of members of the local community, business owners and industry association representatives. Area high school and community college advisory boards in the following Career Technical Education (CTE) disciplines include: Agriculture, Auto Mechanics, Business, Child Development, Construction, Culinary, Digital Arts, Hospitality, Health Careers, Industrial Technology, Information Technology, Manufacturing & Product Development, Teacher Assistant; Video and TV production; among others. A related type of advisory board is the Bakersfield College / California State University Bakersfield Community Nursing Advisory Committee.

Kern Community College District AB86 Consortia AB86 Project Management Plan

- Public / Appointed Boards: A number of project partners participate and/or serve on the following public or appointed boards: Early Childhood Council of Kern, a 30-member appointed advisory board to increase and enhance the quality of early childhood programs in Kern County. The Bakersfield College Child Development Advisory California Early Childhood Mentor Program Selection Committee; who selects experienced classroom teaches to mentor students from the community, college, ROP, and four-year early child development programs. The Eastern Sierra Foundation provides scholarships to Inyo County residents. The Mammoth Lakes Foundation provides scholarships to Mono County residents. .
- The North Kern Adult Education Alliance (AEA) was recently established to address gaps in educational programs for adults in the northern Kern County region. The alliance was recently established to be the link between the North Kern High School Districts (Delano, Wasco and McFarland) and Bakersfield College. The vision is to provide an adult education system that promotes the academic and career skills needed to support local industry and employ local citizens, as well as prepare students for post-secondary education. The group identifies problems, plans solutions, and implements the education and training needed to address the needs of the local adult population. Bakersfield College and the local school districts are committed to supporting North Kern students and adults in higher education. This process involves regular communication and planning to promote student education and training which lead to higher education or employment.
- Informal Groups or Associations: The Bakersfield Adult School partners extensively with the California Jail Programs Association, the Kern County Sheriff's Department AB109 collaborative, and many others detailed in the partners section.

The members have established articulation agreements, student transition efforts. While not all of the data is in yet, the Bakersfield Adult School (BAS) has 14 articulation agreements with Bakersfield College; and in the current year there are 465 students that articulated to and 91 BAS students are currently enrolled at Bakersfield College.

Co-location of College personnel on Adult School campuses: Bakersfield College on Delano Adult School Campus conducting academic development classes, financial aid and student orientations, and students participate in Bakersfield College Career Tech Open House opportunities at the Delano (College) Center.

#### Identify how these relationships may inform the planning process going forward:

Our established relationships between education, workforce training, non-profit, community, business and industry partners (listed in the next section) will share their expertise as to workforce demand; provide guidance as to the knowledge, skills and abilities needed by employees; the specific needs of target population and sub-populations being served; and serve as a liaison with the Consortia.

The established close working relationships between the community colleges and their respective feeder school districts have informed our awareness of the programs offered by each entity and spurred regular ongoing discussions of how we coordinate efforts to best serve the adult education needs in our respective communities.

The AB86 Adult Education planning efforts will deepen and broaden those relationships as we move forward to examine the impact of existing system coordination and transition mechanisms while we identify best practices that could result in better outcomes, more effective and efficient use of facilities, equipment and human resources to address the educational, vocational, and language proficiency needs of our adults.

#### Partnerships:

# List any identified partners and describe how these relationships may inform the planning process going forward.

The consortium expects to draw upon the expertise, leadership, and support of our partners in reaching the community residents that could potentially benefit from additional adult education opportunities. The adult education and community college consortia members regularly partner with:

<u>Educational Entities</u>: Consortia members routinely partner with one another across area education segments (K20). Consortia members regularly engage each other, business, and professional entities in maintaining the rigor and relevance of their existing programs of study through Perkins / Career Technical Education Advisory Committees. Consortia members routinely partner with adjacent colleges, college districts and related entities such as Taft College of the West Kern Community College District, WESTEC, and College of the Sequoias, among others. In the Eastern Sierra area, Sierra Sands USD, Cerro Coso have formal educational partnerships with China Lake NAWC, Bishop and Lone Pine Paiute tribal entities to provide college preparation, technical, vocational and STEM learning opportunities. The Regional Occupational Centers / Programs in the area (the Kern County ROP, the North Kern Vocational Training Center; the West Kern Vocational Training Center, the Tulare County Office of Organization for Vocational Education, and others) also offer programs in health careers, medical terminology, medical front office, criminal justice, restaurant, auto technology, construction, welding and TV/Video production short-term training opportunities for regional adults.

<u>County Offices & Departments</u>: The members routinely partner with America's Job Center of Kern County (formerly Employer's Training Resource; the job training and placement entity of the Kern, Inyo, Mono Workforce Investment Board (WIB) and a Department of the County of Kern); Kern Economic Development Corporation (KEDC), the Kern County Superintendent of Schools (KCSOS), the County of Kern; the Kern County Department of Human Services; Kern County Sheriff's Office (KCSO) AB109 Collaborative; the California Jail Programs Association, the Tulare Workforce Investment Board (Employment Connection).

<u>Workforce Training Partners & Nonprofit Community Based Organizations</u>: Consortium members regularly partner with CBOs such as the Kern Adult Literacy Council, the First 5 Kern, the Kern Childcare Association, the United Way of Kern County and the United

Way of Tulare County; CBOs serving persons with disabilities such as Associations for Retarded Citizens in area cities, the Delano Association of the Developmentally Disabled, and the Porterville Sheltered Workshop; and workforce training partners such as Proteus, MAOF, and others. Consortium members partner with local Delano CBOs such as the Delano Community Alliance and the Delano Area Counselor Collaborative; the eastern sierra CBO the Owens Valley Career Development Center who operates the Tribal TANF program supports Native American adults up to 25 years of age. In addition, the Consortium partners regularly with statewide, regional and local business and industry associations.

#### **Shared Leadership Strategies**

# Describe the shared leadership strategies that may be used during the planning project.

The Consortia service area of nearly 25,000 square miles has three economically distinct sub-regions with differing compositions of business and industry. This different mix of business and industry in each of the sub-regions results in distinctly different labor market needs. The Consortia will analyze the needs, services and gaps in comparison with the unique workforce demands of the corresponding sub-region.

#### Organization by Sub-Region

Eastern Sierra Sub-Region: Located in the eastern portion of the Consortia service area, the Eastern Sierra sub-region, the economic area is home to Edwards Air Force Base, the Naval Air Weapons Stations (NAWS), several fairly large alternative energy solar and wind farms, geothermal plants as well as mountain fishing / hiking / recreational hospitality oriented business and accommodations entities. The Eastern Sierra sub-region has higher-than state average rates of employment and educational attainment, owing to its armed forces and highly skilled technical and engineering workforce. However, the career pathway is fairly limited and most entry level jobs are relatively low-paying hospitality and retail positions. High wage high demand jobs in the Eastern Sierra sub-region includes registered nurses and correctional officers and, to a lesser degree, engineering technicians, drafts persons, etc. (EMSI)

<u>Porterville Sub-Region</u>: Located in the northern portion of the Consortia service area and comprising the eastern half of Tulare County, the Porterville sub-region is heavily dominated by the agricultural and dairy industries, food processing (manufacturing), several logistics / distribution centers, and related service industries. The Porterville sub-region has unemployment ranges from the state average to well below the state average, varying community by community. The Porterville sub-region will include the Lindsay USD, the Porterville Sheltered Workshop for persons with disabilities, the Tule River Band of Yokuts Indians Education Department, the Tulare County Office of Education ROC, Employment Connection of the Tulare County WIB, and Proteus a workforce training partner. <u>Greater Bakersfield Sub-Region</u>: In the southern portion of the Consortia service area (Greater Bakersfield; north to Delano and south to Arvin/Lamont and Frazier Mountain Park) is dominated by two primary industries, oil and agriculture. The oil and gas extraction industry and its related industries include construction, equipment rentals, and other related industries. The agriculture industry includes carrot, tree fruit and nut production, as well as related industries of food processing (manufacturing), pest management, equipment rentals and other related industries. The very southern end of this sub-region includes the Tejon Ranch, the Tejon Foreign Trade Zone and the Shafter Foreign Trade Zone, both duty-free foreign trade zone, and several logistics / distribution centers.

<u>Coordinating Work Group</u>: A coordinating working group will review the needs, services and gaps data for areas within, between, and outside these three primary economic and geographic areas to ensure that adult education students throughout the Consortia service area have the opportunity to improve their knowledge skills and abilities and thereby improve their competitiveness for higher paying jobs.

#### Shared Leadership Structure

The Consortia membership has agreed and adopted shared leadership strategies and specific structural features reflecting the needs of the membership. However, it is anticipated that as the planning work is undertaken, some elements or aspects of the Consortia's operational functioning may need to be altered or modified in order to ensure the effective completion of the consortia-wide planning tasks expected of the Consortia. In order to undertake this work, the Consortia has agreed to the following operational principles:

#### Members:

Members (Districts) are present and participatory.

Members include 1 representative from each Unified School District (USD), High School District (HSD) and community college (CC) within the KCCD service area. The 5 adult schools are part of the HSDs who are members. In some cases, the adult school principals have been designed as the contact for the HSD. The 3 community colleges are part of the Kern CCD who is a member and the fiscal agent for this project. There are other USDs and HSDs that are not presently members. Members will outreach to non-member USDs and HSDs. These districts will be treated as stakeholders and their CEO will be provided additional information regarding this project throughout the project period.

#### Regular Meetings: On-demand information & On-line collaboration

Regularly scheduled meetings (in person and available via on-line webinar) are expected to occur at least every 2 months; more frequently as needed. The subregions will meet monthly. Each sub-region will do an analysis of their current provision of services, service gaps, and needs. Each sub-region will contribute to the comprehensive plan as appropriate. Each sub-region will report out to the full consortia meeting every 2 months. This structure will result in a better stewardship of the available planning funds.

#### Fiscal Agent, Consortia Staff Functions

The Fiscal Agent will be responsible for timely reporting, sharing information, and providing technical equipment necessary for on-line and telephone-based meetings, collaborative work, and compilation of planning documents.

Consortia staff will record and disseminate meeting minutes, shared documents, and e-mails; make information available on-line on demand; support the on-line and in-person collaborative work, editing and compilation of the final planning documents.

#### Consortia Decision-Making and Business Agenda

The consortium has been making decisions by consensus. The Consortia may or may not elect to further refine its decision-making process into a voting structure reflective of the principles of shared leadership.

The consortium has agreed that among its' first order of business is to: create a statement of its core principles and values; develop a Memorandum of Understanding or Agreement for Consortia Members and a Memorandum of Understanding or Agreement for Partners; and establish task-based workgroups based on the objective number, or by topic area such as gathering labor market data or exploring / recommending shared on-line document creation.

#### **Project Planning Roles and Responsibilities**

# Identify the co-chairs, project directors, and/or the person(s) responsible for oversight of the project, and describe the roles and responsibilities that they will assume, including the timely submission of required reports.

<u>Co-Chairs</u>: Sandra Serrano, Chancellor, Kern Community College District and Don Carter, Superintendent of the Kern High School District will co-chair the Consortium during the planning process. The Co-Chairs are responsible for the setting of the meeting agendas, planning project coordination and implementation.

#### Programmatic & Fiscal Project Oversight, Roles & Responsibilities

The Kern Community College District, as the fiscal agent is responsible for programmatic and fiscal report submissions. John Means, Associate Chancellor of Economic and Workforce Development, will serve as the programmatic lead responsible for the timely submission of program reports. Carlene Feichter Accounting Manager is responsible for the submission of fiscal reports (including program reports from Mr. Means). Carlene Feichter reports to Thomas J. Burke, Chief Financial Officer.

#### Identify other staffing that may be necessary for planning.

The Consortium has identified several functions that are needed to fully complete the scope of work anticipated under this planning grant. These functions and expertise include: project coordination at the consortium level, staff support at the region and sub-region level, educational consultants to determine adult education need; researchers or consultants to conduct labor market data analysis at the aggregate region, sub-region and city level; educational segment and inter-segmental expertise; authoring the sub-regional comprehensive plans and compiling the aggregate region-level comprehensive plan. These functions may be addressed through a mixture of both local talent or may contracted out to researchers or consultant(s), as the Consortium members deem most appropriate and fiscally prudent. The number of staff necessary to carry out these functions has yet to be determined by the Consortium.

#### Communication

## Explain how the planning process will be communicated to districts, adult education providers, and other organizations in the region.

The Consortium will communicate with members, partners, and non-member stakeholders within the Consortium area through an email list serve, an online public / private group site that will function as a shared web portal (analogous to Microsoft office sharepoint, google docs, or dropbox) accessible to varying degrees by stakeholders, partners and members. Among the functions of this online web site will be the ability of non-member stakeholders and business partners to access public information about the work of the Consortium. The members-only portion of the online web site will support the compilation, writing and editing of the regional comprehensive plan, submission of accounting invoices and requests for reimbursement, among other necessary functions.

#### Describe strategies that might be used for outreach to regional stakeholders.

Project members will actively solicit non-member stakeholders in their area to be informed, provide input when appropriate regarding the work of the Consortium. The members and Co-Chairs will disseminate information widely throughout the Consortium service area to ensure that stakeholders are fully informed and have the opportunity to contribute to the work of the Consortium. A variety of appropriate communication strategies will be utilized including but not limited to media releases; social media (Facebook, website(s) and Twitter); face-to-face meetings such as community forums and town hall meetings; print ads, flyers, newsletters or advertisements; community surveys, business surveys and other innovative approaches to reach stakeholders.

### **AB86 Adult Education Consortium Planning**

#### A. INTRODUCTION

California has the opportunity to rethink and redesign an educational system to establish linkages for students across the California Department of Education and the California Community College Chancellor's Office adult education systems that provide adults with the academic and career skills needed to enhance student success. To that end, the Legislature and Governor have put in place two unprecedented indicators of California's commitment to improve adult education.

First, the Legislature has committed funds to AB86 regional consortia of K-12 and community college districts to collaborate regionally to develop plans for expanding and improving adult education services by creating linkages between the two educational systems. Regional collaboration provides capacity for the K-12 and community college adult education programs to find common ground and cross historical geographic and cultural boundaries to provide seamless transitions for students. There currently exists in some areas a rich history of collaboration and a range of partners in place that have a regional perspective on policies and programs. Regional collaboration will manifest itself differently in each consortium and may involve a few or many partners.

Second, as funding for education in California rebounds from the years of fiscal crisis, local K-12 districts also are adjusting to changes in how funding flows from the state through the restructured Local Control Funding Formula (LCFF). For adult education, the LCFF legislation imposes a maintenance-of-effort requirement on adult education, which reads;

"For the 2013–14 and 2014–15 fiscal years only, of the funds a school district receives for purposes of regional occupational centers or programs, or adult education, the school district shall expend no less than the amount of funds the school district expended for purposes of regional occupational centers or programs, or adult education, respectively, in the 2012–13 fiscal year."

#### B. AB86 OVERVIEW

This Certification of Eligibility document contains general instructions, procedures, formats, timelines, and reporting requirements for the AB86 Planning Grant. This is a noncompetitive grant for regional consortia made up of K-12 school districts and community college districts within the 72 community college district boundaries to develop plans to better serve the educational needs of adults.

According to Assembly Bill 86 (AB86) Section 76 Article 3, the Chancellor of the California Community Colleges and the State Department of Education shall, pursuant to funding made available in the annual Budget Act, jointly provide planning and implementation grants to regional consortia of community college districts and school districts for the purpose of developing regional plans to better serve the educational needs of adults.

AB86 provides the opportunity for developing the statewide collaboration and regional approach needed to maximize the state's return on its investment in adult education. It provides focused priorities and a new regional design for the California Department of Education and the California Community College Chancellor's Office adult education programs based on the state's critical educational and workforce needs.

To respond to AB86, Section 76, Article 3, the California Community College Chancellor's Office and the California Department of Education jointly established an AB86 Cabinet of six members, three from each agency. The Cabinet, in turn, established and oversees a Work Group comprised of twelve members, four representing adult education programs in school districts, four representing adult education programs in community colleges, and four staff members, two from the CCCCO and two from the CDE.

#### **Program Areas**

AB86, Section 76, Article 3 provides the one-time funding for adult education consortia planning. The total budget for regional consortia planning awards is \$22.5 million. This grant provides planning and implementation funds to regional consortia to improve the delivery of adult education in the following program areas and address existing gaps in programs and services (note: all areas must be addressed by each consortium):

- 1) Elementary and secondary basic skills, including classes required for a high school diploma or high school equivalency certificate.
- 2) Classes and courses for immigrants eligible for educational services in citizenship and English as a second language, and workforce preparation classes in basic skills.
- 3) Education programs for adults with disabilities.
- 4) Short-term career technical education programs with high employment potential.
- 5) Programs for apprentices.

#### **Objectives**

AB86 outlines expectations and as well as planning and implementation requirements to establish the regional consortia for the provision of adult education in all areas of the state. AB86 provides funding to support these collaborative efforts. These grant funds shall assist adult education consortia to accomplish each of the following objectives:

- An evaluation of current levels and types of adult education programs within its region, including education for adults in correctional facilities; credit, noncredit, and enhanced noncredit adult education coursework; and programs funded through Title II of the federal Workforce Investment Act, known as the Adult Education and Family Literacy Act (Public Law 05-220).
- 2) An evaluation of current needs for adult education programs within its region.
- Plans for parties that make up the consortium to integrate their existing programs and create seamless transitions into postsecondary education or the workforce.
- 4) Plans to address the gaps identified pursuant to paragraphs (1) and (2).
- 5) Plans to employ approaches proven to accelerate a student's progress toward his or her academic or career goals, such as contextualized basic skills and career technical education, and other joint programming strategies between adult education and career technical education.

- 6) Plans to collaborate in the provision of ongoing professional development opportunities for faculty and other staff to help them achieve greater program integration and improve student outcomes.
- 7) Plans to leverage existing regional structures, including, but not necessarily limited to, local workforce investment areas.

All of the objectives will be addressed in the Regional Comprehensive Plan developed and submitted by each consortium.

#### **Reports to the Legislature**

As required by the legislation, two reports – compiled by the AB86 Work Group – will be submitted to the legislature:

- By March 1, 2014, a status report will be presented to the legislature and Governor which identifies regional consortia members in all parts of the state and summarizes the distribution of the planning funds.
- By March 1, 2015, a second report will be presented to the legislature and Governor which includes the regional consortia plans and the conclusions drawn from those plans.

The legislature will expect the second report to identify what is needed to expand and improve the provision of adult education throughout the state. The second report will include suggestions on consortia structures including leadership and decision making processes, future delivery models, and expanding the critical linkages between the K-12 and Community College systems that enable student progress and completion. The report, resulting from the consortia's planning processes, offers a unique opportunity to document the need for additional funding. A close review of what has been presented from each region will be the basis for this summative report, as this work will inform policy and determine funding for additional improvement in the state's delivery system serving adult learners.

#### C. ELIGIBILITY

#### Definitions

For the purpose of AB86 planning awards, the following definitions apply:

- A **region** is defined as the geographical boundaries of a community college district.
- A **consortium** is at least one community college district and at least one school district within the geographical boundaries of the community college district.

- A **member** is defined as public school district or community college district within the geographical boundaries of the designated region.
- A partner is determined by the local consortium's membership.

#### Criteria

- (1) Eligibility to receive AB86 planning awards shall be limited to consortia consisting of at least one community college district and at least one school district within the geographical boundaries of the community college district. Reference the community college district map at http://cccgis.org/CCCDistrictBoundaries/tabid/626/Default.aspx
- (2) Consortia need to demonstrate and implement systems of shared-leadership between K-12 and community college members in the consortia.
- (3) Only a school district or a community college district may serve as the consortium's fiscal agent, as determined by the consortium. The fiscal agent does not determine the leadership structure of the consortium.
- (4) If a community college district chooses not to participate in a consortium, a neighboring community college district may form a consortium with school districts within the boundaries of the nonparticipating community college district. Funds designated for the nonparticipating community college district region will be awarded to the neighboring community college district region and must be used for developing a plan for the region defined by the nonparticipating community college district boundaries.
- (5) Districts may be members of only one consortium. Although school districts and community college districts may be members of only one consortium, they may be partners or participate in multiple consortia.
  - For example: If a school district crosses two or more community college district geographic boundaries, the school district must choose to be a member of only one consortium. However, the school district may be a *partner* with other consortiums.
- (6) Consortia members will determine who may be a partner within the consortia. Consortia partners may include entities providing adult education courses, including, but not necessarily limited to, correctional facilities, local workforce investment boards, other local public entities, community-based organizations, and/or social service organizations.
- (7) A consortium may be made up of more than one region if members agree to merge into a single consortium. In this case, the allocation for those regions will be combined and issued to the fiscal agent of that consortium.
- (8) If an applicant consortium does not meet the established eligibility criteria, a revised response will be required prior to awarding the funding. The CCCCO and the CDE reserve the right to deny funding to consortia found not to meet the required criteria.

## D. FUNDING FORMULA

The Table of Regional Awards in Appendix A shows the regional breakout for consortium awards for the AB86 regional adult education program planning.

#### **E. PERFORMANCE PERIOD**

The performance period for the funded Adult Education Regional Consortia is from March 5, 2014 through June 30, 2015. All performance under this allocation shall be completed by June 30, 2015.

## F. REQUIRED APPLICATION CONTENT

#### 1. Certificate of Eligibility Cover Sheet – Due by Friday, January 31, 2014

The Chief Executive Officer/Superintendent/Designee of the fiscal agent (community college district or school district) will submit a Certificate of Eligibility Cover Sheet with signatures within the electronic submission identifying the school district or community college district that will be the fiscal agent for the consortium, if funded. See Appendix B: Application Forms and Templates for the Eligibility Cover Letter template (B.1). The Certificate of Eligibility Cover Sheet will contain:

- Fiscal Agent's name, address, and contact information
- Brief description of the process used to determine the fiscal agent
- Primary contact information for this application (name, title, phone, and email)
- List of participating members

#### 2. Intent-to-Participate Member Signature Forms – <u>Due by Monday, February</u> <u>24, 2014</u>

Each community college district and school district participating in the consortium must submit an Intent-to-Participate Member Signature Form. The form must be signed by each district's Chief Executive Officer, Superintendent, or Designee. It is understood that the makeup of the consortium may change within the performance period. Please submit Intent-to-Participate Forms from those member districts that are currently committed to participating in the planning project. See Appendix B: Application Forms and Templates for the Intent-to-Participate Member Signature Forms (B.2). Consortia must be comprised of at least one community college district and one school district. The Intent-to-Participate Member Signature Form is located in the attachment to the Certification of Eligibility.

#### 3. Project Management Plan – Due by Monday, February 24, 2014

Shared project management is essential to ensuring that effective collaboration exists among all partners, that planning objectives will be met, and that project deliverables will be completed within the timeline defined in this Certification of Eligibility document. The AB86 Work Group recognizes that adult education consortia are at the early stages of this planning process. Given the consortium's planning stage, please address the elements listed below.

**Project Management Narrative** (not to exceed eight pages, single spaced, 1" margins, 12 pt. Arial font). Responses to the following bullets should reflect **shared leadership** between both systems.

#### **Organizational Structure**

- **Consortia Membership:** Describe existing collaborative relationships, between the community college district and school districts related to adult education. Identify how these relationships may inform the planning process going forward.
- **Partnerships:** List any identified partners and describe how these relationships may inform the planning process going forward.

#### Shared Leadership Strategies

• Describe the shared leadership strategies that may be used during the planning project. Examples may include meetings, MOUs, co-chairs, decision-making processes (including resource allocation), advisory groups, and consortia member and partner agreements.

#### **Project Planning Roles and Responsibilities**

- Identify the co-chairs, project directors, and/or the person(s) responsible for oversight of the project, and describe the roles and responsibilities that they will assume, including the timely submission of required reports.
- Identify other staffing that may be necessary for planning.

#### Communication

- Explain how the planning process will be communicated to districts, adult education providers, and other organizations in the region.
- Describe strategies that might be used for outreach to regional stakeholders.

#### 4. Preliminary Budget Summary – Due by Monday, February 24, 2014

The Preliminary Budget Summary template is found in Appendix B, B.4. The form is located in the attachment to the Certification of Eligibility. It is understood that this budget reflects expenditures for planning and may need to be revised during the performance period of the grant.

The Preliminary Budget Summary form must be signed by the fiscal agent district's Chief Business Officer or authorized designee.

Additionally, 4 signed copies must be mailed to the California Community College Chancellor' Office, postmarked by February 24, 2014

- Quarterly Expenditure Report

#### 3) October 31, 2014: Regional Comprehensive Plan Completed-To-Date

Each consortium must provide the AB86 Work Group with their plan to-date by October 31, 2014. This plan-to-date shall include the following listed below.

- Objectives 1 through 7 from the Regional Consortium Plan template as described in Appendix C:
- Quarterly Expenditure report.

#### 4) December 31, 2014: Draft Regional Comprehensive Plan

Each consortium must provide the AB86 Work Group with a draft Regional Comprehensive Plan on or before December 31, 2014. The draft Regional Comprehensive Plan must address all seven objectives in the Regional Comprehensive Plan template in Appendix C.

#### 5) January 31, 2015: Quarterly Expenditure Report

#### 6) March 1, 2015: Final Regional Comprehensive Plan

Each consortium must provide the AB86 Work Group with a final Regional Comprehensive Plan on or before March 1, 2015. The final Regional Comprehensive Plan must address all Objectives in the Regional Comprehensive Plan template in Appendix C.

#### 7) April 30, 2015: Quarterly Expenditure Report

#### 8) August 31, 2015: Final Expenditure Report

In addition to the planning documents described in Appendix C, additional information regarding the consortia's planning efforts may be requested by the AB86 Work Group for use in the March 2014 and March 2015 reports to the legislature and governor. In addition to these two formal report dates, input from the regional consortia and AB86 Work Group may also be shared with state policy makers throughout the performance period of the planning grants.

Reports and plans should describe and document how adult education might be expanded and improved in a region. Commentary should be provided from the consortium members and partners regarding the structural, fiscal and policy changes needed to better serve the educational needs of adults.

<u>Regional Comprehensive Plan Objective #5</u>: Plans to employ approaches proven to accelerate a student's progress toward his or her academic or career goals, such as contextualized basic skills and career technical education, and other joint programming strategies between adult education and career technical education.

Research has emerged in recent years identifying practices that reduce the time it takes for adult learners to progress through basic skills and career education pathways. Common strategies include compressing courses into shorter, more intensive terms (accelerated), individualized instruction based on a student's competencies (competency-based), and putting basic skills content into the context of a student's goals and career path (contextualized).

Many examples of these "best practices" are already in place within and among California adult education and community college programs. These "best practices" are not new to faculty; in fact, they have been developed *by* faculty. AB86 expects that the work done by regional consortia will include plans to make use of these strategies within their basic skills and career programs and in joint programming strategies.

In many places in the country, Integrated Basic Skills Training (IBEST) models, which contextualize the development of basic skills with the acquisition of workforce competency, have produced impressive data showing how learning can be accelerated while joining skills development with career readiness certifications. The AB86 website will continue to build links and resources tied to best practices and research done through adult education and community colleges.

# <u>Regional Comprehensive Plan Objective #6</u>: Plans to collaborate in the provision of ongoing professional development opportunities for faculty and other staff to help them achieve greater program integration and improve student outcomes.

A critical element to ensuring the effective implementation of the consortium's plans to improve adult education programs are faculty and staff equipped with the skills, knowledge, and support needed to deliver high-quality instruction and use classroom support strategies that foster learner persistence and goal achievement. Significant and effective professional development will be required to build capacity within the existing systems to deliver this new vision for adult learning throughout the state. Faculty and staff from all local consortium members and partners will need to implement collaborative professional development strategies to foster alignment and to support ongoing assessment and improvement of student outcomes.

Collaborative professional development plans should identify topic areas the consortium considers a priority, such as:

- Practices in basic and secondary skills that build the "college readiness" skills.
- Team building, critical thinking, problem solving, study skills, soft skills, and career assessment.
- Technology use and integration to enhance and expand technology in Instruction.
- New models and instructional strategies for contextualized and/or accelerated teaching and learning.
- Skills building intercultural competence among faculty, staff, and administrators.

Examples of collaborative activities might include developing professional learning communities comprising faculty in the same content area, representing all consortium participants. #### APPENDIX D: Grant Agreement Article I Program-Specific Legal Terms and Conditions

(Effective December 16, 2013) Chancellor's Office,

#### California Community Colleges

## AB86, Section 76, Article 3: Adult Education Consortia Planning

#### 1. Cost and Payments

In consideration of satisfactory performance of the services described in the Grantee's application, the California Community Colleges, Chancellor's Office (hereinafter Chancellor's Office) agrees to pay the Grantee a total amount not to exceed the "Grant Funds" amount stated on the fully executed Grant Agreement face sheet, which shall be used as set forth in the Application Budget. Payment shall be made as follows:

An advance payment of 50% of the total amount of first year budgeting of this Grant Agreement will be paid as soon as feasible after the Grant Agreement is fully executed.

Grantee may submit request for progress payments at the time that year-todate quarterly and expenditures reports are submitted pursuant to section 4 of this Article. Payment will be made after review and approval of the quarterly reports by the Chancellor's Office. Progress payment(s) can only be made up to 90% of the total grant amount as the last 10% is withheld pending satisfactory performance and submittal of final performance and expenditure reports.

A final payment will be calculated based on the Final Performance and Expenditure Reports due by August 31, 2015. If the total expenditure of funds by that date is less than the advance payment, the Chancellor's Office may invoice the Grantee for the excess amount. If the final report is late and/or cannot be approved by August 31, 2015 the allocation recipient can lose up to 10% of their funding.

#### 2. Budget Changes

Grant recipient(s) may make changes to any budget category amounts without the approval of the Project Monitor so long as budget categories are not added or deleted, the total dollar amount of the Grant Agreement is not affected, the outcomes of the Grant Agreement will not be materially affected, and it is an allowable expenditure. Adding or deleting budget categories is subject to the prior approval of the Project Monitor. Once the requested change is approved, the affected quarterly budget will be updated electronically.

Grant amendments are required for budget changes when there are changes in the total dollar amount of the Grant Agreement and/or the outcomes of the Grant Agreement is materially affected.

## 3. Application Amendment Requests

If circumstances occur during the performance period that would materially affect outcomes(s) of the approved Certification of Eligibility, the grant recipient is required to contact the Project Monitor for further instructions.

## 4. Reporting

The Recipient shall prepare and submit to the Division of Workforce and Economic Development four quarterly "Year-to-Date Expenditure and Progress Reports" and a final claim of expenditures. These reports are due on or before the following dates:

# Year One

1<sup>st</sup> Quarter – July 31, 2014

2<sup>nd</sup> Quarter – October 31, 2014

3<sup>rd</sup> Quarter – January 31, 2014

4<sup>th</sup> Quarter – April 30, 2015

Final Report – August 31, 2015

- **NOTE**: If the above reporting dates fall on a weekend or a holiday the report shall be due by close of business on the last working day **prior to the reporting deadline**. Extensions of reporting deadlines require written approval of the Project Monitor.
- **5**. The Chancellor's Office reserves the right to evaluate a grantees performance as follows:
  - Reasonable and timely progress meeting the objectives of the grant; and
  - Submission of a final plan.

## 6. Allowable Expenditures

**Indirect Costs:** The indirect administrative costs (overhead) for this project cannot exceed four percent (4%) of the total grant (line X of the application budget summary). The application budget detail sheet and application budget summary

within the Excel workbook (Appendix Y) will show an error message if more than 4% of line 8 is requested.

**Travel:** Only travel necessary for the project is allowed. Travel costs are the expenses for transportation, lodging, subsistence, and related items incurred by employees who are in travel status on official business for the grant. Such costs (via Legal Article II attached to the application) will be based the fiscal agent's perdiem rates. These costs shall be considered reasonable and allowable only to the extent such costs do not exceed charges normally allowed by the institution in its regular operations as the result of the institution's written travel policy.

**Out-of-State Travel:** Out-of-State travel requires prior approval. The state reserves the right to limit Out-of-State travel.

**Out-of-Country Travel:** Out-of-Country travel will not be an allowed via this funding source.

**Equipment:** The purchase of equipment is not allowed via this funding source.

7. All items referenced Article I and Article II, the Grant Agreement Terms and Conditions apply to the California Community Colleges Chancellor's Office and to the California Department of Education.

## APPENDIX E: Grant Agreement Article II Standard Legal Terms and Conditions

(Revision November 19, 2012)

#### 1. Work to be Performed

The Grantee shall complete the tasks described in the Grantee's application and funds shall be expended in compliance with the requirements for the funding source and category referenced in the Grant Agreement face sheet.

Grantee may request modifications to the work to be performed. All such requests must be submitted in writing to the Project Monitor prior to the modification being made. The Project Monitor may require that a Grant Amendment be processed, if the monitor determines that the change would materially affect the project outcomes or the term of this Grant Agreement.

Modifications or amendments to the Work to be Performed provisions of this Agreement involving an extension of time are subject to applicable program limitations. For grants funded under the Carl D. Perkins Career and Technical Education Improvement Act of 2006, extensions of time are not allowed beyond June 30th of the year in which the funds were awarded. For other programs, no modification or amendment may permit expenditures to be made after June 30th of the second year following the period for which the funds were appropriated. Any modification or amendment permitting funds to be spent beyond the year of appropriation shall ensure that Grantee does not receive funding for the same expense from more than one fiscal year.

## 2. Amendments

An amendment of this Grant Agreement is required when the Grantee wishes to extend the completion date or materially change the work to be performed or the budget (see Article I section 2 and Article II section 1). The request must be made on the appropriate form provided by the Chancellor's Office and must be submitted to the Project Monitor prior to making the desired alteration in the performance or expenditures under the Grant Agreement. Requests for amendments should be received 60 days before the end of the performance period.

Amendments involving an extension of time are subject to applicable program limitations. For grants funded under the Carl D. Perkins Career and Technical Education Improvement Act of 2006, extensions of time are not allowed beyond June 30th of the year in which the funds were awarded. For other programs, no amendment may permit expenditures to be made after June 30th of the second year following the period for which the funds were appropriated. Any amendment permitting funds to be spent beyond the year of appropriation shall

ensure that Grantee does not receive funding for the same expense from more than one fiscal year.

#### 3. Unenforceable Provision

In the event that any provision of this Grant Agreement is unenforceable or held to be unenforceable, then the parties agree that all other provisions of this Grant Agreement remain in full force and effect and shall not be affected thereby.

#### 4. Dispute

In the event of a dispute, Grantee agrees to file a "Notice of Dispute" with the Chancellor's Office, within ten (10) days of discovery of the problem. Within ten (10) days, the Chancellor or his or her designee shall meet with the Grantee, the Vice Chancellor for the division awarding the Grant Agreement, and the Project Monitor for purposes of resolving the dispute. The decision of the Chancellor shall be final.

In the event of a dispute, the language contained within this Grant Agreement shall prevail over any other language including that of the grant proposal.

Grantee shall continue with the responsibilities under this Grant Agreement during any dispute.

#### 5. Notice

Either party may give notice to the other party by sending certified mail properly addressed, postage fully prepaid to the other party's business address. Notices to be sent to the Chancellor's Office shall be addressed to the Project Monitor at California Community Colleges, Chancellor's Office, 1102 Q Street, Suite 4554, Sacramento, CA 95811-6539. Notices to be sent to the Grantee shall be addressed to the Project Director at the Grantee's address as specified on the face sheet of this Grant Agreement. Such notice shall be effective when received, as indicated by post office records, or if deemed undeliverable by the post office, such notice shall be postponed 24 hours for each such intervening day.

#### 6. Interpretation

In the interpretation of this Grant Agreement, any inconsistencies between the terms hereof and the Exhibits shall be resolved in favor of the terms hereof.

## 7. **Project Director and Key Personnel**

The Project Director is designated by the Grantee on the face sheet of the Grant Agreement, and the key personnel are identified in the application or proposal. The Grantee may change the Project Director or other key personnel, but the Grantee shall immediately notify the Project Monitor in writing of any such changes.

# 8. **Project Monitor**

The Project Monitor is designated by the Chancellor's Office on the face sheet of the Grant Agreement. The Project Monitor is responsible for overseeing the project and any questions or problems relating to the project should be directed to the Project Monitor. If necessary, the Chancellor's Office may change the Project Monitor by written notice sent to the Grantee.

## 9. Budget Concerns

- a. It is mutually understood between the parties that this Grant Agreement may have been written before ascertaining the availability of state or federal funds, for the mutual benefit of both parties in order to avoid program and fiscal delays which would occur if this Grant Agreement were executed after the determination was made.
- b. It is mutually agreed that if the state or federal budget for the current year and/or any subsequent years covered under this Grant Agreement does not appropriate sufficient funds for the program, this Grant Agreement shall have no force and effect. In this event, the Chancellor's Office shall have no liability to pay any funds whatsoever to Grantee or to furnish any consideration under this Grant Agreement and Grantee shall not be obligated to perform any provisions of this Grant Agreement.
- c. Grantee shall inform any subcontractors and subgrantees that any work performed prior to approval of the state or federal budget, as applicable, will be rendered on a voluntary basis, and shall not be compensated unless and until funding is authorized.
- d. In no event may Grantee use Grant funds to pay any individual or organization for the work associated with preparing the Grant application. For breach or violation of this prohibition, the Chancellor's Office shall, in addition to other remedies provided by law, have the right to annul this Grant Agreement without liability, paying only for the value of the work actually performed, or otherwise recover the full amount of such commission, percentage, brokerage, or contingent fee.
- e. In addition, this Grant Agreement is subject to any additional restrictions, funding reductions, limitations or conditions enacted in the state or federal budget, any amendments thereto, or in the laws and Executive Orders that may affect the provisions, term, or funding of this Grant Agreement in any manner. The parties hereby agree that the Chancellor's Office will notify Grantee of any such changes affecting the terms of this Grant Agreement, but need not execute an amendment to modify the Grant Agreement.

## 10. Assignment

Grantee may not transfer by assignment or novation the performance of this Grant Agreement or any part thereof except with the prior written approval of the Project Monitor. Nor may Grantee, without the prior written consent of the Project Monitor, assign any other right that Grantee may have under this Grant Agreement. Each assignment that is approved by the Project Monitor shall contain a provision prohibiting further assignments to any third or subsequent tier assignee without additional written approval by the Project Monitor. The Project Monitor's consent to one or more such assignments or novations shall not constitute a waiver or diminution of the absolute power to approve each and every subsequent assignment or novation.

## 11. Subcontracts or Subgrants

- a. Grantee agrees to obtain the written approval of the Project Monitor prior to the selection of subcontractors or subgrantees to perform services under this Grant Agreement, based upon a written request indicating compliance with the provisions set forth below. Except where prohibited by the Standards of Conduct provisions set forth in section 15 of this Article, subcontractors or subgrantees specifically identified in this Grant Agreement or the Exhibits attached hereto and which are secured in accordance with applicable legal requirements and the provisions set forth below are deemed approved upon execution of this Grant Agreement.
- b. In any event, if the Grantee wishes to enter into a subcontract or subgrant agreement for performance of any part of the activities under this Grant Agreement, Grantee shall disclose the intended purpose and amount of the subcontracting, identify the proposed subcontractor or subgrantee, and certify that the subcontractor or subgrantee was selected according to locally applicable competitive bidding processes which are reasonably calculated to ensure that cost shall be given substantial weight in the selection process, and that the selected subcontractor or subgrantee is the best qualified party available to provide the required services. Upon request, Grantee shall furnish evidence of compliance with this provision to the Project Monitor. Grantee shall immediately notify the Project Monitor in the event that any subcontract or subgrant is terminated.
- c. All subcontracts or subgrants shall contain a provision prohibiting any third or subsequent tier subcontracts or subgrants without additional written approval by the Project Monitor.
- d. The Project Monitor's consent to one or more subcontracts or subgrants shall not constitute a waiver or diminution of the absolute power to approve each and every subsequent subcontract or subgrant.
- e. Upon request, Grantee shall furnish any additional evidence the Project Monitor may deem appropriate concerning the competitive bidding

procedures used or any other matter related to compliance with paragraphs (a) or (b).

- f. Grantee shall not enter into any subgrant or subcontract of the types described below and any such agreement which may be executed is null and void and of no force or effect.
  - 1. A former state employee (including a Chancellor's Office employee, or a district employee who worked for the Chancellor's Office on an Interjurisdictional Exchange (IJE)) cannot enter into a subcontract or subgrant under this Grant Agreement with the Grantee if that employee was engaged in the negotiations, transactions, planning, arrangements or any part of the decisionmaking process relevant to this Grant Agreement while employed by the state. (Gov. Code,

§§ 1090, et seq., 87100, and 87400 et seq.; Cal.Code Regs. tit. 5,

§§ 18741.1 and 18747.)

- 2. A current state employee (including a current Chancellor's Office employee or district employee working for the Chancellor's Office on an Interjurisdictional Exchange (IJE)) cannot enter into a subcontract or subgrant with the Grantee, with the exception of rank-and-file employees of the California State University and the University of California. (Pub. Contr. Code, § 10410.)
- 3. The spouse or a member of the immediate family of a current Chancellor's Office employee (including a current Chancellor's Office employee or district employee working for the Chancellor's Office on an Interjurisdictional Exchange (IJE)) may not enter into a subcontract or subgrant with the Grantee if the Chancellor's Office employee or person on an IJE was engaged in the negotiations, transactions, planning, arrangements or any part of the decision- making process relevant to this Grant Agreement, or the subcontract or subgrant, or had any influence whatsoever in the making of this Grant Agreement, or the subcontract or subgrant. (Gov. Code, §§ 1090, et seq.; and 87100.)
- g. Nothing contained in this Grant Agreement or otherwise, shall create any contractual relationship between the Chancellor's Office and any subcontractors or subgrantees, and no subcontract or subgrant shall relieve Grantee of its responsibilities and obligations hereunder. Grantee agrees to be as fully responsible to the Chancellor's Office for the acts and omissions of its subcontractors, subgrantees, and of persons either directly or indirectly employed by them, as it is for the acts and omissions of persons directly employed by Grantee. Grantee's obligation to pay its subcontractors and subgrantees is independent from the obligation of the

Chancellor's Office to make payments to Grantee. As a result, the Chancellor's Office shall have no obligation to pay or enforce the payment of any moneys to any subcontractor.

## 12. Audit

Grantee agrees that the Chancellor's Office, the Bureau of State Audits, any other appropriate state or federal oversight agency, or their designated representative(s), shall have the right to review and to copy any records and supporting documentation pertaining to the performance of this Grant Agreement. Grantee agrees to maintain such records for possible audit for a minimum of three (3) years after final payment or until any audit findings have been resolved, unless a longer period of records retention is stipulated. Grantee agrees to allow the auditor(s) access to such records during normal business hours and to allow interviews of any employees who might reasonably have information related to such records. Further, Grantee agrees to include a similar right of the Chancellor's Office, the Bureau of State Audits, any other appropriate state or federal oversight agency, or their designated representative(s) to audit records and interview staff in any subcontract or subgrant related to performance of this Grant Agreement.

## 13. **Products and Deliverables**

- a. Each deliverable to be provided under this Grant Agreement shall be submitted to and approved by the Project Monitor. All products, documents and published materials, including multimedia presentations, shall be approved by the Project Monitor prior to distribution.
- b. Any document or written report prepared, in whole or in part by Grantee, or its subcontractors or subgrantees, shall contain the Grant number and dollar amount of the Grant and subcontracts or subgrants relating to the preparation of such document or written report. The Grant and subcontract or subgrant numbers and dollar amounts shall be contained in a separate section of such document or written report. (Gov. Code, §

## 7550(a).

- c. When multiple documents or written reports are the subject or product of the Grant Agreement, the disclosure section must also contain a statement indicating that the total Grant amount represents compensation for multiple documents or written reports. (Gov. Code, § 7550(b).)
- d. All products resulting from this Grant Agreement or its subcontracts in whole or in part shall reference the California Community Colleges, Chancellor's Office and the specific funding source.
- e. All references to the project shall include the phrase, "funded in part by the California Community Colleges, Chancellor's Office."

## 14. Travel

For travel necessary to the performance of this Grant Agreement, Grantee travel and other expense reimbursement claims shall be governed by the travel policy and procedures adopted by the Grantee's governing board. Travel and other expenses shall be limited to those necessary for the performance of this Grant Agreement. For grants involving federal funds, any out-of-state travel must be approved in advance by the Project Monitor.

Grant funds may be used to pay for travel for Chancellor's Office staff provided that the travel is related to the purposes of the Grant Agreement, the travel is necessary to allow Chancellor's Office staff to provide services or technical assistance beyond the scope of normal Grant monitoring, the request is made by the Grantee without duress from Chancellor's Office staff, Grantee does not seek or receive any favorable treatment in exchange for paying for travel, travel is arranged and paid for through ordinary Chancellor's Office processes, and the Grant funds are used to reimburse those costs using Accounting Form RT-01 Request for Services/Agreement to Pay Travel Expenses

#### **15.** Standards of Conduct

Grantee hereby assures that, in administering this Grant Agreement, it will comply with the standards of conduct hereinafter set out, as well as the applicable state laws concerning conflicts of interests, in order to maintain the integrity of this Grant Agreement and to avoid any potential conflict of interests in its administration.

- a. Every reasonable course of action will be taken by the Grantee in order to maintain the integrity of this expenditure of public funds and to avoid any favoritism or questionable or improper conduct. The Grant Agreement will be administered in an impartial manner, free from personal, financial, or political gain. The Grantee, and its officers and employees, in administering the Grant Agreement, will avoid situations which give rise to a suggestion that any decision was influenced by prejudice, bias, special interest, or personal gain.
- b. Conducting Business with Relatives. No relative by blood, adoption, or marriage of any officer or employee of the Grantee, or of any member of its governing board, will receive favorable treatment in the award of subcontracts or subgrants or in educational or employment opportunities funded by this Grant Agreement.
- c. Conducting Business Involving Close Personal Friends and Associates.

In administering the Grant Agreement, officers and employees of the Grantee will exercise due diligence to avoid situations which may give rise to an assertion that favorable treatment is being granted to friends and associates.

- d. Avoidance of Conflicts of Economic Interests.
  - 1. Grantee shall take all reasonable steps to ensure that its officers and employees, and members of its governing board, will avoid any actual or potential conflicts of interests, and that no officer, employee, or board member who exercises any functions or responsibilities in connection with this Grant Agreement shall have any personal financial interest or benefit which either directly or indirectly arises from this Grant Agreement. The term "financial interest" shall include the financial interest of the officer, employee, or board member's spouse or dependent child.
  - 2. Grantee shall establish safeguards to prohibit officers, employees or board members from using their positions for a purpose which could result in private gain, or give the appearance of being motivated for private gain for themselves or others, particularly those with whom they have family, business, or other ties.
  - 3. An officer or employee of Grantee, an elected official in the area, or a member of the governing board, may not solicit or accept money or any other consideration from a third person for the performance of any act reimbursed, in whole or in part, by Grantee or the Chancellor's Office. Supplies, materials, equipment, or services purchased with Grant funds will be used solely for purposes allowed under this Grant Agreement.
  - 4. The governing board may not authorize the award of any subcontract or subgrant funded by this Grant Agreement, if that contract, subcontract or subgrant is for the provision of services or goods by any board member, or by any person or entity which is a source of income to a board member.
- e. In the interest of avoiding conflicts of interests involving friends or associates of Chancellor's Office employees, in administering this Grant Agreement, officers and employees of the Grantee will exercise due diligence to avoid situations which may give rise to an assertion that favorable treatment is being granted to friends and associates of Chancellor's Office employees.

## 16. Statewide or Regional Projects

If this Grant involves provision of coordination, technical assistance, or other services for the California Community College system or for a particular region or group of colleges, the following requirements shall apply:

a. Grantee agrees to consult regularly with the Project Monitor and representatives of the colleges to be served and to give every reasonable consideration to their views in the conduct of the project.

- b. Grantee shall require all employees, consultants, subcontractors and subgrantees to disclose any employment or contractual relationships they may have with other colleges being served under a statewide or regional grant. Such relationships are prohibited and shall be promptly terminated unless, after being fully informed of the circumstances, the Project Monitor determines that the services being provided to the other college by the employee, consultant, or contractor are above and beyond or unrelated to those provided under this Grant.
- c. If the primary role of the Grantee under this agreement is to serve as a fiscal agent for distribution of funds, the Grantee agrees that it will not make any payment to subcontractors engaged to provide consulting services under this grant without the written approval of the Project Monitor and the Executive Vice Chancellor or the person he/she has designated to approve grants pursuant to subdivision (c) of section 3600 of the Chancellor's Office Contracts and Grants Manual. Grantee may, however, disburse funds as provided in the grant budget for other activities (including paying for expenses related to meetings of advisory bodies or travel expenses for site reviews) without prior approval.
- d. If this Grant exceeds \$750,000 and funds a full-time position to perform grant activities, Grantee hereby agrees to engage in full and open recruitment for that position in accord with subsection (a) of section 53021 of title 5 of the California Code of Regulations, with the understanding that such position may be filled on a temporary basis to the extent authorized by law. Grantee shall, in a timely manner, submit to the Personnel Office of the Chancellor's Office a copy of all such job announcements. In the event that an employee of the Chancellor's Office may consider executing an Interjurisdictional Exchange Agreement to permit the employee in question to work for the Grantee.
- e. Consistent with the requirements of section 19 of this Article ("Real Property and Equipment"), the disposition of real property or equipment with an initial purchase price in excess of \$5,000 shall be subject to the approval of the Chancellor's Office.

## 17. Time Is of the Essence

Time is of the essence in this Grant Agreement.

## 18. Intellectual Property

a. Grantee agrees that any and all services rendered and documents or other materials, inventions, processes, machines, manufactures, or compositions of matter, and/or trademarks or servicemarks first created, developed or produced pursuant to the Grant Agreement, whether by Grantee or it subcontractors or subgrantees, shall be and are Work for

Hire. All subcontracts or subgrants shall include a Work for Hire provision by which all materials, procedures, processes, machines, and trademarks or servicemarks produced as a result of the Grant Agreement shall be Work for Hire. All rights, title, and interest in and to the Work first developed under the Grant Agreement or under any subcontract or subgrant shall be assigned and transferred to the Chancellor's Office. This Work for Hire agreement shall survive the expiration or early termination of this Grant Agreement.

b. The copyright for all materials first produced as a result of this Work for Hire agreement shall belong to the Chancellor's Office. Grantee, and all subcontractors, subgrantees, and others that produce copyright materials pursuant to the Grant Agreement, assigns all rights, title and interest, including the copyright to any and all works created pursuant to this Work for Hire agreement, to the Chancellor's Office. The Chancellor's Office shall acknowledge Grantee or its subcontractors and subgrantees, if any, as the author of works produced pursuant to this Work for Hire agreement on all publications of such work. The Chancellor's Office may license Grantee or its subcontractors and subgrantees, if any, to reproduce and disseminate copies of such work, provided the licensee agrees not to permit infringement of the copyright by any person, to compensate Chancellor's Office for any infringement which may occur, and to indemnify and hold harmless the Chancellor's Office for any and all claims arising out of or in connection with the licensing agreement. Said license shall include the right to create and use works derived from those created under this Grant Agreement, even if such derivative works compete with those created under this Grant Agreement.

All materials first developed in draft and in final form pursuant to this Grant Agreement shall, in a prominent place, bear the © (the letter "c" in a circle) or the word "Copyright," or the abbreviation "Copr.", followed by the year created; and the words "California Community Colleges, Chancellor's Office." Acknowledgment may be given to Grantee or the actual author(s) of the work in an appropriate manner elsewhere in the copyright material. If it is deemed necessary by either the Chancellor's Office or the Grantee that the copyright be registered with the U.S. Copyright Office, Grantee will be responsible for applying for, paying the filing fees for, and securing said copyright.

c. All technical communications and records originated or first prepared by the Grantee or its subcontractors and subgrantees, if any, pursuant to this Work for Hire agreement, including papers, reports, charts, computer programs, and technical schematics and diagrams, and other documentation, but not including Grantee's administrative communications and records relating to this Grant Agreement, shall be delivered to and shall become the exclusive property of the Chancellor's Office and may be copyrighted by the Chancellor's Office.

- d. If it is deemed necessary by either the Chancellor's Office or the Grantee that a patent be obtained from the U.S. Patent and Trademark Office for any invention, process, machine, manufacture, or composition of matter, Grantee will be responsible for applying for, paying the filing fees for, and securing said patent. All patents for inventions, processes, machines, manufactures, or compositions of matter developed pursuant to this Grant Agreement shall be issued to the "California Community Colleges, Chancellor's Office." All products and references to patents shall be marked and designated as such as required by law. Acknowledgment may be given to Grantee or the actual inventor(s) in an appropriate manner. The Chancellor's Office agrees to grant a nonexclusive license for such intellectual property to the Grantee. Said license shall include the right to use the patent for inventions, processes, machines, manufactures, or compositions of matter derived from those created under this Grant Agreement.
- e. All trademarks and servicemarks first created, developed or acquired pursuant to this Grant Agreement shall be the property of the Chancellor's Office. If it is deemed necessary by either the Chancellor's Office or the Grantee that a trademark or servicemark be registered with state or federal agencies, Grantee will be responsible for applying for, paying the filing fees for, and securing said protection. All trademarks and servicemarks obtained pursuant to this Grant Agreement shall be issued to the "Chancellor's Office California Community Colleges" and carry the designations permitted or required by law. The Chancellor's Office agrees to grant a nonexclusive license for the use of trademarks or servicemarks created, developed or obtained under this Grant Agreement to the Grantee.
- f. In connection with any license granted pursuant to the preceding paragraphs, Grantee agrees not to permit infringement by any person, to compensate Chancellor's Office for any infringement which may occur, and to indemnify and hold harmless the Chancellor's Office for any and all claims arising out of or in connection with such license. Grantee may, with the permission of the Chancellor's Office, enter into a written sublicensing agreement subject to these same conditions.
- g. Any and all services rendered, materials, inventions, processes, machines, manufactures, or compositions of matter, and trademarks or servicemarks created, developed or produced pursuant to this Grant Agreement by subcontractors or subgrantees that create works for this Grant for Grantee are for and are the property of the Chancellor's Office. Grantee shall obtain an acknowledgement of the work for hire performed by these subcontractors or subgrantees that produce intellectual property pursuant to this Grant Agreement, and all rights, title, and interests in such property shall be assigned to the Chancellor's Office from all subcontractors or subgrantees. Grantee shall incorporate the above applicable paragraphs, modified appropriately, into its agreements with

subcontractors or subgrantees that create works for this Grant. No unpaid volunteer or other person shall produce copyright materials under this Grant Agreement without entering into a subcontract or subgrant between such person(s) and Grantee giving the Chancellor's Office the foregoing rights in exchange for the payment of the sum of at least one dollar (\$1).

## **19.** Real Property and Equipment

Where allowed by the funding source, real property and equipment (as defined in the California Community Colleges Budget and Accounting Manual, page 4.64) procured with Grant funds will be used for the purpose of the Grant in accordance with the following:

- a. Equipment with an initial purchase price in excess of \$5,000 must be appropriately tagged as purchased with funds from the particular funding source and the Grantee shall maintain an inventory of equipment purchased, including a description of the equipment, a serial or other identification number, the acquisition date, the cost of the equipment, the location of the equipment, and any ultimate disposition data. The Grantee will also adhere to all other property management procedures and property accountability requirements as published by the Chancellor's Office.
- b. If the real property or equipment is not needed full time for the purposes of the Grant, it may also be used for other purposes so long as this does not interfere with its use in carrying out the purposes of the Grant throughout the term of this Grant Agreement.
- c. Upon completion or termination of the Grant, or when real property or equipment is no longer useful or necessary for purposes of the Grant, it may be disposed of as follows:
  - 1. Equipment with an initial purchase price less than \$5,000 may be disposed of as the Grantee deems appropriate.
  - 2. If the Grant-funded project involves systemwide or regional coordination or technical assistance activities, the disposition of real property or equipment with an initial purchase price in excess of \$5,000 shall be subject to the approval of the Chancellor's Office.
  - 3. In all other cases, real property or equipment with an initial purchase price in excess of \$5,000 may be sold or used in another program funded by the Chancellor's Office. If the real property or equipment is sold, the proceeds of the sale shall be returned to the program funded by this Grant Agreement, or if that program has been discontinued, to another program funded by the Chancellor's

Office; provided however, that the Grantee may retain \$100 or ten percent of the sale price (whichever is greater) to cover the costs of sale.

d. Equipment purchased with federal funds shall also comply with any additional or more stringent equipment management requirements applicable to the particular federal funding source.

#### 20. Surveys

If this Grant Agreement involves a survey of community college faculty, staff, students, or administrators, Grantee shall ensure that the survey is developed, administered, tabulated, and summarized by a survey evaluator/specialist. Surveys shall conform to project goals, shall minimize the burden on the group being surveyed, and shall not collect data already available to the Grantee from the Chancellor's Office or another source.

## 21. Work by Chancellor's Office Personnel

- a. Chancellor's Office staff will be permitted to work side by side with Grantee's staff to the extent and under conditions that may be directed by the Project Monitor. In this connection, Chancellor's Office staff will be given access to all data, working papers, subcontracts, etc., which Grantee may seek to utilize.
- b. Grantee will not be permitted to utilize Chancellor's Office personnel for the performance of services which are the responsibility of Grantee unless such utilization is previously agreed to in writing by the Project Monitor, and any appropriate adjustment in price is made. No charge will be made to Grantee for the services of Chancellor's Office employees while performing, coordinating or monitoring functions, except where an Interjurisdictional Exchange agreement has been properly executed.

## 22. Termination

a. Termination Option. Either party may at its option terminate this Grant Agreement at any time upon giving thirty (30) days' advance notice in writing to the other party in the manner herein specified. In such event, both parties agree to use all reasonable efforts to mitigate their expenses and obligations hereunder. In such event, the Chancellor's Office shall pay Grantee for all satisfactory services rendered and expenses incurred prior to such termination which could not by reasonable efforts of Grantee have been avoided, but not in excess of the maximum payable under the Grant Agreement as specified on the Grant Agreement Face Sheet. In such event, Grantee agrees to relinquish possession of equipment purchased for this project to the Chancellor's Office or Grantee may, with approval of the Chancellor's Office, purchase or dispose of said equipment as provided in section 19 of this Article ("Real Property and Equipment").

- b. Event of Breach. In the event of any breach of this Grant Agreement, the Chancellor's Office may, without any prejudice to any of its other legal remedies, terminate this Grant Agreement upon five (5) days' written notice to the Grantee. In the event of such termination the Chancellor's Office may select a new grantee to proceed with the work in any manner deemed proper by the Chancellor's Office. The cost to the Chancellor's Office of having the project completed by another grantee shall be deducted from any sum due Grantee under this Grant Agreement, and the balance, if any, shall be paid to Grantee upon demand. Whether or not the Chancellor's Office elects to proceed with the project, the Chancellor's Office shall pay Grantee only the reasonable value of the services theretofore rendered by Grantee as may be agreed upon by the parties or determined by a court of law.
- c. Gratuities. The Chancellor's Office may, by written notice to Grantee, terminate the right of Grantee to proceed under this Grant Agreement if it is found, after notice and hearing by the Chancellor or his or her duly authorized representative, that gratuities were offered or given by Grantee or any agent or representative of Grantee to any officer or employee of the Chancellor's Office with a view toward securing a grant or securing favorable treatment with respect to awarding or amending or making a determination with respect to the performance of such grant.

In the event this Grant Agreement is terminated as provided herein, the Chancellor's Office shall be entitled to (1) pursue the same remedies against Grantee as it could pursue in the event of the breach of the Grant Agreement by the Grantee, and (2) exemplary damages in an amount which shall be not less than three nor more than ten times the cost incurred by Grantee in providing any such gratuities to any such officer or employee, as a penalty in addition to any other damages to which it may be entitled by law.

The rights and remedies provided in this clause shall not be exclusive and are in addition to any other rights and remedies provided by law or under this Grant Agreement.

#### 23. Waiver

No waiver of any breach of this Grant Agreement shall be held to be a waiver of any other or subsequent breach. All remedies afforded in this Grant Agreement shall be taken and construed as cumulative; that is, in addition to every other remedy provided therein or by law. The failure of the Chancellor's Office to enforce at any time any of the provisions of this Grant Agreement, or to require at any time performance by Grantee of any of the provisions thereof, shall in no way be construed to be a waiver of such provisions nor in any way affect the validity of this Grant Agreement or any part thereof or the right of Chancellor's Office to thereafter enforce each and every such provision.

## 24. Workers' Compensation Insurance

Grantee hereby warrants that it carries Workers' Compensation Insurance for all of its employees who will be engaged in the performance of this Grant Agreement, or is self-insured in accordance with the provisions of Labor Code section 3700, and agrees to furnish to the Chancellor's Office satisfactory evidence thereof at any time the Project Monitor may request.

## 25. Law Governing

It is understood and agreed that this Grant Agreement shall be governed by the laws of the State of California both as to interpretation and performance; venue of any action brought with regard to this Grant Agreement shall be in Sacramento County, Sacramento, California.

## 26. Participation in Grant-Funded Activities

- a. During the performance of this Grant Agreement, Grantee and its subcontractors or subgrantees shall ensure that no person is excluded from, denied the benefits of, or otherwise subjected to discrimination with respect to participation in, any program or activity funded under this Grant Agreement on the basis of ethnic group identification, national origin, religion, age, sex, race, color, ancestry, sexual orientation, or physical or mental disability, or on the basis of these perceived characteristics or based on association with a person or group with one or more of these actual or perceived characteristics.
- b. Programs funded by this Grant Agreement should not be designed, administered, or advertised in a manner that discourages participation on any of the bases set forth above. Any informational, advertising, or promotional materials regarding such programs may not include any statements to the effect that a program is for, or designed for students of a particular race, color, national origin, ethnicity or gender. In the event that mentoring or counseling services are provided with funding provided by this Grant Agreement, students may not be paired with mentors or counselors based solely upon the race, color, national origin, ethnicity or gender of the students, mentors, or counselors. The Chancellor's Office may, by written approval of the Chancellor, grant an exception to the requirements of this paragraph where Grantee provides documentation clearly demonstrating that designing a program for a particular group of students is justified under applicable legal standards as a remedy for past discrimination.

# 27. Curriculum Development

If this Grant Agreement involves the development of new college curriculum, the following shall apply:

- a. All courses initiated or substantially modified as a result of activities supported by this Grant Agreement must comply with all applicable provisions of subchapter 1 of chapter 6 of division 6 of title 5 of the California Code of Regulations (commencing with section 55000), including but not limited to, section 55002, which defines standards for degree-applicable credit, non-degree-applicable credit, and noncredit courses. All such courses must be reviewed through the appropriate processes as described in the Program and Course Approval Handbook published by the Chancellor's Office.
- b. All programs (certificates or degrees) initiated or substantially modified as a result of activities supported by this Grant Agreement must be approved at the appropriate level and through the appropriate process as described in subchapter 1 (commencing with section 55000) and subchapter 2 (commencing with section 55100) of chapter 6 of division 6 of title 5 of the California Code of Regulations and the Program and Course Approval Handbook published by the Chancellor's Office.
- c. The fact that the Chancellor's Office has awarded funding through this Grant Agreement to support the development of new curriculum shall not be construed to constitute endorsement or approval of the resulting curriculum or to guarantee or affect the outcome of the curriculum review and approval process.

## 28. Eligibility for Noncitizens

Funds provided under this Grant Agreement shall only be used to employ, contract with, or provide services to citizens of the United States or noncitizens who are eligible to receive public benefits pursuant to section 401 (with respect to federally funded activities) or section 411 (with respect to state funded activities) of the Personal Responsibility and Work Opportunity Reconciliation Act of 1996 (P.L. 104-193, codified at 42 U.S.C. §§ 601 and 611, respectively). Grantee certifies that all of its employees and/or subcontractors or subgrantees are qualified pursuant to these provisions.

## 29. Nondiscrimination Clause

a. During the performance of this Grant Agreement, Grantee and its subcontractors or subgrantees shall not unlawfully discriminate, harass or allow harassment, against any employee or applicant for employment because of ethnic group identification, national origin, religion, creed, age (over 40), sex, race, color, ancestry, sexual orientation, physical disability (including HIV and AIDS), mental disability, medical condition (cancer and genetic characteristics), or on the basis of these perceived characteristics or based on association with a person or group with one or more of these

actual or perceived characteristics, marital status, denial of family care leave, political affiliation, or position in a labor dispute. Grantee and subcontractors or subgrantees shall insure that the evaluation and treatment of their employees and applicants for employment are free from such discrimination and harassment.

- b. Grantee and its subcontractors or subgrantees shall comply with the provisions of the Fair Employment and Housing Act (Gov. Code, §§ 12900 et seq.) and the applicable regulations promulgated thereunder (Cal. Code Regs., tit. 2, §§ 7285 et seq.). The applicable regulations of the Fair Employment and Housing Commission implementing Government Code section 12990 (a-f), set forth in chapter 5 of division 4 of title 2 of the California Code of Regulations are incorporated into this Grant Agreement by reference and made a part hereof as if set forth in full.
- c. Grantee and its subcontractors or subgrantees shall also comply with the provisions of Government Code sections 11135-11139.8, and the regulations promulgated thereunder by the Board of Governors of the California Community Colleges (Cal. Code Regs., tit. 5, §§ 59300 et seq.); provided, however, that if Grantee or any subgrantee or subcontractor is not a community college district the references in the regulations of the Board of Governors to "the district" shall be deemed to refer to the Grantee, subgrantee or subcontractor and references to the "district governing board" shall be deemed to refer to the management or governing body of the Grantee, subgrantee or subcontractor.
- d. Grantee and its subcontractors or subgrantees shall give written notice of their obligations under this clause to labor organizations with which they have a collective bargaining or other agreement.
- e. Grantee shall include the nondiscrimination and compliance provisions of this clause in all subcontract or subgrant agreements to perform work under this Grant Agreement.

## 30. Accessibility for Persons with Disabilities

a. By signing this Grant Agreement, Grantee assures the Chancellor's Office

that it complies with the Americans with Disabilities Act (ADA) of 1990 (42

U.S.C. §§ 12101 et seq.), which prohibits discrimination on the basis of disability, as well as all applicable regulations and guidelines issued pursuant to the ADA.

b. Grantee shall, upon request by any person, make any materials produced with Grant funds available in braille, large print, electronic text, or other

appropriate alternate format. Grantee shall establish policies and procedures to respond to such requests in a timely manner.

- c. All data processing, telecommunications, and/or electronic and information technology (including software, equipment, or other resources) developed, procured, or maintained by Grantee, whether purchased, leased or provided under some other arrangement for use in connection with this Grant Agreement, shall comply with the regulations implementing Section 508 of the Rehabilitation Act of 1973, as amended, set forth at 36 Code of Federal Regulations, part 1194.
- d. Design of computer or web-based materials, including instructional materials, shall conform to guidelines of the Web Access Initiative (see <a href="http://www.w3.org/TR/WAI-WEBCONTENT/">http://www.w3.org/TR/WAI-WEBCONTENT/</a>) or similar guidelines developed by the Chancellor's Office.
- e. Grantee shall respond, and shall require its subcontractors and subgrantees to respond to and resolve any complaints regarding accessibility of its products and services as required by this section. If such complaints are not informally resolved, they shall be treated and processed as complaints of discrimination based on disability pursuant to California Code of Regulations, title 5, sections 59300 et seq.; provided, however, that if Grantee or any subgrantee or subcontractor is not a community college district the references in the regulations of the Board of Governors to "the district" shall be deemed to refer to the Grantee, subgrantee or subcontractor and references to the "district governing board" shall be deemed to refer to the management or governing body of the Grantee, subgrantee or subcontractor.
- f. Grantee and its subcontractors and subgrantees shall indemnify, defend, and hold harmless the Chancellor's Office, its officers, agents, and employees, from any and all claims by any person resulting from the failure to comply with the requirements of this section.
- g. Grantee shall incorporate the requirements of this section into all subcontract or subgrant agreements to perform work under this Grant Agreement.

## 31. Drug-Free Workplace Certification

By signing this Grant Agreement, the Grantee hereby certifies under penalty of perjury under the laws of the State of California that the Grantee will comply with the requirements of the Drug-Free Workplace Act of 1990 (Gov. Code. §§ 8350 et seq.) and will provide a drug-free workplace by taking the following actions:

a. Publish a statement notifying employees that unlawful manufacture, distribution, dispensation, possession, or use of a controlled substance is

prohibited and specifying actions to be taken against employees for violations.

- b. Establish a Drug-Free Awareness Program to inform employees about:
  - 1. The dangers of drug abuse in the workplace;
  - 2. The organization's policy of maintaining a drug-free workplace;
  - 3. Any available counseling, rehabilitation, and employee assistance programs; and,
  - 4. Penalties that may be imposed upon employees for drug abuse violations.
- c. Every employee who works under the Grant will:
  - 1. Receive a copy of the Grantee's drug-free policy statement; and,
  - 2. Agree to abide by the terms of the Grantee's policy statement as a condition of employment under the Grant.

Failure to comply with these requirements may result in suspension of payments under the Grant Agreement or termination of the Grant Agreement or both and Grantee may be ineligible for award of any future state grants if the Chancellor's Office determines that any of the following has occurred: (1) Grantee has made false certification, or (2) violated the certification by failing to carry out the requirements as noted above.

## 32. Captions

The clause headings appearing in this Grant Agreement have been inserted for the purpose of convenience and ready reference. They do not purport to and shall not be deemed to define, limit, or extend the scope or intent of the clauses to which they appertain.

## 33. Indemnification

Grantee agrees to indemnify, defend and save harmless the State, the Board of Governors of the California Community Colleges, the Chancellor's Office, its officers, agents and employees from any and all claims and losses accruing or resulting to any and all employees, subcontractors, subgrantees, suppliers, laborers and any other person, firm or corporation furnishing or supplying work, services, materials or supplies in connection with performance of this Grant Agreement, and from any and all claims and losses accruing or resulting to any person, firm or corporation who may be injured or damaged by the Grantee in the performance of this Grant Agreement. Such defense and payment will be conditional upon the following:

- a. The Chancellor's Office will notify Grantee of any such claim in writing and tender the defense thereof within a reasonable time; and
- b. Grantee will have sole control of the defense of any action on such claim and all negotiations for its settlement or compromise; provided that:
  - 1. When substantial principles of government or public law are involved, when litigation might create precedent affecting future Chancellor's Office operations or liability, or when involvement of the Chancellor's Office is otherwise mandated by law, the Chancellor's Office may participate in such action at its own expense with respect to attorneys' fees and costs (but not liability);
  - 2. The Chancellor's Office will have the right to approve or disapprove any settlement or compromise, which approval will not unreasonably be withheld or delayed; and
  - 3. The Chancellor's Office will reasonably cooperate in the defense and in any related settlement negotiations.

## 34. Independent Status of Grantee

The Grantee, and the agents and employees of Grantee, in the performance of this Grant Agreement, shall act in an independent capacity and not as officers or employees or agents of the State of California or the Chancellor's Office.

## 35. Grant Agreement is Complete

No amendment, alteration or variation of the terms of this Grant Agreement shall be valid unless made in writing, signed by the parties, and approved as required. No oral understanding or agreement not incorporated in this Grant Agreement is binding on any of the parties.

# 36. Union Organizing

Grantee, by signing this Grant Agreement, hereby acknowledges the applicability of Government Code section 16645.2 to this Grant Agreement, and hereby certifies that none of the Grant funds will be used to assist, promote or deter union organizing.

If Grantee incurs costs, or makes expenditures to assist, promote or deter union organizing, Grantee will maintain records sufficient to show that no reimbursement from state funds has been sought for these costs, and Grantee shall provide those records to the Attorney General upon request.

# 37. Debarment, Suspension, and Other Responsibility Matters

If this Grant Agreement is funded in whole or in part with federal funds, Executive

Order 12549, Debarment and Suspension, and the implementing regulations set forth at 34 Code of Federal Regulations part 85, require that prospective participants in covered transactions, as defined at 34 Code of Federal Regulations part 85, sections 85.105 and 85.110, provide the certification set forth in paragraph a. or the explanation required by paragraph b. below.

- a. By signing this Grant Agreement, Grantee hereby certifies under penalty of perjury under the laws of the State of California that Grantee and its principals:
  - 1. Are not presently debarred, suspended, proposed for debarment, declared ineligible, or voluntarily excluded from covered transactions by any Federal department or agency;
  - 2. Have not within a three-year period preceding this Grant Agreement been convicted of or had a civil judgment rendered against them for commission of fraud or a criminal offense in connection with obtaining, attempting to obtain, or performing a public (federal, state, or local) transaction or contract under a public transaction; violation of federal or state antitrust statutes or commission of embezzlement, theft, forgery, bribery, falsification or destruction of records, making false statements, or receiving stolen property;
  - 3. Are not presently indicted for or otherwise criminally or civilly charged by a governmental entity (federal, state, or local) with commission of any of the offenses enumerated in paragraph 8(a)(2) of this certification; and
  - 4. Have not within a three-year period preceding this Grant Agreement had one or more public transactions (federal, state, or local) terminated for cause or default.
- b. Where Grantee is unable to certify to any of the above statements, Grantee shall attach an explanation to the face sheet for this Agreement.

# APPENDIX F: AB86 Maintenance of Effort

## Maintenance Of Effort for Adult Education

The Local Control Funding Formula (LCFF) legislation imposes a maintenance-of-effort requirement on adult education, see Education Code sections 2575(k)(2) and 42238.03(a)(7). The language from the latter section is as follows:

"For the 2013–14 and 2014–15 fiscal years only, of the funds a school district receives for purposes of regional occupational centers or programs, or adult education, the school district shall expend no less than the amount of funds the school district expended for purposes of regional occupational centers or programs, or adult education, respectively, in the 2012–13 fiscal year."

# AGREEMENT FOR PROFESSIONAL SERVICES

This Agreement for Professional Services is entered into between the Kern Community College District ("District") and \_\_\_\_\_\_\_. ("Contractor") and is dated, for reference, \_\_\_\_\_\_.

The parties agree as follows:

- 1. CONSULTANT SERVICES. Contractor agrees to perform during the term of this Agreement, the tasks, obligations and services set forth in the "Scope of Services" attached to and incorporated into this Agreement as Appendix "A."
- **2. PAYMENT FOR SERVICES.** Contractor agrees to undertake the work defined in Appendix A for:
  - A. a total price not to exceed \$\_\_\_\_\_, or -
  - B. payment at the rate of \$ \_\_\_\_\_ per day or \$ \_\_\_\_\_ per hour for periods of less than one day.

In addition to these rates, District will, at District's rate, reimburse Contractor for actual and necessary travel expenses, which will include meals and lodging only if overnight stay is required. Car travel reimbursement will not exceed the then current District's rate. Travel outside of Kern County, or by air, will not be reimbursed unless previously approved by District.

All payments will be based on invoices submitted to District by Contractor and approved by District's authorized representative.

Contractor will invoice District not more frequently than monthly for services performed and expenses incurred during the previous month. District will render payment to Contractor within 30 days of receipt of invoice, except that if payment is based on a total price under (a) above, District will retain 10 percent of the total contract amount (other than travel expenses) until all services under this Agreement have been completed satisfactorily.

## 3. TERM OF AGREEMENT. The term of this Agreement begins on\_\_\_\_

and ends\_\_\_\_\_\_. Extension or renewal requires approval of District or its authorized representative. Unless compensation is fixed on the basis of a daily or hourly rate, compensation will not be increased upon extension of the Agreement without approval of District or its authorized representative. This agreement may be terminated by District at any time on 30 days prior written notice to Contractor. In the event of termination for reasons other than cause, District will pay Contractor for work done up to the time of termination. In the event of termination for cause, Contractor need be compensated only to the extent required by law.

- 4. TIME FOR PERFORMANCE. All services required of the Contractor will be completed on or before the specified end of the term, or at such other date as is designated by District.
- **5. RECORDS.** Contractor will maintain full and accurate records in connection with this Agreement and will make them available to District for inspection at any time. Contractor's work product produced under this Agreement shall be the property of District. Contractor will prepare such reports and analyses concerning Contractor's work as are requested by District.
- 6. CONFIDENTIALITY. Contractor shall at all times protect the confidentiality of all matters for which Contractor provides service or to which Contractor has access under this Agreement. Contractor shall not disclose or discuss the facts of any such matter with any person other than District's authorized representatives without prior written consent of District, a court order, judicial subpoena or other valid legal process. Contractor shall notify District immediately by telephone and facsimile of any subpoena or court order seeking information covered by this Agreement.
- 7. STATUS OF CONTRACTOR. District and Contractor agree that Contractor, in performing the services specified in this Agreement, shall act as an independent contractor and shall have control of all work and the manner in which it is performed. Contractor shall be free to contract for similar services to be performed for other employers while under contract with District. Contractor will not accept such engagements, which interfere with performance under this Agreement. Contractor is not entitled to participate in any pension plan, insurance, bonus or similar benefits the District provides for its employees.
- 8. INDEMNIFICATION AND HOLD HARMLESS. Contractor shall defend, indemnify and hold District, its officers, agents and employees harmless from all suits, claims and liabilities resulting from negligent acts or omissions of Contractor, its officers, agents or employees in performing services under this Agreement or while otherwise present on District's premises.
- **9. COMPLIANCE WITH LAWS.** Contractor shall comply with all applicable federal, state and local laws, rules, regulations and ordinances involving its employees, including workers' compensation and tax laws.
- **10. MODIFICATION OR ASSIGNMENT.** This Agreement may not be assigned by either party without the express written consent of the other. Any attempted

assignment without permission shall be void. No modification shall be effective unless approved in writing by District or its authorized representatives of the parties and their business addresses as follows:

- **11.ENTIRE AGREEMENT.** This Agreement and its appendix constitute the final, complete and exclusive statement of the terms of the Agreement between the parties pertaining to the investigations and other services, which are the subject of the Agreement and supersede all prior and contemporaneous understandings or agreements of the parties. No party has been induced to enter into this Agreement by, nor is any party relaying on, any representation or warranty outside those expressly set forth in this Agreement.
- **12.COPYRIGHT.** *[OPTIONAL]* District shall own, solely and exclusively, the copyright and all rights to any written or otherwise copyrightable material delivered under this Agreement. Contractor is specifically subject to an obligation to assign all right, title and interest in any such copyrights to District. Contractor warrants that all creators of copyrightable material delivered under this Agreement to District are, at the time of the material's creation, bona fide employees or subcontractors of Contractor, and that such creation is within the course and scope of the creator's employment.
- **13. INSURANCE.** Contractor shall obtain, pay for and maintain in effect during the life of this Agreement the following policies of insurance issued by an insurance company rated not less than "A-V" in Best Insurance Rating Guide and admitted to transact insurance business in California: (1) commercial general liability insurance (including contractual, products and completed operations coverages, bodily injury and property damage liability insurance) with single combined limits of not less than \$1,000,000 per occurrence; (2) commercial automobile liability insurance for "any auto" with combined single limits of liability of not less than \$1,000,000 per occurrence; (3) professional liability insurance (errors and omissions) with a limit of liability of not less than \$1,000,000 per occurrence; and "1,000,000 per occurrence" as required under state law.

Each policy shall contain an endorsement naming District as an additional insured insofar as this Agreement is concerned, and provide that written notice

shall be given to District at least 30 days prior to cancellation or material change in the form of the policy or reduction in coverage. Contractor shall furnish District with a certificate of insurance containing the endorsements required under this section, and District shall have the right to inspect Contractor's original insurance policies upon request. Upon notification of receipt of a notice of cancellation, change or reduction in coverage, Contractor shall immediately file with District a certified copy of the required new or renewal policy and certificates for such policy.

Nothing in this section concerning minimum insurance requirements shall reduce Contractor's liabilities or obligations under the indemnification provisions of this Agreement.
