- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 **Sec. 1.** RCW 28A.160.220 and 1990 c 33 s 147 are each amended to 6 read as follows:
- 7 If the superintendent of public instruction or the state board of
- 8 education, in carrying out their powers and duties under Title 28A RCW,
- 9 request the service of any certificated or classified employee of a
- 10 school district upon any committee formed for the purpose of furthering
- 11 education within the state, or within any school district therein, and
- 12 such service would result in a need for a school district to employ a
- 13 substitute for such certificated or classified employee during such
- 14 service, payment for such a substitute may be made by the
- 15 superintendent of public instruction from funds appropriated by the
- 16 legislature for the current use of the common schools and such payments
- 17 shall be construed as amounts needed for state support to the common
- 18 schools under RCW 28A.150.380. If such substitute is paid by the
- 19 superintendent of public instruction, no deduction shall be made from

- 1 the salary of the certificated or classified employee. In no event
- 2 shall a school district deduct from the salary of a certificated or
- 3 <u>classified</u> employee serving on such committee more than the amount paid
- 4 the substitute employed by the district.
