- 1. **Payment**: The person signing the contract certifies that he/she has the authority for his/her action on behalf of the organization represented. All contracts must be signed with the appropriate signature and payment method determined before the event can be held. **Payment methods: Cash Check Money Order.**
- 2. **Service Charges & Deposits**: A \$150.00 minimum reservation deposit is required at time of booking an event and is **non-refundable**. The \$150.00 will be deducted from final catering bill. A deposit of 50% must be made must be made one month prior to all full service catering events and orders for 50 or more people. Payment in full is due the day of the event, prior to the meal being served, unless the client has made other billing arrangements with the catering guru.
- 3. **Guest Attendance/ Menu Selections**: A minimum guaranteed guest attendance number and menu selections must be submitted at time of contract signing. Any changes in guaranteed guest attendance number or menu selections must be made no later than seven **(7)** business days prior to the date of the event. At that time any and all new applicable charges will be added to the contract. Price changes will be agreed upon by contractor and a catering representative and a new contract will be signed. The minimum charge will be 100% percent of final guarantee. Guaranteed guest count may be increased (no more than 8% of initial guaranteed guest amount) up to two days before event. We guarantee your 'guest count' will be served. If you know that your guests are heavy consumers, we suggest ordering larger quantities.
- 4. **Event Cancellation**: If the event is canceled less than ten (10) business days prior to the scheduled date of the event, a forfeiture of any/and all monies paid will be lost by the contractor. If the event is canceled less than five (5) calendar days prior to the scheduled date of the event, a payment for the guaranteed minimum guest count will be paid by the contractor. - 9. **Sales Tax**: Sales tax must be paid unless: 1) nonprofit organization furnishes an Exempt Organization Certificate; or 2) a governmental agency furnishes a State Purchase order or Tax Exempt Certification Form. Unless tax-exempt certificate is provided when signing contract, sales tax will be collected.
- 10. The contractor shall not be held liable due to unforeseeable circumstances or circumstances beyond the control of *Handsome Devil LLC*.
- 11. Prepared food contracted for consumption at the event only may not be taken from the specific event or venue unless otherwise agreed upon prior to the event and it is stated on the catering contract. **IF** left-over food on buffet line will be left with client it will be in sealed foiled pans tagged with specific safety and re-heating/refrigeration directions.
