After you mail your renewal application:

- 1. **Receipt Notice**. Within a few weeks of sending your application, you should receive a receipt notice from USCIS confirming that they received your request and payment.
- **2. Fingerprint Appointment**. Soon after, you will receive a notice of your appointment to have your fingerprints taken. You must go to this appointment with photo ID and your appointment notice. If you miss this appointment, your renewal request will be denied. If you need to reschedule your appointment, follow the instructions on the notice.
