

## **Attention Property Owners:**

All properties <u>must be inspected</u> by the City of Allentown <u>prior to transfer</u> <u>of title</u>. Property must comply with the City of Allentown Property Rehabilitation and Maintenance Code and allowable use by the City of Allentown Zoning Ordinance (Bill 109-2007).

The owner **<u>must</u>** call the city for an inspection within 5 business days of offering the property for sale.

- Properties need to be registered with the City of Allentown and provide a Local Rental Agent if the owner does not work in Lehigh County or reside in Lehigh County.
- Yearly rental registration fees are billed in January.
- Rental Properties are inspected on a cycle depending on the location of the property.
- Code Summary is a checklist of what the inspectors look for during a rental inspection.
- Property Rehabilitation and Maintenance Code Books are available upon request in the office and online, instructions on how to access the code book online are on the back of the registration application.
- Proper Permits must be pulled for work being done on the property
