Bond Auto ACT Invitational Qualifier: Winner will receive \$500 bonus if they enter and participate in the Invitational. Competitor must be ACT approved to compete at NHMS.

RACING ELECTRONICS AWARDS: \$100 in product certificates payable contingent upon use of RE Radios or authorized equipment and proper display of decal: \$50 to winning driver, \$25 to 7th place, \$15 to top finishing driver who has not won an ACT Tour feature in current year, regardless of position and \$10 to first non-qualified driver. (Maximum of three awards during season). If designated winner and 7th place finisher are not in compliance with criteria or have reached maximum awards, no award is given. If designated first non-winner and first non-qualifier are not in compliance or have reached maximum awards the next eligible driver will receive award.

BASSETT: \$30 off the purchase of any two (2) wheels to 2nd place finisher payable contingent upon proper display of decal.

CRAZY HORSE AWARD: \$50 certificate to tenth place finisher regardless of chassis or decal display.

VP RACING FUEL HARD CHARGER AWARD: A 5 gallon pail of VP "spec" fuel will be awarded to approved VP Hard Charger who has not won an ACT event in 2012 contingent upon proper display of decal.
