- Attendees must be registered for the annual meeting.
- VIP Morning Tours are scheduled on Monday, December 2 Thursday, December 5 from 8:00 a.m. to 10:00 a.m., with the last group entering the hall before 9:30 a.m. NO early morning meetings will be approved for Sunday, December 1.

- Companies will be responsible for providing escorts to and from these entry points:
