**Ramps at the sole discretion of the judge**, approved breeds may be judged on the ground or on a ramp: Boykin Spaniels, Clumber Spaniels, Field Spaniels, Sussex Spaniels, Welsh Springer Spaniels, Whippets, Irish Terriers, Kerry Blue Terriers, Soft Coated Wheaten Terriers, Staffordshire Bull Terriers, Chinese Shar-Pei, Chow Chows, Keeshonden, Norwegian Buhunds & Polish Lowland Sheepdogs. (Boykin Spaniels & Whippets may be judged on the table, ramp or on the ground.)

**Basset Hounds & Bulldogs** are expected to be judged on the ramp during breed judging.

**This list may be** revised from time to time, and the current list can be found on the AKC website in Judging Operations.

**A judge requesting** the use of a ramp must give reasonable notice to the Show Superintendent/Show Secretary prior to the day of the show. AKC approval is not required.

**Ramps may be used** in emergency situations to judge any breed. (In all but emergency situations, the exhibitor has no recourse. In an emergency situation, where use of a ramp is not indicated in the premium list, an exhibitor has the option of withdrawing their entry and receiving a refund.)

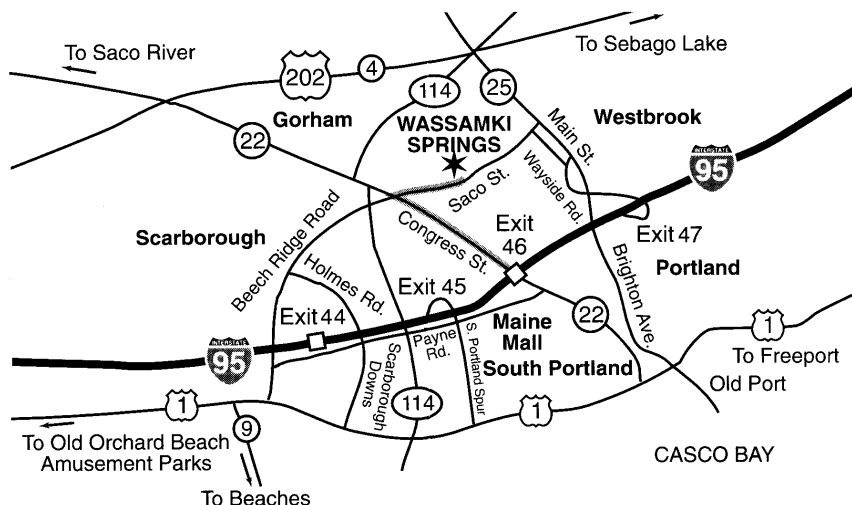

## Attention Exhibitors

- \* Southern Maine Coastal Classic will not be held responsible for any accidents that may occur to any person, animal, property or vehicle. The exhibitor shall hold the Event Committee harmless and indemnify it against any legal proceedings arising from any accident.
- \* **Show location** will be available the evening before the Thursday show.
- \* **A Parking Fee will be charged. Any vehicle parked overnight will be charged at the camping rate.**
- \* **NO UNENTERED DOGS WILL BE ALLOWED ON THE SHOW GROUNDS** - Only dogs that are eligible to be shown under the AKC rules shall be allowed within the show premises. Chapter 11, Section 11, AKC Rules Applying to Dog Shows.
- \* Rude, abusive language, arguing and objectionable behavior or failure to follow the parking rules or directions of Club Officials or the Parking Committee will immediately be subject to action by the Event Committee. **NO EXCEPTIONS.**

### 4 & Under 6 Months Puppy Competition

**Sunday, May 19, 2013**

Entry Fee: \$15.00 per puppy

One combined class will be offered for breeds and varieties of dogs that are (4) four months & under (6) six months and divided into Groups as described in Chapter 3, Section 1 of the *Rules Applying to Dog Shows* and the Miscellaneous Class breeds as listed in Chapter 3, Section 23. **There will be a selection of Best 4 & Under 6 Months Puppy in each Breed/Variety**, each Best 4 & Under 6 Months Puppy in Breed/Variety winner will then compete in their respective group for First through Fourth Placements. The Miscellaneous Class Competition will be judged same as above followed by a Miscellaneous 4 & Under 6 Months Puppy Group Competition. The Foundation Stock Service Class Competition will be judged same as above followed by a FSS 4 & Under 6 Months Puppy Group Competition. All First Place Group Winners will be eligible to compete in Best 4 & Under 6 Months Puppy in Show.

An AKC registration number or AKC litter number will be required for entries of an AKC recognized breed or Miscellaneous breed. FSS number or FSS registered litter number will be required for FSS entries.

A foreign born dog may enter this class if they are registered in the country of origin.

Dogs are required to be vaccinated (including rabies) in accordance with their veterinarian's protocol in order to avoid inadvertent transmission of illness by/to puppies not yet fully immunized.

Professional handlers are not permitted to exhibit in this class. *Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay.*

AKC *Rules in Dealing with Misconduct* will be applicable to any person and dog entered at this competition. All applicable rules found in *Rules Applying to Dog Shows* will govern the conduct of this competition unless these regulations state otherwise.

Exhibitors should plan on opening the mouth of their puppy for the judges. Breed standard disqualifications such as color, height, weight or dentition shall not be a point of consideration in the judging process for this 4 & Under 6 Months Puppy in Show Competition.

In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.

### INSTRUCTIONS

1. (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).

2. The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.

3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. age division, color division, weight division.

4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)

5. Mixed Breed dogs entering classes for Agility, Obedience, and Rally trials should mark Breed as "All-American Dog/Mixed Breed." Sire and Dam information shall remain blank for mixed breed entrants.

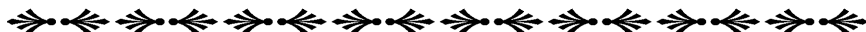

**All Dogs Present** must be held on leash or confined to their crates except when being judged or when in the exercising ring.

**Class Cash Prizes** will be paid in the ring to the person showing the dog. Claims for prize money must be made in the ring before the judging of that breed is over, and the Event Secretary's Office advised at once. The Event Secretary and show-giving Club disclaim any liability for cash prizes after the judging of the breed is over.

**No gasoline or diesel generators** are permitted inside any building or within 100 feet of any tent in which this dog show is conducted.



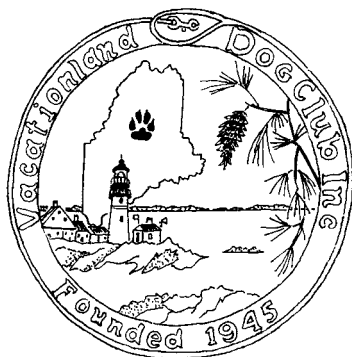

2. The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.

3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. age division, color division, weight division.

4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name.
