Purpose

I am writing to provide you the California Women, Infants and Children (WIC) Program's Nutrition Services Plan (NSP) instruction packet for FFY 2012-2104 (October 1, 2011 through September 30, 2014). Your completed NSP Local Agency Work Plan is due to us by October 31, 2011.

For this three year cycle, we continue a streamlined statewide approach by providing designated goals and objectives for your local WIC agency to pursue along with planning and training tools. Highlights of the FFY 2012-2014 NSP

The following information provides highlights of Sections 1-4 as well as the NSP Evaluation Survey.

Local Agency Work Plan – Section 1

Section 1 includes a three year local agency work plan with designated goals and objectives in the areas of Breast Feeding Promotion, the Baby Behaviors Campaign, and Participant Centered Education (PCE). There are three specific goals with corresponding objectives and timelines. We also encourage you to look at your program and identify additional goals and objectives that you may want to obtain or continue.

Goal 3 and its corresponding objectives are provided in a slightly different format. The Training and Career Development Section (TCDS) of the California WIC Program developed this goal and objectives to help provide local WIC agencies support in the areas of education and training in providing PCE. TCDS will be providing additional reminders, assistance, and information throughout the NSP period for completing Goal 3 objectives.

Ongoing Quality Improvement – Section 2

This is a new section which highlights the use of an ongoing quality improvement monitoring plan and maintaining ongoing quality improvement activities to ensure high quality nutrition services. We included a Sample Continuous Quality Improvement (CQI) Monitoring Plan with examples of areas to monitor (e.g., nutrition education, certification and corrective action items) and suggestions on how to monitor and/or improve these areas. Please complete a CQI monitoring plan and keep on file.

Local Agency Planning – Section 3

This section will help you to identify areas of nutrition services to consider and review on a regular basis as part of program operations. We have included a checklist to assist you in this process.

Staff Training Plan – Section 4

This section provides information on developing and maintaining a staff training schedule and training log. Please complete a staff training plan and keep on file.
