## REFUNDS, CANCELLATIONS AND TRANSFERS

- Please note that all cancellations and changes are subject to the policies below, without exception.
- All cancellations must be made in writing (i.e. fax, e-mail or letter) to the Alliance française d'Edmonton downtown office.
- Refunds can only be issued for sessions cancelled maximum 1 week prior to the first day of camp. A \$50 cancellation fee will apply (per child and per session cancelled.) No refunds will be granted for withdrawals less than 1 week prior to the start of the session.
- Refunds for medical reasons can only be granted upon presentation of a medical certificate to the Alliance française d'Edmonton office.
- Pro-rated refunds cannot be granted if a child cannot attend the camp some days due to illness or any other personal circumstance, or because other services requested and paid for are not fully utilized.
- All transfer requests must be made in writing (i.e. fax, e-mail or letter) to the Alliance française d'Edmonton office. All transfers will be subject to a mandatory \$25 transfer fee per transfer per child.
- Requests for transfers will be accepted up to 1 week prior to the first day of a camp session, provided there is sufficient room in the preferred camp session.
- A \$25 administrative charge will be applied to all NSF cheques.

## RELEASE AND AUTHORIZATION

- I understand that the participation in any children's activity can result in possible injury or danger. I do not hold the Alliance française d'Edmonton and staff liable in case of harm or damage arising or sustained by my child during the period of registration. I further certify that the registrant is covered by Alberta Health Care and/or private health insurance.
- I agree to drop off and pick up my child(ren) in the premises. The Alliance française d'Edmonton is not responsible for children off the premises. In case of absenteeism, parents are asked to call Alliance française d'Edmonton. Children are not allowed to leave the premises except with written permission. Parents who choose the after-hour service must pick up their children at 6:00 pm at the latest.
- Peanuts or any other types of nuts are strictly forbidden and cannot be eaten in the camp premises, as they can be serious threats to allergic students.
- We require that all young people attending Alliance française d'Edmonton summer camps demonstrate respect for each other and for their counselors. This includes respect for each other's safety and for each other's feelings. Politeness, attitude and behavior must conform to the expectations. The Alliance française d'Edmonton reserves the right to expel students whose attitude presents a nuisance or a danger to the spirit of the group.
- I hereby give permission for my child to participate in all activities including trips away from the premises.
- I understand that neither the Alliance française d'Edmonton, nor its staff is responsible for damage or loss of personal belongings during the program.
- I understand that descriptions of programs are subject to change before and/or during the camp season without prior notice.
