# BACKGROUND:

The Brookville Volunteer Fire Department, 3640 Waterlick Road, Forest, Virginia in the Timberlake Election District has submitted a request for an exception from the Noise Ordinance for a fundraising event named "End of Summer Bash" at 1301 Greenview Drive, Lynchburg, Virginia on August 23, 2014. The event will include music, food and beer with an anticipated attendance of 200. The Fire Department is requesting an extension of time for the event from 10:00 p.m. until 11:00 p.m. and a maximum decibel level at the property line of 75 dba.

# DISCUSSION:

Attached is a request for exception from the Noise Ordinance. The County's ordinance specifies a decibel level of 77 dba from 6 a.m. to 10 p.m. and 52 from 10 p.m. to 6 a.m. if the property abuts an occupied dwelling. The request is to extend the noise ordinance for one hour from 10:00 p.m. to 11:00 p.m.

A Special Entertainment Permit is currently being completed for approval by the County Administrator.

## **RECOMMENDATION:**

Staff recommends the Board review the request from the Brookville Volunteer Fire Department and advise if you will grant an exception to the noise ordinance for this event.

The County, its employees, officers and agents shall not have to give the undersigned any specific types of notices of such claims.
