OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING.

PROMOTION DATES 1.

These rules (the "Official Rules") govern the \$10,000 Superquiz ("Promotion") will begin on March 25th, 2013 at 6a MST and end on a. May 31st, 2013 at 6p MST.

ELIGIBILITY RESTRICTIONS 2.

The Promotion is open to all legal residents of the United States and the District of Columbia who are 18 years of age or older at the a. time of entry and who live in Idaho. Employees of Journal Broadcast Group, Inc., d/b/a KTHI (the "Promoter" or "Station"), its corporate parent, subsidiary, and affiliated entities, its advertising agencies, participating sponsors/promotional partners, other broadcasting stations in the Boise metropolitan area, and the members of their immediate families (spouse, parents, siblings or children) or households (whether related or not) are ineligible to participate or win. The 7th caller after the cue to call will be eligible to win the daily prize. To win the daily prize, the 7th caller must answer survey questions correctly. The top three most common answers to each survey guestion provided by listeners/public at www.khits.fm will represent the correct survey answers provided by caller #7 during the contesting as outlined in 3.a. to win prizes as listed in 4.a.. In the case that two or more survey questions receive the same amount answers from survey takers, they will all represent correct answers in the contesting period as outlined in 3.a.. Survey answers will be allowed once per person, per IP address and per email address.

c. One winner per person or per household.

This Promotion is in no way sponsored, endorsed, administered by, or associated with Facebook. By submission of an entry, an d. entrant releases Facebook from any responsibility or liability for the Promotion, the Promotion's administration, prizes, or promotion. You are providing entry information to the Station and not to Facebook.

4. PRIZES

Monetary prizes will be awarded to caller #7 as outlined in 3.a. based on the number of correct answers to contesting as outlined in a. 3.a. and 3.b.. Caller #7 will have a maximum of three questions. One correct answer will award caller #7 \$25; two correct answers will award
