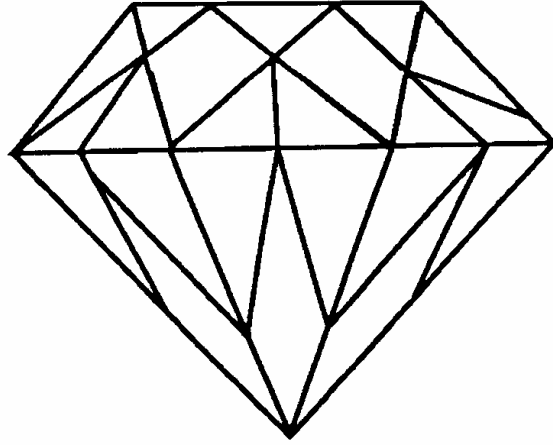

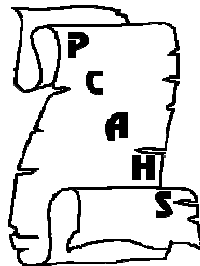

Notes for JAMES ORRICK or OURROUCH: From: Colonial Families of the Southern States of America, p. 400: The Orricks (or Oric, Orrok, Orrouck, Ourrouck, etc. as the name is variously spelled) are of an ancient family of Scottish origin. According to the authority of "Nesbet's Heraldry", Vol. II, "Simon de Orrock is without question the ancestor of the House of Orrock (of that ilk) in the County of Fife reputed an ancient family" and an honorable one. Sir Simon de Orrock's name is inscribed upon the Ragman's Roll which for antiquity is the rival of the British Doom's Day Book. The name Orrick or Orrock is said to have originated from the rock upon that part of the Fife coast where lay the great landed estate of Orrok, belonging to the family of the same name. A history of the Orrock or Orrick family of Scotland, whose arms continue to be borne by the Orricks of America, takes us back to the 13th century.

James Orrick or Ourrouch, as his name is quaintly spelled by the scrivener who wrote his will, appears in the Colony of Maryland, about the year of 1650; on Nov. 30, 1665, he was granted a patent for 190 acres of land on the bayside called Orwick; on May 1, 1683, he was granted a patent for 150 acres of land called Orwick's (Ferry or Fancy), located on the north side of the Severn River.

In 1675, a will was filed in Annapolis, MD where this James (his son) is called James Ourrouck, son of Elizabeth Moose, his father having died and his

mother having married as her second husband, Richard Moose.

In September, 1681, James Orrick (the son) was paid 500 pounds of tobacco by the Province of Maryland for services he had rendered. His will was probated November 11, 1690 in which he names his wife, Mary as executrix and his sons William, John and James.

Tipton, who was born in Tennessee in 1840, a son of Isaac and Elizabeth (Anderson) Tipton, the former of whom was a native of Carter County, Tenn., and a son of John Tipton of that county. ..."

"Murfreesboro.

"The Weekly Defense, at Murfreesboro, was one of Pike County's first newspapers. It collapsed in

1883. Dr. McKethan and E.B. Kelley were its editors and publishers.

"R.H. Waddell started the Pike County Sentinel, in January 1885, with the material of the defunct Mineral Springs Home Journal, and ran it until the fall of that year, selling to J.O.A. Bush and H.F. Fagan. They changed its politics from Democratic to Independent. O.C. Story next bought Mr. Fagan/s interest, and in 1886 J.O.A. Bush became sole owner. ..."

Excerpt from *Lest We Forget or Character Gems Gleaned From South Arkansas* ...

"A historical sketch of Center Point Circuit would be incomplete without mention of the camp grounds and annual camp meetings. The camp ground two and a half miles north of Center Point known as Ebenezer Camp Ground, is an ancient institution. Just when it was first established no living man knows. An old Quarterly Conference record shows that the Fourth Quarterly Conference for Sevier Circuit was held there October 5, 1839. This was more than seventy years ago, and within about twenty years of the first Methodist preaching in the bounds of this state. It must have been established in the first decade of Methodist history."

Isaac A. Hutson

Isaac A. Hutson was in Pike County, Arkansas by 1847, having recently arrived from White County, Tennessee with his wife Jane __, grown children and their families. They settled in the Sweet Home area, where Isaac obtained a land grant. It is believed that Isaac was a brother of Sarah (Hudson) Cooley of Pike County. Isaac was born about 1784, near Pumpkintown, Pickins County, South Carolina and lived in this area until about 1812. In 1816, he is found on tax records in White Co., Tennessee. He was the son of George Hutson and Creasy __ of Old Pendleton District, South Carolina. Isaac probably married Jane there, as their oldest son, Joab, was born in South Carolina (Census records) and about 1812, they moved with Isaac's mother and siblings to White Co., Tennessee. Isaac died in Pike County, Arkansas, May 1859 of pneumonia and his burial site is unknown.

Jane was born in Virginia and her family is not known. She died in Pike County, October 3, 1852 at

age 62 years, 6 months and 22 days (April 12, 1790), according to her marker in Wolff Cemetery at Bengin.

From Burnt Records in Pike County, Probate Book 1, page 309. May 20, 1859, Silas Hutson

petitions that on May 18, he took letters of Administration on the estate of Isaac Hutson, who died in Pike County. All heirs are of age. The court gave Silas Hutson permission to sell personal estate.

Probate Book 1, page 351 Andrew Hutson says on May 2, 1859, Isaac Hutson, Senior intended to give him some land, but the land was imperfectly described. It was part of the southeast 1/4 of the southeast 1/4 of section 35, township 8 and part of the northeast 1/4 of the Northeast quarter fraction of Section 2. Township 9, all in range 26 West. Claim verified by Joab Hutson and John A. Hutson. The court granted his request.

Census records show they had seven sons and five daughters. All except Joab were born in Tennessee. Children accompanying them to Pike County were:

Davis W. Hutson

Davis W. Hutson preceded his father, Isaac, to Arkansas, locating in Hempstead County about 1843. He had married Nancy Phelps Stewart in White County, Tennessee, September 25, 1839. She was the

daughter of William and Rachel (Wisdom) Stewart of White County.

On the 1850 Federal Census, the family was listed next to Charles and Parthenia (Stewart) Kennedy in Mine Creek, Hempstead County, Arkansas. Charles Kennedy had been in this area before 1839 and Parthenia was Nancy Hutson's oldest sister. Both Davis Hutson and Charles Kennedy obtained land grants along the Pike County and Hempstead County line at Tokio, and were probably at this location in 1850. They were farmers. Davis Hutson was born in January, 1812, in Tennessee, probably in White County, and died in Hempstead County, Arkansas, November 16, 1894. He had written his will and named his children the week before. (November 9, Hempstead records)

Nancy (Stewart) Hutson was born in White County, Tennessee, March 3, 1822 and died October 7, 1907 in Pike County. She became ill (depressed?) in her last years and spend about a year in the State Hospital at Little Rock, with E. K. Stewart her guardian. She then lived with her daughter, Louisa Jane Stewart of Sweet Home. Both are buried in Oak Grove Cemetery.

They were early members of Mt. Tabor Methodist Protestant Church in 1878 (Goodspeed).. On January 20, 1880, Davis acquired 160 acres of his father's grant at Sweet Home and on November 22, 1883, he gave 3 acres near the Hudson springs in Hempstead County, for the Sweet Home Methodist Episcopal and Protestant Methodist Church. He signed this deed with his mark. Measurement began in the middle of the meetinghouse, indicating others gave part of the church property. Davis Hutson's son Thomas told his children that his father had fought in the Civil War, but there have not been any details been found.

Dock was born at Tokio, in Hempstead County, Arkansas May 23, 1857. He was a farmer and a Methodist. He married Lucy Rattiken, probably in Hempstead County, August 11, 1887. She died in 1892 in Pike County. Their children:

Both Doss and Louis returned to Arkansas as young men and changed their last name to Hudson.

He stayed at Sweet Home until 1898, when he took his two small sons, Doss and Louis, and moved to Britton in Tarrant County, Texas, following the Rattikin family, to a rented farm. There, Andrew Rattikin told him there was a pretty young widow at church that he must meet. This meeting at the Bisbee Methodist Church was his introduction to Mary Olive (Teague) Johnson, who had five children at home. Following their marriage on November 18, they went back to Dock's old house. The next morning, Ollie

got up early to cook breakfast, stepped out on the front porch and fell through rotted boards. She had a broken leg! Their daughter, Ellen, was born the next summer on August 15. Except for a brief stay in Eastland County, Texas, Dock and Ollie spent the rest of their lives in various locations in Tarrant County, building a home in 1927 in Fort Worth. He spend his later years as a night watchman for a nearby cottonseed processor.

Dock died March 14, 1946 and Ollie died in August 1964. Both are buried in Laurel Land Cemetery in Fort Worth.

The trial of Laura and Walter Whisenhunt, charged with murder for the killing of Isom Whisenhunt, their husband and father, was begun in the Howard County Circuit Court in Nashville, Thursday morning.

Mrs. Whisenhunt was placed on trial first. Thursday and Friday were consumed in the hearing of the case and it was thought it would be submitted to the jury last night.

The state was forced to depend upon the evidence of the family, mainly, for its case, together with much circumstances as tended to throw light upon the matter.

Since the finding of the body the contention of the defense has been that Mrs. Whisenhunt shot her husband in defense of the life of herself and son, Walter, who is jointly indicted with her for the murder,

Walter Whisenhunt, his brother, Jesse, and a sister were placed on the stand by the prosecution. Their evidence was practically the same, along the lines indicated from the first, and when Mrs. Whisenhunt was placed on the stand to testify upon her own behalf her testimony was the same as that of her children, in all the essential features.

It was testified that Isom Whisenhunt went to his home from Nashville, drunk and quarrelsome; that after arriving at home he had declared his intention of killing the family, and more especially Walter; that he secured his Winchester rifle, and seated himself in a chair, forced his family to remain in the room, while he continued his threats; that he finally raised his gun, as if to shoot Walter, when Mrs. Whisenhunt, with a pistol she had taken from a trunk, shot him 3 times! That the body was placed in a wagon by Mrs. Whisenhunt and her sons, Walter and Jesse, and taken and placed in a well; where it was later found after Mrs. Whisenhunt had revealed the hiding place in a confession of the killing.

All other evidence was circumstantial, as the members of the family are the only known eyewitnesses to the killing.

Acquittal Verdict Was returned by Jury Last Saturday In Whisenhunt Case Jury Declared That Mrs. Laura Whisenhunt was not Guilty Of Murder Charge:

On Saturday afternoon in the Howard Circuit Court, the jury in the case of Mrs. Laura Whisenhunt charged with murder for the killing of her husband, Isom Whisenhunt, returned a verdict of not guilty. Mrs.

Whisenhunt was seated in the rear of the courtroom near the aisle, when the verdict was rendered, and shook hands with the Jurors and thanked them as they filed from the room.

The case against Walter Whisenhunt, the son, was continued, but it will be dismissed later, as the evidence in both cases is identical. Mrs. Whisenhunt confessed to the killing of her husband, but claimed that she shot in defense of herself and children

Resurrecting Redland Cemetery

When the original Pike County Arkansas Cemetery book was published, Redland Cemetery had only three markers that included names and dates. The other 33 graves were marked with only large rocks or small wooden crosses placed at the head of the grave. No one was sure who these unnamed souls were.

A few years ago, when reading the archival Civil War Records for Joseph David Alford, it was revealed that his first wife Margaret Jordan Alford and her sister, Elizabeth "Bettie" Jordan Pyburn Alford (his second wife) were buried in the "old family graveyard" on the Jordan home place. The papers further revealed that one of Margaret's children and one of her sister's children are buried there also. Margaret and the two children had died in the same house within 30 minutes of each other from a "fever that came up."

The papers also revealed that Margaret and Bettie's parents, James and Delilah Jordan were also buried in the Redland Cemetery. This gave us documentation for six of the 33 graves.

This spring, some members of Frontier Trails Genealogy Club and other concerned community members decided to visit the cemetery and clean it up. It has not been used for new burials in many years and only a few people even remember where it is located out in the middle of a Weyerhaeuser pine plantation.

In April, Annie and Billy Funderburk obtained the key for the gate Weyerhaeuser had put up. Wallace and Lee Ann Turner met the Funderburks at Kirby and followed them out to the site. It seemed like a long way down the narrow, rutted, washed-out dirt road from highway 84 on over to the cemetery....it was actually less than a mile.

Billy stopped, hopped out of his truck and started off down through the woods-pushing through underbrush, muscadine vines and huge sawbriers off

to the left of the one-lane road. Wallace was wondering what he was looking for out in the woods when Annie came up to the Turner's idling Jeep and said, "This is it!"

Finally, wading out into the huckleberry bushes and weeds, we could see the three markers rising through the underbrush keeping their silent vigil. We could make out a few of the other graves, one with large rocks ringing the whole grave.

After we looked around and found the approximate perimeter of the area, we dragged out our leather gloves, chain saws, limb-loppers and rakes and started cutting and hacking away at the vines and saplings growing around and over the grave sites. We uncovered shreds of a barbed wire fence around some areas. The wire was embedded in some huge oak trees at one corner of the cemetery and in the ground along two sides. As the vines and saplings were cut, we hauled them off to pile across the road. The larger trees were left. We were afraid they would damage the remaining stones if they were felled indiscriminately and not removed carefully.

Shortly after we begin, reinforcements arrived in the guise of Jimmy and Fern Adams, their two children and Fern's sister, Robbie Stewart. The group of us cut, chopped, dragged and hauled limbs and debris for hours until we were all worn out, hot and tired. The cemetery was recognizable as such, but there was still much to be done.

About a month later, we all met at Redland again for another round of cleaning. This time Wallace and Billy cut out the larger hardwood trees while Jimmy limbed some up with his ax. The women and Richard hauled limbs, short logs, brush and more vines out and piled them out of the way. We started raking off years of accumulated leaves and other forest detritus.

Armadillos, moles and other creatures had dug their tunnels and holes around and a few of the old graves had settled so that a person had to be careful of their footing. Fern kept insisting that there used to be more marked graves than were visible. We started looking for ridges in rows and raking deeper. In some places we found the rows of rock markers buried under 6-8 inches of accumulated leaf mold. We started "prospecting" with a fire rake and soon had several rows of rock markers that were lined up with other identified markers. Robbie Stewart painted the rocks white so they would be left in place. Some of the gravesites had been marked with small white wooden crosses that had rotted off and fallen over and were lying askew. We replaced those we could find with metal crosses or pieces of concrete blocks as a temporary substitute.

A few days later, Annie and Billy collected donations and arranged to have road signs made by the county. Then they helped erect the signs-one on

the highway where the dirt road turns off, and others where there were other turns at intersections.

Fern Adams in contacting some descendants of other buried in the unnamed graves and markers are planned for a few graves when it is known who the individual is that is buried in the rock-marked spot. For those people we know are buried in the cemetery, but their precise resting place has been undetermined, we are planning one large memorial marker with all the names inscribed.

There are still some large pine trees to be cleared and more raking and pruning to be done before the old cemetery will look really cared for, but for now at least, it is again recognizable as a burial place and not just part of a clear-cut pine plantation.

If anyone knows the name of any others buried in the Redland Cemetery without a marker, please let us know so the names can be included on the new marker, as well as the new, soon to be published, cemetery book. ... Lee Ann Turner

Dear Sir & Kinsman

I received your letter today and take pleasure in answering it. My Great Grand Father on my father's side was named Francis. He had five sons. Their names were John, Simeon, Thomas, William and Samuel. This Samuel was my Grandfather and I was named for him.

My Fathers' name was Francis - he being named for his Grandfather Francis. My Great Grandfather Francis Bittick settled near St. Louis about the year 1800 and my Grandfather Samuel died there when my father was quite a small boy. My Father with his mother moved to Arkansas when my father was quite small. My father moved to Texas 1852. James Bittick who lived in Jefferson County, Missouri

3
and who died there last winter in his 79th year was an own cousin to my father. I had corresponded with him last year. He was a son of old John Bittick a brother to my Grandfather Samuel. Every Bittick in Missouri I presume is a descendant of my Great Grandfather Francis. My Great Grand Father Francis had a brother named Samuel who came with him from Wales to America. This Brother settled in Tennessee.

And Tennessee is full of his descendents, a good many of his descendants are in Texas, some of whom I have seen. But I have never in my life seen a Kinsman of my father's name who was a descendant of my Great Grand father Francis - and it would be a curiosity to me to see one of my father's people.

My father had no brothers and I have none. I had one sister and she has been dead about fourteen years. My father died 15 years ago at the age of 64. My mother is alive and lives with me, she is 81. ancestor, was born in Fifeshire, Scotland (see pages

Samuel Henderson, son of Nathaniel, was born
in 1759 in Granville county, N.C. ... (his)
grandfather, Samuel Henderson (1700-1783) had
moved from Hanover county, Va., about 1745 to
what is now Granville county ... (He) moved with his
father to Hawkins county, Tenn., and (in 1786)
married Lucy Ryckman, who was born and reared in
Cumberland county, Va., a county adjoining Hanover
county, the former home of the Hendersons. We learn
from the diary of his son, Dr. Samuel Henderson
(1804-1884), written while his mother, Lucy
Ryckman Henderson, still lived. This diary now
(1919) is in the hands of Captain Thomas P.
Henderson, of Franklin, Tenn. She was of Dutch
descent.

Samuel, the subject of our sketch, was married in
Greene county, Tenn., March 14, (1786), while this
was a part of the short lived "State of Franklin." The
State of Franklin was composed of Davidson,
Greene, Washington, Hawkins and Sullivan counties.
In November, 1785, a convention met at Greenville
to ratify a constitution of the State of Franklin, which

constitution had been made at Jonesboro, Dec. 14,
1784. John Sevier, at this convention, was chosen
Governor of the State of Franklin; Langdon Carter
was Speaker of the Senate; William Cage, Speaker of
the House of Commons; and David Campbell, Joshua
Gist and John Henderson, Judges of the Superior
Court (see page 93, Wheeler's History of North
Carolina) ... William Cocke was to represent the State
before Congress. In September, 1787, the Legislature
of the State of Franklin met for the last time in
Greenville.

After his marriage (to Lucy Ryckman), Samuel
Henderson (1759-1828) moved to Knox county,
Tenn., and settled on the Holston river, about four
miles from Knoxville, on the opposite side of the
river. Here their children were born. All their
children were girls except the youngest, Samuel, who
was born (in) 1804.

The writer has, framed and hanging in her home,
an old land warrant which belonged to Samuel
Henderson (1759-1828), showing 100 acres in
Hawkins county was conveyed to him in 1791,
through Isaac Taylor. This warrant is dated "Western
Territory South of the Ohio, Sep. 19, 1791." This ...
land warrant reads: "The Estate of Isaac Taylor,
Des'd. to Samuel Henderson Jr. one hundred acre
Land Warrant; Hawkins County, W.T. So. of Ohio.
This day came James Henderson before me, James
White, a Justice of the Peace for Hawkins county,
and made oath that he heard Issac Taylor assume on
Armstrong's one Hundred Acre Warrant to Samuel
Henderson, and further saith not. Sworn to before me
this 19th of Sept. 1791. James White, Jcp. This day
came Samuel Henderson as above and made oath that
he never received any satisfaction for the above
Warrant. Sworn to this 19th of Sept. 1791. James
White, Jcp."

He was my grandfather. He belonged to (the)
Ninth Regiment North Carolina Continental Troops.
This regiment was commanded by Colonel John P.
Williams, Lieut. Col. John Luttrell, Major Wm. Polk
(see North Carolina Register). He enlisted Nov. 26,
1776. His name is on the tablet on the court house in
Franklin, Tenn., placed there in honor of
Revolutionary soldiers buried in Williamson county,
Tenn. ... Early in the American Revolution men
would sometimes enlist for a short period. We do not
think Samuel Henderson served during the whole of
the war. When sixteen years old, in 1775, he was
with his father, Nathaniel Henderson, for a while at
Fort Boonsboro on the Kentucky River ...

Samuel Henderson (1759-1828), who was
married in (1786), ten years after the founding of
Boonsboro, named one of his ... children "Levisa" in
honor of the old name given to (the) Kentucky river
upon which Boonsboro was founded ... the youngest
child ... was given the name of his father, Samuel
Henderson. I will say in passing that the last Samuel

was my father and ... he did not marry until he was in his fortieth year. I am one of his younger children, so in this way tradition is close.

In 1808 he moved ... his family to Louisiana Territory (Missouri), settling ... (east) the vicinity of St. Louis ... They went all the way by river in a ... boat, down the Holston to the Tennessee river, down this to the Ohio, along this to the Mississippi, then up to St. Louis.

Samuel Henderson (1759-1828) and his wife had both for many years been members of the Presbyterian church, but here they found no Presbyterian church, so they joined the Methodist church. From the diary of Samuel Henderson (1804-1884) we learn that his mother, in the spring of 1787, joined the Presbyterian church in Knox county, and that her husband, Samuel Henderson (1859-1828) had already joined the church about a year earlier.

Lucy Ryckman, wife of Samuel Henderson (1759-1828), was born in Cumberland county, Va. ... (of a) Dutch family, some of whom settled in New York at an early date ... One branch of the family left New York for Virginia, settling in Cumberland county ... To this branch Lucy (Ryckman) Henderson belongs ... (She) was born November 15, 1765, and died July 14, 1843. After her daughters had all married and had settled in different states, she made her home with her only son, Dr. Samuel Henderson (1804-1884), near Bethesda, Williamson county, Tenn. This son had such devotion for his mother that he would not suffer his heart to become so deeply involved that he should marry before she died. So he lived a bachelor. He married in his fortieth year. Lucy Henderson was active and full of energy even to her last days. Though she lived to be seventy-eight years old, it was no unusual thing to see her run from the house to the kitchen or negro cabins. She was five feet four inches in height, and of athletic build. Aside from more useful arts she taught her daughters to embroider and do fancy work.

The children of Samuel Henderson (1759-1828) and his wife, Lucy Ryckman, were all born in Knox county, Tenn., (and) all went with their father to Missouri in 1808 to live. Ann, married Charles Pyron, while living in Knox county, (and) she and her husband moved to Missouri in 1808. They were (the) parents of Tapley, John and Sterling Pyron. Levisa, named for Levisa river, ... married Bradford Bynum ... and made their home in Illinois. Mary, married Oliver Brewer, and moved to Missouri, but afterwards to (Hempstead) county, Arkansas. Their descendants live now (1883) in Pike county, Arkansas, and elsewhere. Mathilda, married Ely (Eli) Bynum, (and) lived in Kentucky. Elizabeth, married John Strickland. Sally, married Henry Edwards, and lived in West Tennessee. Lucy, after being divorced from her first husband (Meady Gully), by whom she had no children, married Thomas Gillespie. They

moved to Texas ... They had one child, Thomas. Samuel Henderson, ... was born October 8, 1804. He married Rachel Jane Hughes, March 14, 1844. He died December 9, 1884.
