# Hazardous Waste Collection Day

The Farmington Conservation Commission, this year with the help of the Green Efforts Committee, will be sponsoring its 23<sup>rd</sup> Annual Household Hazardous Waste Collection Day on April 24<sup>th</sup> at the Farmington High School from 8:00 am to 1:00 pm. This collection day follows last year's record collection with 604 cars attending. The Hazardous Waste Collection enables Farmington residents, as well as residents from other MDC participating towns, a safe, convenient and environmentally responsible way to dispose of their hazardous materials. Common acceptable wastes include oil-based paint, pesticides and herbicides; drain cleaners, antifreeze, cleaning solvents and pool chemicals. Green Efforts Committee members will be on hand to assist the Conservation Commission with registration and traffic control and also to educate participants about their clean energy options. The Farmington Highway Department will also assist the collection by accepting waste oil and car batteries.

Deferred loans are 0% interest loans, which require no payment until a transfer of title, the Owner's demise, or the subject property is no longer the applicant's principle place of residence. Passage of the above resolution and certification of the attached by the Town Clerk is a requirement of the grant application.
