- 3. \$25 FILING FEE must accompany filing-must be money order, certified check or cash only. NO PERSONAL CHECKS ACCEPTED.
- 4. Mailed filings must provide self-addressed, <u>stamped</u> envelope (*regular, first class postage*) for return mailing of certification & receipt
- 5. These Affidavits are <u>not to be used</u> for Settlement of Small Estates under 20 Pa.C.S.A. §3102
