TO CORRECT AN APPLICATION FOR MARRIAGE LICENSE:

Please note that in the case of a change to name or date of birth, supporting documentation for the correction must be provided to determine if the Affidavit can be filed. If the Application correctly reflects the information as it was presented at the time of issuance, an Affidavit of Correction cannot be filed. You may want to contact our office before filing the Affidavit to ensure you have everything you need. If the Affidavit is filed, it does not change the Application on file, but will be added as a supplemental record and kept in connection with the initial Application.

<u>FORMS:</u> A form Affidavit of Correction has been provided for your convenience at page three of this link.

<u>FEES:</u> The fee for filing an Affidavit of Correction is \$25.00. (NRS 122.045).

<u>COPIES</u>: To obtain a copy of the Affidavit of Correction include an additional \$0.50 for a regular copy <u>OR</u> \$6.50 for a certified copy.
