<u>Instructions for Completing the Annual Affidavit of No Change</u>

The **Annual Affidavit of No Change** (**Affidavit**) is required on your firm's certification anniversary date. By signing the **Affidavit** as the firm's owner you declare, under penalty of perjury, that there have been no changes in the firm's circumstances that affect business size, disadvantaged status, ownership or control.

If there have been changes in the firm's circumstances that would affect your DBE eligibility, including suspension or debarment actions that may exclude you from participation in the DBE program, you must notify HDOT in writing on your company's letterhead, of such changes and submit supporting documentation within 30 days of the change or action.

The **Affidavit** affirms that your company continues to meet U.S. Small Business Administration's business size standards to be considered a small business¹. Business size can be measured in average gross receipts or number of employees. Visit the website below to determine your business size according to the applicable North American Industry Classification System (NAICS) code. https://www.sba.gov/sites/default/files/files/Size Standards Table.pdf

The following are instructions for completing the Affidavit:

- 1. Name of the DBE owner (owns 51% or more)
- 2. Name of DBE firm
- 3. Name of DBE firm
- 4. Name of DBE firm
- 5. List SBA's business size standard for firm's primary NAICS code (e.g. 238120 = \$14 million)
- 6. Number of employees (if applicable)

In addition to the signed and notarized **Affidavit**, please submit the following documentation:

 U.S. tax returns for the DBE firm and its affiliates, including all schedules for the most recent tax year (i.e. Form 1120, 1120S or 1065). If you are a sole proprietor or your firm is an LLC and you report business income on a Schedule C, submit your entire most recently completed U.S. individual tax return. (i.e. Form 1040)

If you fail to provide this **Affidavit** and tax returns in a timely manner, you will be deemed to have failed to cooperate under § 26.109(c), and HDOT shall take steps to remove your firm's eligibility.

¹ The U.S. Department of Transportation's business size cap is \$22.41 million. Firms with average gross receipts in excess of this amount do not qualify as a DBE even though they may qualify under SBA's size standards.
