CHAIR'S CALL TO ORDER/REPORT

Noting a quorum of the Board Dr. Henderson, Vice Chair called the meeting to order at 3:50 p.m.

EXECUTIVE COMMITTEE REPORT- Dr. Henderson stated the Executive Committee met over the phone due to inclement weather. Most items discussed at the committee meeting were Policy related and will be discussed in the Legislation and Policy Reports.

EXECUTIVE REPORT

The Executive Report was given by Carole Catalfo, Executive Director.

Legislation- The Policy Unit has a new Policy Analyst, Mark Woodard. The Board has made over 50 appearances in Annapolis. The Bills are moving through the legislative process. Carole Catalfo provided update on the status of the Sunset, Licensure, Cosmetic Surgery, and Naturopathy bills. Carole reported Kinesiotherapists, Naturopaths, and Certified Lay-Midwives will be presented to a work group/study with objective criteria and then the Board will make recommendation.

POLICY- Robin Bailey reported that it seems likely that the Secretary will develop regulations for cosmetic medical procedures and cosmetic surgical facilities. The Board would like to include medical spas. Three amendments presented by the Board were discussed 1)Hospital/ambi-surg center privileges, 2)Advanced training, and 3) CMEs. Amendments 1 & 2 were opposed because these are already requirements if the practitioner is plastic surgery board certified. MedChi opposed amendment 3 because they are not in favor of a mandated CME requirement.
