## COURSE OUTLINE:

The concept of assigning an Agreement of Purchase and Sale is relatively simple. However, bringing the concept into realty comes with its challenges.

This presentation will outline the different provisions in the Assignment Agreement with a view to provide information on how to complete the form. It will also address the issues that arise in the process of assigning the original agreement including when the commission is to be paid.
