

***Plumas-Sierra County Fair
Horse Arena Use Agreement***

Individual use of the Horse Arena is a privilege granted subject to your obeying the Rules below, the execution of this use agreement, your providing proof of or purchasing liability insurance through California Fair Services Authority (CFSA), signing a Release and Waiver of Liability Agreement, and paying any required fees.

Rules of Use: (Violation of these Rules may cause revocation of riding privileges.)

1. Notify the Fair office promptly of any safety problems, broken property or vandalism.
2. Only horses are allowed inside the Arena (NO trailers, 4-wheelers, motorcycles, etc.)
3. All trash and debris must be removed with you.
4. Activities are restricted to the equestrian area and the rest of the Fairgrounds shall not be used.
5. No professional paid classes/training may take place without prior authorization from Fair Manager.
6. A \$50.00 dollar fee will be assessed to any person who leaves arena lights on or gates unlocked.
7. In an emergency, contact the Fair Office during business hours and/or call 911.
8. No loose horses at anytime around arena.
9. No dogs allowed on Fairgrounds, except guide dogs.
10. Horses must be ridden with a bridle or hackamore (not with just a halter).
11. There shall be no loud, noisy or profane language.
12. No animal shall be put down or destroyed at the Fair.
13. Parking is limited to the Range Cattle area.
14. Speed limit for motorized vehicles – 5 mph – will be strictly enforced.
15. Close, and lock (if appropriate) all gates after your use.
16. There shall be no alcoholic beverages in the equestrian area, nor any glass containers in the arena area.
17. Helmets with chin straps are required to be worn by riders jumping horses.
18. Climbing or sitting on the arena fence is prohibited. No animals may be tied to the fence.

Scheduling Policy:

Do not interfere with Arena activities scheduled by the Fair. Scheduling is to made with the Fair Office. Any updates/changes in the schedule will be e-mailed to all pass holders. If you do not have an e-mail address, it will be your responsibility to call the office with inquiries.

Release and Waiver of Liability Agreement:

Please read carefully and sign the attached Agreement, which is incorporated by reference, releasing the Plumas-Sierra County Fair of any liability for injury, property damage or death.
