Legal description of each point of diversion:** Chaffee County, NE ¼ of the NW ¼ Section 35, Township 13 South, Range 79 West, 6th P.M., 1050 feet from the North section line and 1550 feet from the West section line. **4. Source:** An unobstructed stream flow, of Powell Creek beginning at the diversion point of senior water rights on Powell Creek in the NW ¼ of the NE ¼, Section 33, Township 13 S., Range 79 W., of the 6th P.M. and ending at the point of diversion of the Olson Ditch, as described above, a distance of approximately 1.8 miles. Powell Creek is an intermittent tributary of the Arkansas River. **5. A. Date of initiation of appropriation:** March 29, 1996; **B. How appropriation was initiated:** By the act of appropriation, claiming the Olson Ditch, its decree and its development. **C. Date water applied to beneficial use:** Diversion to the Olson Ditch started May 22, 2001. **6. Amount claimed:** 1.6 cfs Conditional. **7. Application for Change of Water Right and Request for Alternate Point of Diversion

El Paso County

2. Decree information: Case No. 95CW111, District Court, Water Division 2, as entered on August 27, 1997. In that decree, Applicant's Well 2A (Permit No. 27229-F) which is decreed and permitted to withdraw 294 acre-feet per year of nontributary Arapahoe aquifer groundwater, and Applicant's Well 3A (Permit No. 34671-F) which is decreed and permitted to withdraw 272 acre-feet per year of nontributary Arapahoe aquifer groundwater, were designated as alternate points of diversion for each other. Also, Wells 2A and 3A, were designated as alternate points of diversion to withdraw an additional 259 acre-feet per year of nontributary Arapahoe aquifer groundwater associated with Applicant's Well 1 (Permit No. 16140-F). The decree allows withdrawal of a total of 825 acre-feet per year of nontributary Arapahoe aquifer groundwater through one or a combination of Wells 2A and 3A. The wells are located within the boundary of the District and the water from the wells is used in a unified municipal water supply system for service within the District. The District is generally located in parts of Section 1, T12S, R67W; Section 6, T12S, R66W; and Sections 29, 31, and 32, T11S, R66W, all of the 6th P.M., as shown on Attachment A to the Application. All exhibits mentioned herein are incorporated by reference and may be inspected at the office of the Clerk of this Court. **4. Proposed change and request for alternate point of diversion:** Applicant is not enlarging, expanding or increasing the decreed quantity of water which may be applied to beneficial use, nor is it attempting to change the character, purpose or place of

use of the subject water. By this application, Applicant requests an additional alternate point of diversion for the wells and water described above. The alternate point of diversion well will be located within the boundary of the District in the NE1/4NE1/4 of Section 31, T11S, R66W of the 6th P.M., and subject to the same limitations of Wells 2A and 3A described above. The alternate point of diversion well will operate at a rate of flow not to exceed 500 gpm, and pumping from all three wells at one time will not exceed a combination of 1025 gpm. WHEREFORE, Applicant prays that this Court enter a decree granting this application and for a finding that the change requested herein will not injuriously affect other owners or users of vested or conditional water rights, and for such other relief as it deems proper in the premises.
