

**SUPERIOR COURT OF THE DISTRICT OF COLUMBIA  
ADMINISTRATIVE ORDER NO. 14-02**

**Pairing of Judges - Supersedes Administrative Order No. 13-05**

Each active judge opposite a retired or senior judge is hereby designated to hear all matters that would normally be heard by the retired judge, or, in the case of a senior judge, when the senior judge is not available, except that where a senior judge is presiding on a misdemeanor calendar, cases heard by the senior judge will remain on the calendar unless the senior judge orders otherwise.
