Dear Parent/Legal Guardian:

This letter is to inform you that your child has recently visited the Israel Cancer Research Fund's ("ICRF") website, <u>www.icrfonline.org</u> ("Site"). Your child is now requesting your permission to participate in the communication opportunities of the Site, such as setting up a Personal Fundraising Page through ICRF's <u>Junior Philanthropists</u> [<u>www.icrfonline.org/junior-philanthropists</u>] program. ICRF requires children under the age of 13 to obtain written parental consent prior to using certain features of the Site. If you consent, the types of personally identifiable information that we will collect and save from your child online may include his/her name, e-mail address, mailing address, demographic and computer information, as well as information about your child's interest in and use of the Site.

We encourage you to visit our Site to see for yourself all we have to offer. Your child's privacy and your privacy are very important to us. Please view our <u>Privacy Policy</u> [<u>www.icrfonline.org/privacy-policy</u>] to learn what measures we have undertaken to protect the privacy of visitors to our Site.

With your approval, we will activate your child's account so that your child can enjoy all of the communication activities on our Site, including participating in ICRF's Junior Philanthropists Program, and setting up a Personal Fundraising Page. Your child's participation on our Site will require that his or her information will be collected and processed in the United States and that you consent to our use of cookies as described in our Privacy Policy.

Because some of the features on our Site will enable your child to publicly post personal information, we encourage you to monitor and supervise your child's Internet activities during his or her exploration of our Site. You may, for example, want to set rules for your children about whom they can talk to and what general discussion topics are all right, which types are off limits and what personal information, if any, is all right to share. Please teach and remind your child not to publicly post personally identifiable information such as name, telephone number or e-mail on any website.
