### SCOPE OF WORK

---

#### D.1 OVERVIEW

- A. The Virginia Railway Express (VRE) operates various types of passenger railcars from the Crossroads Yard (outside of Fredericksburg, VA) and the Broad Run Yard (outside of Manassas, VA) to Washington, DC utilizing a fleet of MP36PH-3C diesel engine passenger locomotives.
- B. The electronic fuel injector assembly units currently in use on VRE's passenger locomotives are the original equipment manufacturer (OEM) specified or equivalent.
- C. In the performance of this Contract, the Contractor shall comply with **ATTACHMENT T.1 – GENERAL TERMS AND CONDITIONS** included herein.
- D. The Contractor shall deliver sixteen (16) electronic fuel injector assembly units for *thirteen (13)* VRE passenger locomotives, for a total of *two hundred and eight (208)* electronic fuel injector assembly units.
- E. The parts supplied to VRE must adhere to all applicable requirements including, but not limited to, the current editions of the following:
  - 1. 49 CFR 229, Railroad Locomotive Safety Standards;
  - 2. 49 CFR 238, Passenger Equipment Safety Standards;
  - 3. AAR Section E, Manual of Standards and Practices;
  - 4. 40 CFR Parts 85, 89 and 92, Emission Standard for Locomotives and Locomotive Engines; and
  - 5. Environmental Protection Agency regulations and requirements.
