AGREEMENT:

The undersigned Consignor (as identified above) hereby warrants that he/she has the legal right to own this firearm.

Consignor further agrees to consign the above-described firearm(s) to Consignee, H2 ARMS, LLC. The purpose of the consignment is for H2 ARMS, LLC to arrange for the sale of this firearm. In consideration of this transaction,

H2 ARMS, LLC will receive payment based upon the proceeds of the sale as follows:

H2 ARMS, LLC charges 15% of the sale price per firearm plus any shipping fees paid by the buyer.

ALL ITEMS MUST BE IN GOOD CONDITION AND CLEAN: Consignee reserves the right not to display any consigned item found on close inspection to be defective. Any repair costs or cleaning to the above-described firearm, which is previously authorized by the Consignor, will be deducted from the amount paid to Consignor. The payment to the Consignor will be made within a reasonable time period after the sale transaction is concluded with the third party buyer. This will include any time necessary for payment of funds or checks to clear the bank into H2 ARMS, LLC's possession.

This agreement allows for H2 ARMS, LLC to show this firearm at various locations including gun shows, auctions and its online store and allows H2 ARMS, LLC the opportunity to display and advertise this firearm as if it was H2 ARMS, LLC'S own property.

Consignor agrees to consign the above-described firearm to H2 ARMS, LLC for a maximum of 120 days from the date of this agreement.

Consignor may terminate this agreement by retaking possession of the firearm, provided no sale is pending, and Consignee may terminate it by leaving notice for customer through phone, email, or postal mail to retrieve the firearm.

NOTE: A completion of ATF form 4473, and a NICS FBI background check may be required prior to release of the firearm(s) back to the Consignor, or his/her designee. If a person other than the original owner of the firearm(s) wishes to receive the firearm(s) arrangements must be made in advance and the name of the person must be provided by the original customer. The Consignor's designee MUST be over the legal age of eighteen (18) to receive long guns and twenty one (21) to receive handguns and MUST present a valid Texas driver's license. If H2 ARMS, LLC deems the identification is insufficient, the firearm(s) will not be transferred to the designee. Consignor may arrange to have the firearm(s) transferred to his/herself or his/her designee via an FFL dealer in another state of residence, in which case Consignor is responsible for verifying that the firearm(s) are legal for possession and transfer in the new state of residence and paying shipping costs, plus a \$20 handling fee. If the firearm(s) have not been picked up by the customer within 30 calendar days after this agreement expires or 30 calendar days after notification by H2 Arms LLC to retrieve the firearm as provided above, whichever is sooner, the firearm(s) becomes property of H2 ARMS, LLC.
