- Footprint not to exceed 10X10X4 inches. System should be able to be installed at any angle, in an easily accessible place.
- System status must be displayed using LED lights and these LED's must be visible to the driver
- Removable hard drive minimum 60GB. Hard drive must be a USB device. Video review to be accomplished with a PC and supplied software.
- System must have event marking capability.
- System must be equipped with a USB memory stick process to quickly remove marked events from the on-board system
- Video must be able to be secured from tampering.
- Cameras to be Infrared
- System to include two cameras, recording on individual channels, both with independent audio.
- Each camera will record up to 30 FPS
- Mpeg4 compression will be used
- Working temperature: extremes from -10 degrees F to +160 degrees F
