The New Hampshire Institute of Art is pleased to announce Biennial 2013, a regional juried exhibition for New England artists. This exhibition of painting, drawing, printmaking, photography, and illustration will be on display in the Institute's French Building Gallery.

# entry guidelines

#### ELIGIBILITY

- Entries will be accepted in the media of painting, drawing, illustration, printmaking, digital imaging, and photography.
- Each artist may submit a maximum of two entries.
- Images, registration forms and entry fees must be received by **October 14, 2013**.
- Registration forms must be signed. Entry fees are not refundable. Notification of acceptance will be via email.

Registration forms will be available on our website: www.nhia.edu or send a self addressed stamped envelope to receive a registration packet. You may photocopy this form.

Any incomplete application or fee, or images that are not labeled or formatted correctly or are of poor quality, will be returned to the artist and will not be eligible for entry.

#### **DEADLINE: OCT. 14, 2013**

Digital images, registration forms, and entry fees. Registration forms must be signed. Entry fees are not refundable. Notification will be by email.

#### ENTRY FEE

\$30 for up to 2 digital images. Make checks payable to **New Hampshire Institute of Art**. Materials cannot be returned, please keep a copy for your records.

The entry material for accepted art will be held for possible publicity use. Do not send resumes, bios, or photographs with entries.

#### ENTRY LABELING

Preliminary judging of entries will be done from digital images. It is imperative that your images are of professional quality. Poor images may be disqualified at the juror's discretion. Digital images submitted must be 300 dpi, with largest dimension no larger than 6", jpeg format.

- Name the file as follows: Lastnamefirstinitial.entrynumber.jpg Example: smithb.01.jpg
- Please use a jewel case or sleeve to protect the compact disc.

- All disks sent must be labeled with the artist's name, title of work, dimension and medium. Disks that are not labeled correctly will be declined.
- CD's cannot be returned—please make sure you have a copy of your images for your records.

#### JUDGING

The juror will view the entries individually. The juror has the option, upon receipt of the artwork, of rejecting from the exhibition any works not commensurate with submitted digital images.

#### NOTIFICATION OF ACCEPTANCE

Emailed notification of acceptance to the Biennial Exhibition will be by **October 21, 2013**.

#### **DELIVERY OF ACCEPTED ARTWORK**

Artworks selected for the Biennial Exhibition MUST be received by **6 pm, Monday, November 4, 2013**.

Please include instructions for display with images if necessary, display will be at the juror's discretion. Any work determined unsafe or unstable may be excluded at the gallery director's discretion.

**In-Person:** If you choose to deliver the artwork in person it must be between the hours of

Carrier: Artwork sent by common carrier must be received before 6 pm, Monday,

#### PICK-UP/RETURN OF ARTWORK

All work submitted for exhibition must be removed at the time designated. If work is not picked up by the artist or designated representative on time, there will be a \$50 administrative charge and a storage charge of \$7.50 per day. After 30 days, the art, including all rights, title, and interest of the

artist in and to the property shall become the property of the Institute.

- In-Person: Artists who want to pick up their work in person may do so from 4–6 pm, December 17, 2013. Artwork should be collected from: The New Hampshire Institute of Art 148 Concord St., Manchester, NH 03104
- **Carrier:** Shipped work must be prepaid and have the same prepaid postage for the return of the artwork. All shipped works must be packed in sturdy, reusable containers. Artwork returned by carrier will be sent from the Institute on **December 17, 2013**.

#### SALES

A commission of 35% is required on all sales. All artwork is considered for sale unless listed NFS (not for sale). Artwork listed NFS should be clearly marked NFS on the registration form, followed by a fair market value for insurance purposes. Artwork will be released to the purchaser at the close of the exhibition. Selling artists must accept responsibility for shipping costs.

#### LIABILITY AND INSURANCE

All artwork will be insured against loss or damage while on exhibit at the Institute. While work is in transit, coming to and returning from the Institute, liability and insurance are the responsibility of the artist.

#### RECEPTION

The Biennial Exhibition Opening Reception and Awards Ceremony is **November 20, 2013, 5–7pm** in the French Building Gallery, 148 Concord St., Manchester, NH. The New Hampshire Institute of Art will award more than \$2000 in prize money.

#### CATALOG

The Biennial Exhibition will be accompanied by a catalog available at the opening of the exhibition. All selected artists will be listed in the catalog and a representative sampling of accepted work will be reproduced in this publication.
