**IF YOU ARE A STUDENT**

1. Complete the attached application, include your financial documentation and return them to DMAC. Once received we will issue an I-20 form which you will take to the US Embassy/Consulate on your appointment to apply for the student visa:
  - Application for Form I-20 Certificate of Eligibility
  - Affidavit of Support for International Students
  - Supporting documentation for the Affidavit of Support

For students taking the TOEFL test, our school code: 8427.

**IF YOU ARE A TRANSFER STUDENT**

2. Notify the DSO/Foreign Student Advisor at your current school of your plans to transfer to Digital Media Arts College so they may release your SEVIS record to our school.
3. Obtain from the Office of International Admissions the following documents, complete them and return them to DMAC:
  - Application for Form I-20 Certificate of Eligibility
  - Affidavit of Support for International Students
  - Supporting documentation for the Affidavit of Support

**DO NOT ENTER THE UNITED STATES WITHOUT AN F-1 STUDENT ENTRY VISA**

DO NOT enter the US on the WT Visa waiver Program. If you enter the U.S. without a VISA, you may only stay for ninety (90) days and cannot change to an F-1 status.

**UNDER NO CIRCUMSTANCES** are you permitted to work in the US without appropriate authorization from DMAC or the USCIS – **NO EXCEPTIONS.**

DMAC MUST BE INFORMED OF **ALL** ADDRESS AND PHONE NUMBER CHANGES.

**TRAVEL OUTSIDE OF THE UNITED STATES**

Be sure that your paperwork is in order before traveling. You must have a valid signature on the I-20 and a valid F-1 VISA and passport. Consult your Designated School Official in advance of your trip.

Checklist for international students upon their arrival at DMAC:

- Check into the Office of International Admissions upon your arrival. Please bring with you your passport, I-20 and I-94 card.
- Update your current address information with the college.
- Apply for a Social Security card.
- Apply for a bank account; bring with you your passport, I-20, I-94 card, DMAC ID, if possible your Social Security card.
