Criteria

To be considered for this award, students must

- Be enrolled full-time in their 3rd or 4th year within the Bachelor of Commerce degree program, majoring in Management Studies
- Demonstrate financial need
- Be in good academic standing with a cumulative GPA of 3.0 or greater
- In the unlikely event that applicants do not meet the GPA requirement, the bursary recipient will be selected based on the top 10th percentile of qualifying students, based on other established criteria.

A selection committee will choose the recipient for the *Project Management Institute (PMI) Northern Alberta Chapter Management Award*.

The successful applicant will be notified via mail. Appeals will be not considered, as the committee selections are final.
