COURSE DESCRIPTION

This class examines the prevalence of violence against registered nurses, patients and other healthcare employees, what laws and regulations currently exist to prevent violence in healthcare settings, and what your facility should be doing to prevent violent episodes. It further examines the scope of the workplace violence problems, how to recognize impending violence, through behavioral assessment techniques and how registered nurses can be proactive in their practice settings in promoting workplace security, preventing violence and dealing with violent incidents, and their aftermath effectively.

COURSE OBJECTIVES

Upon completion of this program, participants will be able to:

- 1. Concisely outline the California health and safety code requirements for each hospital to have a safety and security plan in place to prevent and protect against violence.
- 2. Understand the "assault cycle" and how to safely intervene in the assault cycle to prevent a violent escalation.
- 3. Understand the factors that contribute to incidents of violence and how to mitigate those factors.
- 4. Initiate steps or actions to lessen the potential of violence in their workplace both at the facility level and in the public policy arena.
- 5. Identify behaviors that undermine a culture of safety.
