## TERMS & CONDITIONS

By engaging in any SUP fitness, Rentals or SUP Instruction, the customer must sign and agree to the following terms and conditions. No rental shall take place without customers signing this form.

**SIGNED CONTRACTS:** All customers must read and sign the rental agreement contract before using any equipment. This contract includes a waiver of liability that waives all legal responsibility for Virginia Power Kites and puts the responsibility on the renter.

I have the appropriate skills to SUP board, and I accept completely responsibility for any damages to the board. If the board should be lost or damaged, I shall pay the full price for all repairs or loss. I will wear a life jacket and anyone who also uses a SUP board under my supervision will wear a life jacket (this is Virginia state law). I agree to all the terms and conditions within this contract. I understand that SUP boarding can result in the loss of life, drowning, and other fatal accidents if not conducted properly, and I assume complete responsibility for anything that should occur during the rental period.

**HEALTH & FITNESS:** All customers must be fit and healthy enough for the proposed activity. All Virginia Power Kites participants or users of rental gear must have appropriate swimming abilities.
